Emergency Measure An Act to Repeal the Maine Bid Preference Law (H. P. 1904) (L. D. 1889) (C. "A" H-624) Was reported by the Committee on En-

grossed Bills as truly and strictly engrossed. The SPEAKER: The Chair recognizes the gentleman from Scarborough, Mr. Higgins.

Mr. HIGGINS: Mr. Speaker, Ladies and Gentlemen of the House: I would just pose a question through the Chair. I recall when this bill went through initially several years ago and there was quite a bit of debate and concern over it. Does this completely eliminate the bid preference law that we did pass several years ago and just how is this going to affect the law?

The SPEAKER: The gentleman from Scar-borough, Mr. Higgins, has posed a question through the Chair to anyone who may care to answer.

The Chair recognizes the gentlewoman from Waterville, Mrs. Kany. Mrs. KANY: Mr. Speaker, Ladies and Gen-tlemen of the House: The present Maine bid preference on our books allows a 5 percent - if a Maine firm is within 5 percent of the lowest bid, then the Maine firm has had an opportunity to meet that lowest bid, and this legislature did recently enact that

We have this bill before us which would repeal the Maine bid preference law as a result of a problem in that some other states are now interested in retaliating against any states that do have preference laws. The State of Pennsylvania has retaliated against any Maine bidders.

There is a firm in the southern part of the state which is interested in as much as \$2 million worth of business in Pennsylvania and was not even allowed to bid.

I will say that our committee was totally open-minded on this issue and we waited to hear from our purchasing agent, basically Stuart Sabean, before making any judgments on it.

We do have some Maine firms who have used our preference law. We have approximately \$60 million worth of business and about \$30 million that would come under our Maine bid preference law, and we have felt that in the past it kept perhaps \$300,000 worth of business in the state as a result of our preference. But on balance, it seemed that we were losing much more by having the law than we were by repealing it.

In addition — I don't know if I should say this but it is true – in a way, we keep much of our business here in Maine through the law by having a bid preference list. In other words, those who are interested in bidding on many state contracts can sign up with the director of Purchasing and thereby be on any list that goes out if there is something in their area of inter-est. Those are basically all Maine firms.

So, even though we repeal this preference, we do have means of encouraging preference of Maine business still

The SPEAKER: The pending question is on passage to be enacted. This being an emergency measure, it requires a two-thirds vote of all the members elected to the House. All those in favor will vote yes those opposed will vote no. A vote of the House was taken.
