# HOUSE

Wednesday, March 2, 1983 The House met according to adjournment and was called to order by the Speaker.

Prayer by Father Frank Morin of St. Joseph's Church, Lewiston.

The journal of yesterday was read and approved.

# Papers from the Senate

The following Joint Order: (S. P. 319) WHEREAS, the Belgrade Lakes region is one of the most beautiful and popular recreation areas in the State; and

WHEREAS, in the heart of this region lies the Town of Oakland; and

WHEREAS, on March 1, 1883, the people of the Town of West Waterville adopted the new name of Oakland for their town at a special town meeting; and

WHEREAS, on March 9, 1983, the Maine House of Representatives approved the adoption of the name; and

WHEREAS, on the following day, March 10, 1883, the Maine Senate and the Governor similarly approved the new name for the town; and

WHEREAS, March 10, 1983, is the ONE HUNDREDTH ANNIVERSARY of the adoption of this new name of the Town of Oakland; now, therefore, be it

ORDERED, the House concurring, that we, the Members of the First Regular Session of the One Hundred and Eleventh Legislature now assembled, extend our heartiest congratulations and best wishes to the citizens of Oakland on the historical and memorable occasion of its centennial anniversary; and be it further

ORDERED, upon passage, that a copy of this Order duly attested and bearing the great seal of the State of Maine, be immediately transmitted to the citizens of Oakland in token of the sentiment expressed herein.

Came from the Senate read and passed.

In the House, under suspension of the Rules, the Order was read.

The SPEAKER: The Chair recognizes the gentleman from Scarborough, Mr. Higgins.

Mr. HIGGINS: Mr. Speaker and Members of the House: The reason for my rising is that when I read through this paper last night, I saw that we were passing an Order in adoption of something that has yet to happen. I wonder if someone could explain to us why. It says on March 9, 1983, the House is going to do something, and on the 10th the Senate is going to do something. Are we aware that that is going to take place?

The SPEAKER: The Chair would advise the gentleman, as the Speaker reads it, it refers to March 9, 1893, a time long since gone by.

The Chair recognizes the gentleman from Scarborough, Mr. Higgins.

Mr. HIGGINS: Mr. Speaker, I am going to take exception because we are both right. If you look on the blue copy, it says 1983, am I correct, Mr. Speaker?

The SPEAKER: The Chair would advise the gentleman that the "Whereas" deals with the past; the order deals with today. And in reference to March 10, 1983, it will be the 100th anniversary of the adoption of the new name of the Town of Oakland.
