In the House: Reports were read.

The SPEAKER: The Chair recognizes the gentleman from Brewer, Mr. Cox.

Mr. COX: Mr. Speaker, I move that we accept the Majority "Ought to Pass" Report in concurrence

The SPEAKER: The gentleman from Brewer, Mr. Cox, moves that the Majority "Ought to Pass" Report be accepted in concurrence.

The Chair recognizes the gentleman from West Bath, Mr. Stover.

Mr. STOVER: Mr. Speaker, Ladies and Gentlemen of the House: I signed this bill out, as you know, "ought not to pass" and I thought I would like to explain to you my thinking behind it.

At the present time, there are no liquor stores that are open on Sunday in the State of Maine. There is a process whereby this can be done if enough people in the community want it to happen - that is through the petition process. If 15 percent of the people who voted in the last gubernatorial election sign a petition, take it to the governing body of that municipality, then that question shall be put on the ballot and the people have a chance to vote whether or not they want to open the liquor stores on Sunday. This would bypass that process and would allow the Liquor Commission to write to the governing body and then the governing body, by majority vote, could go ahead and put this question before the voters.

I am againt this for two reasons, one is that I

feel we do have a process in place. If people want to take advantage of it, they can. It is the democratic way of doing it, and also I think it is getting the Liquor Commission to another level in the legislative process. I think it is not a good idea, it is almost like the tail wagging the dog. I feel that this is not a good bill and I am going to vote against it and hope you will join with me, and I would ask for a division.

The SPEAKER: The Chair recognizes the gentleman from Lewiston, Mr. Handy.

Mr. HANDY: Mr. Speaker and Members of the House: I, too, am one of the signers of the Minority "Ought Not to Pass" Report and I would like to briefly explain my reasons why.

Currently, the bill would allow for or would be, in effect, a bypass of the petition process as outlined in 28 MRSA Sec. 101.

I am a signer of the "ought not to pass" report for two primary reasons. Number one, there is already a mechanism in place whereby if a town or city would like to consider the local option question, it may do so under the provisions of Section 101. Secondly, I don't feel that it is proper for the State Liquor Commission to get into the business of asking our towns and cities to have an election on a local option qu-

I would urge the members of the body to oppose the "ought to pass" report so we may accept the "ought not to pass" report.

The SPEAKER: A vote has been requested. The pending question is one the motion of the gentleman from Brewer, Mr. Cox, that the Majority "Ought to Pass" Report be accepted. All those in favor will vote yes; those opposed will vote no.

A vote of the House was taken.

39 having voted in the affirmative and 69 having voted in the negative, the motion did not prevail.

Thereupon, the Minority "Ought Not to Pass" Report was accepted in non-concurrence and sent up for concurrence.

The SPEAKER: The Chair recognizes the gentleman from Brewer, Mr. Cox.

Mr. COX: Mr. Speaker, I move that the House recede and concur.

The SPEAKER: The gentleman from Brewer, Mr. Cox, moves that the House recede and concur.

The Chair recognizes the gentleman from

York, Mr. Rolde. Mr. ROLDE: Mr. Speaker, I would just ask the good gentleman to explain what the Senate did and what is Senate Amendment "A"

The SPEAKER: The gentleman from York, Mr. Rolde, has posed a question through the Chair to anyone who may care to answer

The Chair recognizes the gentleman from Bangor, Mr. Kelleher.

Mr. KELLEHER: Mr. Speaker, Ladies and Gentlemen of the House: If the good gentleman from York hasn't already heard, as I understand the amendment the other body wants fair and equitable prices all over the state, something that I personally think seems to be very reasonable.

I would urge the House to support the House Chairman's motion to recede and concur.

We have been subsidizing long enough across the state southern Maine, or the towns down in southern Maine, in the cost of liquor. We all know that the old argument is that we have got to get them across the border from New Hampshire and into Maine with fair prices. Well, I think the first thing this House ought to do is to give fair and equitable prices to all its citizens, not just try to lure the almighty dollar from New Hampshire and Massachusetts into the coffers of the State of Maine at the expense of the rest of the people of this state.

I wholeheartedly agree with the gentleman's motion. I know there is a price tag involved in this. Somewhere along the line we will be looking at it, but I would urge you to support the motion to recede and concur.

The SPEAKER: The Chair recognizes the gentleman from Cumberland, Mr. Dillenback.

Mr. DILLENBACK: Mr. Speaker, Ladies and Gentlemen of the House: I would like to have somebody tell me, or please explain to me, what this will cost the state in revenues?

The SPEAKER: The gentleman from Cumberland, Mr. Dillenback, has posed a question through the Chair to anyone who may care to answer.

The Chair recognizes the gentleman from Bangor, Mr. Kelleher.

Mr. KELLEHER: Mr. Speaker, I don't think it is going to cost the State of Maine a great deal of money if we just increase the prices for the liquor down in those border towns.

The SPEAKER: The Chair recognizes the gentleman from York, Mr. Rolde.

Mr. ROLDE: Mr. Speaker, Ladies and Gentlemen of the House: If I understand the gentleman from Bangor, Mr. Kelleher, correctly, this bill would lower the prices throughout the state to what those are at Kittery, and that is fine with me. I have always supported that bill.

I would take issue with the gentleman from Bangor, Mr. Kelleher, who said that the original store was put in Kittery to benefit the people in southern Maine — that is not true. The money that comes from that store benefits the people throughout the State of Maine.

I think this is a fine idea, I have always supported it. I would ask for a roll call and I would ask you to vote to recede and concur.

The SPEAKER: The Chair recognizes the gentleman from Cumberland, Mr. Dillenback.

Mr. DILLENBACK: Mr. Speaker, Ladies and Gentlemen of the House: I don't believe my question was answered. I think this state has had a problem right along in raising funds. We have raised enough taxes, we have raised enough fees, and now you want to cut the fees on liquor, which would be fair to everybody in the state. It may be fair, but it is one of the greatest revenue gatherers we have in the state. We need the money we get from the liquor sales.

If you wanted to be fair, you would put one store perhaps in Augusta which would have a discount price, or someplace centrally located if people wanted to travel the distance. But I think it is ridiculous for us to lose the revenue that we have. I can't believe that this legislature, with the problems we have had raising funds for the different programs we have, talking about a 5 cent gas increase for state highways, talking about helping the elderly and poor, and here you want to cut the revenues of the state. I think the amendment was put on to kill this bill, I don't think it was put on to be serious. I just can't believe that we as a group would vote for this. I hope you will not vote for it.

The SPEAKER: The Chair recognizes the gentlewoman from Athens, Ms. Rotondi.

Ms. ROTONDI: Mr. Speaker, Ladies and Gentlemen of the House: I urge you to support the motion to recede and concur. As you know, the intent of the original legislation was to enable patrons of liquor stores in southern Maine border towns to purchase liquor at the lower prices now found in Kittery.

I originally had reservations about the bill because it only dealt with a few of the many border communities whose stores lose business to neighboring New Hampshire liquor stores. As a legislator whose district includes a prominent border town, Jackman, I am sure you can understand my concern. I have prepared an amendment that would have expanded the bill to include Jackman as well. However, this amendment that we have debated now goes even further and is, I believe, the fairest way to go. It not only makes the border towns competitive with New Hampshire, it also removes the discrimination that has existed against those who, unfortunately, do not live close enough to Kittery to benefit from the lower prices available there.

I believe as long as the state is in the liquor business, it should be both competitive as well as fair. This amendment accomplishes both those objectives. I ask for your support of my position.

The SPEAKER: The Chair recognizes the gentlewoman from Wells, Mrs. Wentworth.

Mrs. WENTWORTH: Mr. Speaker and Members of the House: I would like to agree with my colleague. I think that if we go with the cut-rate price all over the state, we will not be losing revenue, because I have seen along the coast and inland division of Maine and New Hampshire, if those people return and buy their liquor in this state, I think it will more than make up the difference that will be lost.

The SPEAKER: The Chair recognizes the gentlewoman from Cape Elizabeth, Mrs. Masterton.

Mrs. MASTERTON: Mr. Speaker, I would like to pose a question through the Chair. As I am reading the amendment, H-40, it says that the purpose of this amendment is not to extend the discount prices all over the state in every single liquor store but just to add Rumford to Kittery, Sanford and Fryeburg which were on the original bill. I would like to ask if this is correct?

The SPEAKER: The gentlewoman from Cape Elizabeth, Mrs. Masterton, has posed a question through the Chair to anyone who may respond if they so desire.

The Chair recognizes the gentleman from York, Mr. Rolde.

Mr. ROLDE: Mr. Speaker, Ladies and Gentlemen of the House: I believe the gentlelady from Cape Elizabeth is on the wrong amendment. The amendment is under filing No. S-20 and that is the one that lowers the prices all over the state.

The SPEAKER: The Chair recognizes the gentleman from Biddeford, Mr. Racine.

Mr. RACINE: Mr. Speaker, Ladies and Gentlemen of the House: As I look at the Statement of Fact and Senate Amendment "A", it reads that the Kittery store sells liquor now at approximately 45 percent above the delivered warehouse price while the remainder of the state stores sell at least at a 75 percent markup. This amendment lowers the markup to 45 percent statewide.

If you would take a look at your General Fund Undedicated Revenue for the month ending February 28, 1983, and if you will look at the transfer from the Liquor Commission, the actual was \$19,694,100.93—my question is this—if the State Liquor Commission reduces its price to 45 percent of the markup, how much revenue would the state lose? It seems to me that somebody should be able to answer that question.

The SPEAKER: The gentleman from Biddeford, Mr. Racine, has posed a question through the Chair to anyone who may respond if they so desire.

The Chair recognizes the gentleman from Brewer, Mr. Cox.

Mr. COX: Mr. Speaker, Ladies and Gentlemen of the House: I don't think there is anyone who can, with any degree of certainty, answer the question of cost. The Liquor Commission estimates there would be a one million dollar loss of revenue if there were no increase in sales, but I think we all know that there will be

a considerable increase in sales from those people inland who are so enraged about the special price at Kittery that they go right by Kittery and go to New Hampshire to purchase their liquor. So I think we can assume that there would be a substantial increase in sales, but as to the exact amount of loss, I don't think anyone can tell us, except the State Liquor Commission assumes \$11 million if there is no increase in sales.

The committee looked into this a couple of years ago and we had figures of maybe a \$5 million or \$6 million loss but, as I say, these are just guesses. We have absolutely no way of knowing how many people from the rest of the state go to New Hampshire to purchase their liquor. We know there is a substantial number of them, we hear back in our district all the time from constituents who tell us they will not shop at the Kittery Store because of the unfairness in the price.

The SPEAKER: The Chair recognizes the gentlewoman from Vassalboro, Mrs. Mitchell.

Mrs. MITCHELL: Mr. Speaker, I would like to inquire if this amendment has a proper fiscal note?

The SPEAKER: The Chair has not yet been provided a fiscal note pursuant to the requirement at this point.

Thereupon, the Bill was tabled pending a ruling from the Chair relating to Joint Rule 21.

Another side of Warren was that he was always to help other legislators, whether the problem was hospitalization, a room, or anything and many here in this chamber received that quiet, unheralded help.

The night he was stricken with a massive heart attack, he waited to call for help because, as he put it, he didn't want to bother anyone.

Today our sympathies go out to District 109 and the town of Berwick for the loss of their public servant. Our hearts go out to his wife, Emma, his three daughters and four grand-children, and as the priest said today, Warren left everyone with good memories.

Warren, this afternoon, rests on a knoll that looks out toward the snowcapped White Mountains. It is a guiet, beautiful place—Godspeed, Warren, we miss you.
