Senate Paper 439, Legislative Document 1318, AN ACT Pertaining to the Political Rights of State Employees, having been returned by the Governor together with his objections to the same pursuant to the provisions of the Constitution of the State of Maine, after reconsideration the Senate proceeded to vote on the question: "Shall this Bill become a law notwithstanding the objections of the Governor.

# House at Ease

Called to order by the Speaker.

The following paper was taken up out of order by unanimous consent:

#### Passed to Be Enacted Emergency Measure

An Act to Delay Employers' Filing Deadlines under the Chemical Substance Identification Law (H. P. 1477) (L. D. 1930)

Was reported by the Committee on Engrossed Bills as truly and strictly engrossed.

The SPEAKER: The Chair recognizes the gentlewoman from Auburn, Representative Robinson.

Representative ROBINSON: Mr. Speaker, Ladies and Gentlemen of the House: The law that this bill addresses has caused as much concern among the people of this state as anything else that was passed over the objections of the minority in this House during the first regular session. This is a law which is especially hard on our really small businesses, such as gas stations, beauty shops, doughnut shops, that type of business. It is a law that imposes an additional tax—330 to, I believe, \$300 on employers. It is a law which, in my opinion, should be repealed.

Today what the bill in front of us does is it buys some time before the law goes into effect. I believe that that is a good thing to do and I think that we should probably try to buy that time and vote in favor of this bill today. However, during this one month that we are buying, I hope that we can see fit to rectify the situation and make substantial changes in the law that was passed last Spring.

The SPEAKER: The Chair recognizes the gentleman from Old Town, Mr. Cashman.

Mr. CASHMAN: Mr. Speaker, Men and Women of the House: I would agree with Representative Robinson, we do need more time to work on the solutions to the problems that the original bill has created, but I think the problems are primarily administrative problems. The fact is, I think, that there was a wide consensus in this House during the first session of the 111th that the intent of the bill was good, I still think that it is, and I think that the bill, while it does require filing by small businesses and gas stations and so forth, the bill has been a pro employer as well as a pro employee bill.

The fact is, employers who are now handling toxic substances, that are handling chemicals, have nowhere to turn for advice and consultation at the state level on how to handle these materials properly. This is something that has been done not just in Maine but it has become a matter of state law in most states in the country, because with the increasing use of toxic substances, we can't just bury our heads in the sand and ignore the hazards that are caused by them.

I think the original intent of the bill was fine. The bill before us and the bill we are voting on right now is to delay implementation for a month so we can work the administrative bugs out of it.

The SPEAKER: The pending question is on passage to be enacted. This being an emergency measure, it requires a two-thirds vote of all the members elected to the House. All those in favor will vote yes; those opposed will vote no.

A vote of the House was taken.

132 having voted in favor of same and one against, the Bill was passed to be enacted, signed by the Speaker and sent to the Senate.

By unanimous consent, ordered sent forthwith.

An Act to Extend the Deadlines for the Filing of Various Reports with the Legislature (H. P. 1478) (L. D. 1932)

This being an emergency measure and a twothirds vote of all the members elected to the House being necessary, a total was taken. 109 voted in favor of same and one against, and accordingly the Bill was passed to be enacted, signed by the Speaker and sent to the Senate.
