Bill "An Act to Deny Certain State Funds to Any Person Who Refuses to Register Under the United States Military Selective Services Act' (H.P. 643) (L.D. 897)

Was reported by the Committee on Bills in the Second Reading and read a second time. The SPEAKER: The Chair recognizes the

Representative from Auburn, Representative Brodeur.

Representative BRODEUR: Thank you Mr. Speaker. I move that this Bill and all of its accompanying papers be indefinitely postponed.

Mr. Speaker and Members of the House: Yesterday after the debate on this Bill, I saw both Representative Dillenback from Cumberland and the Representative from Old Town, Representative Paradis and they were waiting for me to speak, so as not to disappoint them today, I thought I would proceed. Although, I was a little bit uneasy with the characterization of myself as a big gun by the Representative from Old Town, Mr. Paradis, I don't feel very comfortable with that characterization.

When I speak, I in no way mean to offend or to take anything away from the glory and pride of the men and women who served the people of our nation in war for my father served with them. They deserve our respect for their commitment, their bravery and their sacrifice.

Our history tells of the glory and pride of the United States as it defended itself, history of which many of you lived through with our allies against fascism and aggressive imperialism of axis powers, forty years ago. Our democracy and our allies were threatened. We, and other nations, were unjustly attacked forty years ago. Our country was defending itself. Defending democracy and defending the basic human rights of nations and its peoples. But it is the experience of the draft of the last twenty years that I am most familiar with.

When we debate a Bill in this chamber, we usually look at many of the implications and possible results of the Bill. I want to present the results of some of our past experiences and past results along with possible results and implications of this Bill.

When I turned eighteen, I too registered for the draft. My friends and classmates were those who were drafted though. Some never came back alive and some came back physically, psychologically and chemically injured. It is a fact that many of those who resisted are now better off than those who did serve. Unfortunately, the war in Vietnam wasn't fought to promote democracy, but to oppose it. It wasn't fought to foster the human rights of people, but to deny them. It wasn't fought as the defender of liberty and unjust aggression, we were the aggressor. Killing one million people in Vietnam, 500,000 of them children, injuring and making homeless 5 million people, poisoning their farm lands and leaving the countryside with mines and chemicals that continue to injure today.

But I would like to focus on this Bill on a personal level. Draft registration is not only making up a roster, but a necessary step towards registration and towards the draft, towards men fighting a war. The Representatives from Cumberland and Old Town both said that this was to be available in time of need, to meet manpower objectives to meet it's national objectives. That is a nice clean way of stating what time of need is and what national objective is. But I think that the history that I am familiar with, another way of putting that is that you offer your sons and your grandsons and our constituents' sons and grandsons as a sacrificial offering to the whims of other politicians. I strongly object to that. Do we have to wait until forty thousand more young men and women are killed in a conflict with no just cause before we act? I hope not. In the situation we are faced with today, we have two fleets on the shores of Nicaragua. We have six or seven bases in Honduras against Congressional intent and Congressional directives, ready to fight a war there. A democratic nation where there are six or seven political parties that just had an election in which one party received a high percentage of the vote. A democratic nation. A new nation that just had a revolution. A democratic nation where all the people who can have arms, have arms, and if they had an oppressor there, they could use their arms against any oppressor. I hope that we don't go down the path of encouraging our young men to proceed blindly to the whims of politicians. I think we should look very carefully at where we are heading and I hope this isn't the direction that we take.

The SPEAKER: The Chair recognizes the Representative from Old Town, Representative Paradis

Representative PARADIS: Mr. Speaker, Members of the House, I request a roll call. Members of the House: We gave this Bill a

good hearing yesterday and with a good solid vote for passage. I hope that we would do the same again today. Let's pass this Bill and send it on its way to the other body so that they can act on it. I hope that puts this to rest for some period of time. Thank you.

The SPEAKER: A roll call has been requested. In order for the Chair to order a roll call it must have the expressed desire of more than one-fifth of the members present and voting. Those in favor will vote yes; those opposed will vote no.
