Dear Speaker Martin:

Please find enclosed a copy of the **3rd An**nual Fee Review prepared by the Department's Bureau of Medical Services Staff in compliance with 22 M.R.S.A., section 3173. The primary objectives of the review were to consider, in consultation with providers and their representative associations, the cost of providing specific services, the effect of various economic factors on the adequancy of existing fee schedules, and the Department's obligation to ensure sufficient provider participation in the Medical Assistance Program.

As you will note in the attached summary, the major conclusions reached as a result of the 3rd Annual Fee Review are:

1. The Department of Human Services had fulfilled its obligation under 22 M.R.S.A., section 3173 — AN ACT Concerning Review of Fees for Providers Under the Medical Assistance Program.

2. The Department of Human Services has, as a result of the review, made some changes in fee schedules. Oral surgery fees have been increased with special attention given to orthognathic procedures. Durable Medical Equipment and Suppplies percentage mark-up allowances have been increased and, with a special appropriations from the Legislature, the ambulance fee schedule has been increased. An increase in orthodontia fees is planned for the Spring of 1985, and Department of Human Services is working with the Department of Mental Health and Retardation's Bureau of Mental Health toward increasing reimbursement for Mental Health Clinic services.

Medicaid coverage has also been expanded to include specific services provided in freestanding Substance Abuse Treatment Facilities.

Details of these and other Medicaid fee schedule adjustments which have been made since the enactment of P.L. 1981, C. 329 are noted in Table G of the summary.

3. The Department acknowledges the existance of certain problem areas and the necessity of addressing these areas with specific fee increases. However, the Department also recognizes that such action is not feasible within existing fiscal constraints.

As indicated in the attached document, copies of the review are also being shared with representative health care provider associations and, upon request, individual providers. Any questions or concerns you may have

Representative from Portland, Representative Connolly.

Representative CONNOLLY: Mr. Speaker, Members of the House: It is my intention this morning-I have no illusions whatsoever about the ultimate fate of this bill-this bill is going to pass. The two roll call votes that were taken in this body last week and the week before, I believe, showed that there was overwhelming support for this legislation and the votes were better than two to one, I believe. However, I am going to request this morning that someone make a motion to table this bill for two days because I believe that since it appears certain that this bill is going to become law that we, in this legislature, should know exactly what we are getting ourselves into and should know from the very beginning whether or not there are any possible constitutional or legal questions with this bill.

I got caught off-guard, I thought that this bill had been held up in the other body and was going to be debated in the other body and would not be in here for enactment until probably Thursday or Friday of this week and it was not until I arrived here this morning and saw the calendar that I saw that it was up for enactment.

I am preparing a letter to the Attorney General that will be delivered this afternoon that will be asking the Attorney General whether or not this legislation, if it becomes law, violates either the U.S. Constitution or the State Constitution on certain technical grounds dealing with equal protection and selfincrimination and also asking a question whether or not this would violate the state's Human Rights Act because it is discriminatory. Even the supporters of the legislation admitted last week in debate that this legislation discriminates against young men and it also discriminates against poor people, those people who must rely on student aid in order to go to school.

The Governor has sadly given his support for the legislation and, obviously if it gets to his desk, he is going to sign it. There is no question whatsoever what this body is going to do if the vote is taken today or if it is taken two days from now or if it is taken two weeks from now, the votes are here to pass it. If we are going to pass the legislation, I think we should know exactly what we are getting ourselves into and I would ask this body, as perhaps a matter of courtesy, tht they allow this bill to be tabled for two days so that we have an opportunity to get a formal opinion from the Attorney General.

The SPEAKER: The Chair recognizes the Representative from Canton, Representative MCCOLLISTER.

Representative McCOLLISTER: Mr. Speaker, I move that this be tabled for two legislative days.

Representative Kane of South Portland requested a roll call.

The SPEAKER: For the Chair to order a roll, it must have the expressed desire of more than one-fifth of the members present and voting. Those in favor will vote yes; those opposed will vote no

Obviously, more than one-fifth of the members present and voting having expressed a desire for a roll call, a roll call was ordered.

The SPEAKER: The pending question before the House is the motion of the Representative from Canton, Representative McCollister, that this bill be tabled for two legislative days. Those is favor will vote yes; those opposed will vote no
