The following Joint Resolution: (S.P. 419) JOINT RESOLUTION MEMORIALIZING CONGRESS TO RESTORE FUNDING FOR THE SMALL BUSINESS ADMINISTRATION

WE, your Memorialists, the Senate and the House of Representatives of the State of Maine in the One Hundred and Twelfth Legislative Session now assembled, most respectfully present and petition the Congress of the United States, as follows:

WHEREAS, 97% of all businesses in Maine are defined by the Small Business Administra-

tion as being small businesses; and WHEREAS, in 1984, the Small Business Administration approved \$29.3 million in loans to 188 small businesses; maintained a portfolio of over 2,900 loans worth more than \$134 million; sponsored training programs for over 4,000 small business people; and, by establishing a revolving line of credit financing, made available working capital loans up to \$1 million to exporters; and

WHEREAS, the Small Business Development Center, whose principal source of funding is the Small Business Administration, provided counseling to more than 1,300 businesses, training programs for over 1,500 small business people and responded to more than 650 information requests through its Business Informtion Service; now, therefore, be it

RESOLVED: That We. your Memorialists, respectfully urge and request that the Congress of the United States restore the funding for the Small Business Administration, which has assisted Maine Businesses throughout the years; and be it further

RESOLVED: That a copy of this Memorial duly authenticated by the Secretary of State, be transmitted forthwith by the Secretary of State to each member of the Maine Congressional Delegation and to the President of the Senate and the Speaker of the House of Representatives of the Congress of the United States.

Representative Murphy of Berwick offered House Amendment "A" (H-43) and moved its adoption.

House Amendment "A" was read by the Clerk.

The SPEAKER: The Chair recognizes the Representative from Berwick, Representative Murphy.

Representative MURPHY: Mr. Speaker. Ladies and Gentlemen of the House: What this amendment does is it raises the copy of the vital statistics from \$2.00 to \$3.00 for the first copy and it does not change the figure of the second additional copy. I am sorry, it doesn't raise it from \$2.00 to \$3.00 it decreases it from \$5.00 to \$3.00. When the Clerks' Association asked for this increase, this was the original amount they wanted but when the state went to \$5.00 on January 1st, that is when they came and wanted the whole \$5.00. I certainly believe that a \$3.00 increase in a service provided by our towns to our people is much too high when it is 150% I don't believe that the cost of doing these copies has gone up 150% and, in our society today, we don't only have to get death certificates when someone dies or marriage certificates or birth certificates, there are many things, if we want to travel or a number of things that we have to go in and get copies of our births and certain things. So therefore, I wish you would support this amendment as being fair to our town clerks and also to our constituents.

The SPEAKER: The Chair recognizes the Representative from Milo, Representative Masterman.

Representative MASTERMAN: Mr. Speaker. I don't see the sponsor of this bill in the House

and I would move this be tabled one day.
The SPEAKER: The Chair recognizes the Representative from Milo, Representative

Masterman: Representative MASTERMAN: Mr. Speaker. I understood Gregg Nadeau to say he was the sponsor of the bill. In view of the fact that he

isn't sponsor of the bill, I withdraw my motion. The SPEAKER: The Chair recognizes the Representative from Wells, Representative Wentworth.

Representative WENTWORTH: Mr. Speaker and Members of the House: I have to ask you to vote against this amendment in order to adopt the original bill. This is a request from the Maine City and Clerks' Association because there has been no increase for more than 8 years. Please remember that this is only an increase on the first copy. If we do not increase this fee, then the property taxpayers will have to subsidize any further increase in cost. Your town clerk's do all the verifying and, if necessary, the completing of vital records which are then forwarded to the state. The state merely records them.

I hope that you will pass this bill, will stay with your decision and I would ask those of you who voted against the bill to reconsider and support your municipal clerk. I request a roll call

The SPEAKER: The Chair recognizes the Representative from Camden, Representative Taylor.

Representative TAYLOR: Mr. Speaker. Members of the House: I urge also, that you do not support the amendment that has been presented today and support this first motion that you heard vesterday.

I would just like to add two points to what perhaps what you already do know. Remember that any research around these records is done at the local level. And furthermore, that the approximately 175 clerks in the towns of less than 1,000 rely pretty heavily on the bulk of these fees for their income. The time and research and preparation particularly in those towns is even greater so I do urge your defeat

of this amendment.

The SPEAKER: The Chair recognizes the Representative from Lewiston, Representative Nadeau.

Representative NADEAU: Mr. Speaker. Members of the House: My thanks to the Representative from Milo, Mr. Masterman for his consideration. I am a cosponsor of this bill, however. I simply want to say that I obviously concur with the two previous speakers. Currently, the case at the state level is that the statutes give the Commissioner the authority to adjust these fees at essentially his discretion For the purpose of recouping the cost of the program, I think that is essentially what we are asking at the local level. The current \$5.00 fee at the state level doesn't even cover cost and I think that they may be considering an increase as well. All we are asking is that the fee at the local level be comparable to that at the state level to recover costs. As we stated, it is an expensive process keeping these records and the process of searching and all of that. All we are asking is that the fee be raised after a long time to cover the cost so that municipalities are not burdened and that the users of these vital records be asked to pay the cost of that program as well. I would ask you to defeat the amendment and will move to accept the Majority Report

The SPEAKER: The Chair recognizes the Representative from Sanford, Representative Hale

Representative HALE: Mr. Speaker. Men and Women of the House: I urge you to support the amendment before you today. This is a 50% increase to your municipalities which is not necessary. The Department of Human Services may need an increase but our record keeping in each municipality certainly does not need an increase. The paper is supplied by the state to the municipalities. I don't know what else I can say other than what I said the other day. Our municipality, our people, are the taxpayers of this State of Maine. They do support the Department of Human Services. We are trying to give them a service in our municipalities and they certainly should not be penalized at the rate that the original bill requests. An increase of \$1.00 for the original document more than justifies the cost. I have checked into it very carefully. I don't know about you, but for ten minutes work, I don't expect to pay 50° per minute. I urge the ones that did not vote for it originally to reconsider and to adopt the amendment

The SPEAKER: The Chair recognizes the Representative from Madawaska, Representative McHenry.

Representative McHENRY: Mr. Speaker. Ladies and Gentlemen of the House: I would like, first of all, to set the record straight. When I debated the bill the first time, I had said that this bill was attached to the rule-making process and I was debating the original bill and not the new draft. So I apologize. That's straightened out.

I believe that the Clerks' Association when they met, were voting on \$3.00 and since then the state has gone up to \$5.00. They did not vote on the \$5.00 from what I understand. So the \$3.00 I believe is what they wanted and I have no problem with the \$3.00. 5.00 for the state — they have to go through millions, while a municipality might go through thousands or hundreds. There is a big difference when the state searches for vital statistics and when a small municipality searches or a large municipality. There are differences. It is not all \$5.00 work. In some municipality it might take them two minutes. Two minutes for \$5.00 is quite a bit of money.

The SPEAKER: The Chair recognizes the Representative from Corinth, Representative Strout.

Representative STROUT: Mr. Speaker. Members of the House: It has been mentioned this afternoon that those clerks who receive their fees, about 175 of them, this is some of the only money that they get for doing their iob. Let me remind you that when the clerk's run for their office each year, they know what the job pays and they know what they get for fees. I take you back to last October, October of 1984 at the MMA convention. At that time, this bill was discussed and it was discussed whether we should go to \$3.00 or to \$5.00. At that time, it was not unanimous either way, but it was the feeling of a lot of those town clerks that to go from \$2.00 to \$3.00 was enough this year. I speak here today, not for the town clerks, but I speak for the citizens that are going in to have certified copies. I think that it is reasonable to go at this time, from \$2.00 to \$3.00 rather than support the draft that came out increasing 150%. I would urge you to support the amendment.

The SPEAKER: The Chair recognizes the Representative from Wells, Representative Wentworth.

Representative WENTWORTH: Mr. Speaker, Members of the House: Just to clarify the request of the town and city clerks was to conform with the state fee. And let me remind you once more that the state does no research, all the verifying, all the completing, is done by the home clerk in the town who receives it. The state merely receives it and records it.

The SPEAKER: The Chair recognizes the Representative from Island Falls, Representative Smith:

Representative SMITH: Mr. Speaker, Ladies and Gentlemen of the House: This copy of record we are talking about is birth record, death certificate and marriage record. This isn't something you need every day, every month or every year. I would ask you, any of you, when was the last time you had purchased a record? How many have you purchased in a life time? Now if this was something you were purchasing every week, every month, then I would feel that \$5.00 was too much. But when you consider the number of copies that you would actually be buying, it wouldn't amount to much. You know, the clerks in all our towns are compassionate people. If there was someone they feel that couldn't afford to pay the \$5.00, I am sure they have a remedy for that. I hope you vote against the amendment

The SPEAKER: A roll call has been requested. For the Chair to order a roll call it must have the expressed desire of more than one-fifth of the members present and voting. Those in favor will vote yes; those opposed will vote no.

A vote of the House was taken and, obviously, more than one-fifth of the members present and voting having expressed a desire for a roll call, a roll call was ordered.

The SPEAKER: The Chair recognizes the Representative from Milo, Representative Masterman.

Representative MASTERMAN: Mr. Speaker. Men and Women of the House: I hope you will recall the brevity exercised by the minister yesterday morning when he lead us to the throne of grace in such a clear and concise manner. I appreciate short invocations, like yesterday morning, and I appreciate speeches that are also to the point. Therefore, all I will say is, that if we are as concerned about the burden of the property tax that we all seem to be during our campaigns, then we will defeat this motion and get on with the bill as it was signed out by the ten members of the committee.

The SPEAKER: The pending question before the House is adoption of House Amendment "A." Those in favor will vote yes; those opposed will vote no.
