The SPEAKER PRO TEM: The Chair recognizes the Representative from Washington, Representative Allen.

Representative ALLEN: Mr. Speaker, Men and Women of the House: I would urge you this morning to accept House Amendment "A". It is the result of many long hours of work and compromise on behalf of both the members of the Legislative Delegation in Lincoln County and the Legislative Delegation of Knox County of which I am a member of both

As Chair of a sub-committee dealing with the Knox-Lincoln County Extension, we felt it was imperative that the County Extension Service be funded in a way that was equitable to both counties. In the past there has been some discussion as to what the percentage breakdown should be according to the law with regards to extensions that are shared by two counties. I believe that further on in this session we will be dealiung with a bill from agriculture that hopefully will settle this kind of a problem in the future. But the amendment that you have before you today is the result of a compromise that was accepted by the Knox County Delegation and I understand is an accepted compromise with the Lincoln County Delegation so I urge your support. The SPEAKER PRO TEM: The Chair

Representative HOLLOWAY: Mr. Speaker and Members of the House: For the Record, I mostly wanted to say that the Lincoln County Commissioners voted to hold the line on the Knox-Lincoln County budget as did the budget committee and there was no opposition voiced at the public hearing. When Knox County cut their extension funding by 5 percent, a deficit was created within the extension budget. So. this sub-committee that the Representative spoke of was established between both county legislators and it is now the decision of Lincoln County who has the highest evaluation to make up for that deficit for the current year. Thereupon, House Amendment "A" was

adopted.

An Act to Authorize the Sale of Frozen Lobster Tails (H.P. 231) (L.D. 272) (C. "A" H-68) Was reported by the Committee on Engrossed

Bills as truly and strictly engrossed. The SPEAKER PRO TEM: The Chair recognizes the Representative from St. George, Representative Scarpino.

Representative SCARPINO: Mr. Speaker, Ladies and Gentlemen of the House: I will make this brief. This bill came out a unanimous report. The only reason it came out a unanimous report is I was out with the flu and, under the current 48 hour rule we have, my vote was cast with the majority. If I had been present, it would not have been.

I have tow problems with this bill. One, the bill was presented by the department in an attempt to correct or by their definition correct a situation that is currently allowing a half million dollar annual illegal business within this state. It is currently against the law to market or sell frozen lobster tails. It violates our mutilization laws. There is an underground business that has been going on for a number of years that has now reached the size of a half a million dollars a year. This bill would serve the purpose to make what is currently illegal legal in order to justify for economic reasons the business.

The other problem I have is quite simply that in the testimony at the public hearing both Major Pinkham, the Chief of Marine Patrol and the commissioner acknowledged the fact that we have no viable dependable method to judge the legal size of a lobster by the size of that lobster tails after is has been removed from the carcass of the lobster. My main fear is that unless we have the Marine Patrol Officers to put them on sight, and every dealer who is licensed to deal with frozen lobster tails, we will have no means to prevent the opening of a pipeline for the tails from illegal short lobsters. The future of our lobster industry is dependent in a tremendous account to the protection of our juveniles. We have taken many actions, escape hatches and traps and a number of other things to protect our juvenile lobsters. My major fear is that this bill would open an illegal pipeline for the sale of illegal short lobsters. Based on that and that alone, would request that you oppose this bill.

Mr. Speaker, I request a roll call

The SPEAKER PRO TEM: A roll call has been requested. For the Chair to order a roll call, it must have the expressed desire of one-fifth of the members present and voting. Those in favor will vote yes; those opposed will vote no.

A vote of the House was taken and, obviously, more than one-fifth of the members present and voting having expressed a desire for a roll call, a roll call was ordered.

The SPEAKER PRO TEM: The Chair recognizes the Representative from Stockton Springs, Representative Crowley.

Representative CROWLEY: Mr. Speaker, Ladies and Gentlemen of the House: Just to clarify a few things. The first problem, we had, the 48 hour problem, we held this bill for a lot longer than 48 hours because one of the members of the committee, not Representative Scarpino, was having trouble with accepting the bill and wanted to get more facts, wanted to speak with the commissioner some more on it and so we must have held the bill for about a week, maybe more. It was really not rushed out in order to do something underhanded. I know that Representative Scarpino is not saying that.

The Committee had reservations about the bill and we studied hard and came up with the unanimous "Ought to Pass.' We have got two ways to go here, either we punish the industry by the department's lack of oversight here or we take the commissioner and his crew to the woodshed. We are having the committe report to us by January 1, 1986 on their actions on this bill and we have sunsetted the bill for May 1986 so there will be no loopholes in this thing. I hope you will go along with the committee

The SPEAKER PRO TEM: The Chair

recognizes the Representative from St. George, Representative Scarpino.

Representative SCARPINO: Mr. Speaker, Men and Women of the House: Just to agree with something that my chairman has said, there is no concern involved with this with any hankypanky that went on with the report. I was out for a period of time, in excess, with both our recesses over the Easter vacation and being ill slightly before and for a couple of days after which made it under our existing 48 hour rule impossible for me to be in a position to sign the bill in the "Ought Not to Pass."

As far as taking the commission to the woodshed, I have currently pending request to the Attorney General's Office to find out if the commissioner has, in fact, violated state statute by being overly involved with 12 lobster dealers by his own admission in the press in what would appear to be an illegal operation. My concern is not with the specifics or with the honesty and equitability of these particular lobster dealers. I have no doubt that they are honest and equitable men. If they weren't, they wouldn't have taken the position or chosen the avenue they chose to attempt to correct the situation.

My concern is with the potential unethical individual that will take advantage of a situation that it would create if we pass this bill and would start dealing in illegal short lobster tails. My concern is to prevent that from happening. It is an ackowledgment that it would have a negative financial impact on some individuals. But they, to be quite honest about it, started a business and developed the business with the full knowledge that it was illegal when they did that. I do not think that we ought to be taking positions of sympathy for those individuals who, with their full knowledge, entered into the creation of a business that was against state statute. I do feel, however, that we ought to take full consideration to make sure that those individuals who would continue in that practice, would continue in an illegal manner, should be prevented. Based on that, I would once again request that you oppose this measure.

The SPEAKER PRO TEM: A roll call has been ordered. The pending question before the House is passage to be enacted. This being an emergency measure, a two-thirds vote of the House is necessary. Those in favor will vote yes; those opposed will vote no.
