This 1985 report to the Maine State Legislature is submitted in response to legislation enacted in 1975 (P.L. c. 584; 7 MRSA section 2, subsection 5). That law requires the Commissioner of Agriculture, Food and Rural Resources to annually recommend "methods of stimulating and encouraging the growth and modernization of agricultural enterprises in this State." Given the serious problems and major changes facing agriculture nationally, this charge to maintain and expand agriculture in Maine will be particularly challenging in the years to come.

During the past year, the Department of Agriculture, Food and Rural Resources has been implementing a number of new programs designed to deal with many of the needs and problems confronting Maine Agriculture. In this report, we review recent accomplishments and describe the new initiatives we believe are necessary for the future.

Working together, farmers, agricultural leaders, the Department and members of the Maine State Legislature can meet today's challenges and use them to strengthen future prospects for agriculture in Maine. I look forward to that cooperative effort.

Representative MAYO: Mr. Speaker, Men and Women of the House: I rise today as the sponsor of L.D. 492. Donald E. Davey was killed in the line of duty on July 30, 1984 while enroute to an investigation for the Lincoln County Sheriff's Department. Detective Sergeant Davey was an 11 year veteran of the Lincoln County Sheriff's Department. He is survived by his wife Lorinda and their two daughters, Jessica and Cicily.

I will not attempt to paint a picture of Detective Sergeant Davey that enlarges him in death beyond what he was in life. He did not attain great notoriety or fame. He did not solve the great problems of our time. He simply made the largest sacrifice that an individual can make to protect his state and country, he laid down his life. There are those that will say that,

because Detective Sergeant Davey was not a famous man, we should not name the Wiscasset Bridge after him. I say it is time that those in this state who serve the public good behind the scenes and out of the limelight are honored in a way such as this. It is because of Detective Sergeant Davey and people like him that other people are able to attain recognition and fame. I believe those people who quietly go to work every day, who protect our streets and homes, who perform many tasks for the public good, are rarely recognized for their efforts. I ask you then, is it not time that we honor a man such as Detective Sergeant Donald E. Davey in this way?

I simply ask you to act favorably on this Resolve for when we honor Detective Sergeant Davey in this way, we honor the thousands of individuals across the state who, like him,

quietly go to work every day.

Report was accepted, the bill read once and assigned for Second Reading tomorrow.
