The SPEAKER: The Chair recognizes the Representative from Scarborough, Representative Higgins.

Representative HIGGINS: Mr. Speaker, Ladies and Gentlemen of the House: Over the past few years, there has been a considerable amount of talk around the nation and certainly in these halls about excellence in education. Today, I want to share with you what I believe is an extremely exciting educational feat accomplished by nine Scarborough high school junior and senior students with the assistance of numerous advisors and tutors.

On April 10th in Los Angeles, California, the

U.S. Decathlon was held. At least 35 schools from around the nation competed for top honors. The intent of the decathlon was to encourage high school students to place the same kind of emphasis and enthusiasm on academic winning as there is on athletic winning. Scarborough was selected to represent Maine this year in the national competition because our principal, Sharon Hennessey, agreed to coordinate the statewide competition in next years event. Competition rules required that each team include, not only A students but an equal amount of B and \tilde{C} students as well. For months prior to this event, these nine students and their advisors and tutors spent countless hours, seven days a week, preparing for this test, not only in subjects with history, English,

science and math but also becoming well

versed in other non-traditional, if you will,

areas such as fine arts, economics, and public

speaking. The entire student body and the community itself provided strong support for our team. Besides the tutors who are here today, many fellow students served as study assistants; others helped in raising funds; local clubs and businesses raised over \$13,000 to send these students to Los Angeles.

Now that I have given you the background for this outstanding group, I am extremely proud to say, as you can see on the calendar today, that Scarborough placed 15th nationally against schools from around the nation, many of them who had been in competition for many, many years and certainly schools who were many times the size of Scarborough's.

In addition to this accomplishment as a team, one student, a junior, stood out as one of the top three performers nationally in the competion. Art Driscoll, age 18, won gold medals both in math and English events; silver in economics; and a bronze in science. This best in the nation showing earned him a \$2,000 scholarship. I know that you will agree with me that his performance is a truly amazing feat as well as that of the entire team

As one of the three Scarborough High alumni in this body, I want you to know how proud I am of their accomplishments. The state has every right to be as proud. We look forward to competing against some of your schools next year and I know that Scarborough High School has supplied some of that excellence in education that I spoke of earlier.
