Reports were read.

The SPEAKER: The Chair recognizes the Representative from Gorham, Representative Brown.

Representative BROWN: Mr. Speaker, Men and Women of the House: I move that the House accept the Majority "Ought to Pass" Report, Report "A."

The original bill would have provided for the Commissioner of the Department of Educational and Cultural Services to award up to \$5,000 as reimbursement for travel and other expenses associated with the duties of the Teacher of the Year. That money would have been paid from the classroom based Innovative Educational Grants Program. In Report "A", a majority of the committee felt that use of those funds was appropriate, but also supported amending the bill to require the commissioner to use other available funds for those purposes before using the Innovative Grant money.

There were two Minority Reports. The first, Report "B" "Ought Not to Pass" would do nothing to help defray the costs incurred by the Teacher of the Year. Report "C", the second Minority Report, would amend the bill to provide for up to \$2,000 in general expense from the General Fund and payment of additional expenses associated with promotion of an innovative classroom grant program by the Teacher of the Year from the innovative grant money. That was supported by one person.

The Majority Report was supported by eight people. This bill establishes a permanent funding mechanism for Teacher of the Year, which would be for travel expenses and a special project. Testimony from former Teachers of the Year indicated that they had to pay out of their pocket for their expenses. I wonder what legislator would travel across Maine at his own expense to promote whatever honor he or she was given.

This bill is supported by Maine School Management, MTA and the Department of Education. A project created by Maine Teacher of the Year does warrant an innovative grant and I am sorry such a worthy piece of legislation has been lobbied against so extensively. Any off the record agreement to find the money this year does nothing to fund future Teachers of the Year. One argument we heard in committee was that there were not enough candidates applying for the honor. I think if we pass this bill, there will be more teachers interested in applying for the honor because they will know that funds are available for their expenses.

I urge you to support the Majority Report out of the Education Committee, which was not partisan. When the vote is taken Mr. Speaker, I request the yeas and nays.

The SPEAKER: A roll call has been requested. For the Chair to order a roll call, it must have the expressed desire of more than one-fifth of the members present and voting. Those in favor will vote yes; those opposed will vote no.

A vote of the House was taken and more than one-fifth of the members present and voting having expressed a desire for a roll call, a roll call was ordered.

At this point, the Speaker appointed Representative Gwadosky of Fairfield to act as Speaker pro tem. The House was called to order by the Speaker pro tem.

The SPEAKER PRO TEM: The Chair recognizes the Representative from Lewiston, Representative Handy.

Representative HANDY: Mr. Speaker, Men and Women of the House: I signed the Minority "Ought Not to Pass" Report for a number of reasons and basically these are policy reasons and no other reason exists. I am not against having a Teacher of the Year.

I would like to provide you with some information which is what I would deem to be accurate so that you can get the complete picture. I am sure many of us are under the impression that this Teacher of the Year superlative in the competition is one program that is administered, organized, sanctioned and funded fully by state government. It is none of those. The Teacher of the Year program is a program that is sponsored by corporations, among them the Encyclopedia Britannica.

The role of the Department of Education is simply that of a clearing house that administers and disperses the information regarding the program.

My reason for opposing providing monies for this program is because this is run by corporations; it is not something that the legislature as a lawmaking body of this state has had a role in (designing the program). I don't think that we should be put in the position of having to financially back up a program that is run by corporations.

With respect to some comments that were made earlier, there were some of the organizations, who testified at our public hearing in support of the program, that did caution us about taking monies out of the Innovative Grant Program. The Innovative Grant Program, which is part of the Education Reform Act, is one of the most widely applauded and accepted programs, applauded widely and accepted by administrators, teachers and a number of people and groups within the educational community. In the Innovative Grant Program, there is a specific process one goes through like any other grant process and that is the way it should be. One should not be handed carte blanche because they have been designated by a particular group of corporations that they are the Teacher of the Year. Although I endorse recognizing a Teacher of the Year, I do not support these monies coming from state funds, particularly where it is private corporations.

I would urge you to oppose the pending motion so that we can go on to accept the Minority "Ought Not to Pass" Report.

The SPEAKER PRO TEM: The Chair recognizes the Representative from Yarmouth, Representative Foss.

Representative FOSS: Mr. Speaker, Men and Women of the House: Maine's Teacher of the Year is representative of the best and brightest in the teaching profession. The Teacher of the Year is promoted by the Department of Education and is designed to recognize a teacher who represents outstanding scholarship, effective instructional practices, and leadership.

Although endorsed by the Education Department, money for travel expenses and any substitute costs have been provided in the past by the local school district or the recognized teacher. Many times, the individual who has received this award, has been forced to use personal funds to carry out the responsibilities of the honor.

This year, at the request of Commissioner Boose, the 1986 Maine Teacher of the Year, Charlie Seymour of Camden-Rockport High School, decided to develop a project to aid in implementing the new fine arts curriculum as enacted by the legislature. Mr. Seymour agreed to this request and has pursued the production of a video tape promoting fine arts. He has stated and I quote, "There are some school districts who are resisting the incorporation of the fine arts requirement into their program. My goal will be to help those schools bridge the gap from what they believe presents a hardship to them to what I believe is possible for the utilization of communities."

I think this video tape is a timely idea and shows real initiative, and unfortunately, state funds were not specifically designated for this kind of project. The bill before you today, L.D. 2146, is supported by a majority of the Education Committee including its two chairmen. As stated earlier, it provides a permanent funding mechanism for future Teachers of the Year and this funding should encourage, not only the development of innovative projects, but it will also encourage more teachers to apply for the honor because they will know that they will not have to use their own personal funds to carry out their responsibilities.

In reference to the innovative grants money, there is \$750,000 in the fund. Last year, there was no argument about tapping that fund for \$60,000 for an administrative certification bill. In light of that, the argument against earmarking \$5,000 of that three-quarters of a million dollars for a Teacher of the Year project, which is surely an example of an innovative classroom based grant for the finest representative of Maine's teachers, becomes a little hollow. In fact, as mentioned by the Chairman of the Committee, the amended version of this bill, again supported by the majority, provides for the use of alternative sources of funding -- for example from other parts of the Education Budget or from federal funds, if they are available, before the use of innovative grant funds.

I hope you will support L.D. 2146 as endorsed by the majority, by the Maine Teachers Association and by Maine School Management Association. It will appropriately recognize the expertise of the Maine Teacher of the Year and will encourage the development of projects that will benefit all Maine children. The Teacher of the Year award has been in existence since 1951. It is about time after 35 years for the state to provide a permanent source of funding to allow the recipients to carry out a meaningful expression of the honor. It is a state program and should be state financed.

The SPEAKER PRO TEM: The Chair recognizes the Representative from Rockland, Representative Melendy.

Representative MELENDY: Mr. Speaker, Ladies and Gentlemen of the House: I will be voting against the pending motion and I would like to tell you my reason for doing so. I feel this is another "do nothing" bill.

It is allowing the department to do what it already can do. In late January, I spoke with Commissioner Boose regarding the matter of Teacher of

the Year. He assured me at that time that the needed funding would be taken care of to assist the current Teacher of the Year, who is from the mid-coast area and who he had asked to do a specific project, that the money would be there to fund it. Recently, I spoke to the acting Commissioner and he said, whether this bill passed or not, that because former Commissioner Boose had made a promise to the Teacher of the Year, that the funding would be there. So I say to you — do we have to pass a bill when something can already be done from within the department?

The SPEAKER PRO TEM: The Chair recognizes the Representative from Orono, Representative Bott.

Representative BOTT: Mr. Speaker, Men and Women of the House: I wish to pose a question if I may.

The previous speaker said that the funding is there currently for this year's Teacher of the Year. Is there any guarantee the funding would be there next year and the year after that?

The SPEAKER PRO TEM: The Representative from Orono, Representative Bott, has posed a question through the Chair to anyone who may respond if they so desire.

The Chair recognizes the Representative from Gorham, Representative Brown.

Representative BROWN: Mr. Speaker, Men and Women of the House: No there is no guarantee, that is why the legislation is necessary so there will be a permanent funding mechanism in the law.

The SPEAKER PRO TEM: The Chair recognizes the Representative from Orono, Representative Bott.

Representative BOTT: Mr. Speaker, Men and Women of the House: In light of the remarks just made by the good Representative from Gorham, I would hope that you will support the Majority Report so we can get this into law and we can recognize Maine's Teacher of the Year, not just now, but in the future. Let's look to the future and vote with the majority of the committee.

The SPEAKER PRO TEM: The Chair recognizes the Representative from Westbrook, Representative O'Gara. Representative O'GARA: Mr. Speaker, Men and

Women of the House: I want to also respond to that. Obviously, the Education Committee and this legislature cannot pin down an incoming Commissioner of Education, even though the outgoing Commissioner made comment that he would provide funds, that doesn't in any way ensure that this program will be funded in the future.

What I really wanted to stand up for -- this is a simple, nice, clean bill that, for the first time in a long time, up to \$5,000 would be used to support a teacher that has been recognized out of Maine's almost 14,000 teachers as its Teacher of the Year. have heard several people talking about why should we spend money for trips and travel and all that sort of thing --- it almost makes me smile sometimes that legislators would make that kind of a comment. The only reason that it is in there, the only reason, is that if the Teacher of the Year, the person that is selected, in my opinion, as he or she is doing the research for the project they are going to be asked to do and may be asked in a variety of ways to go around the state and to talk about being Teacher of the Year and gather information for his or her report, that is what the money is for, not for trips here or there or just for any reason at all.

The only other thing I want to say Mr. Chairman to the ladies and gentlemen of the House -- in the

short time I have been here, I have seen a lot of bills lobbied, bills of great significance but I haven't anything like the kind of lobbying and the things that have gone on, as I sat there and listened with no opposition at the hearing, it was glowing, the comments that were made. None of the people, who have gone around and worked very hard to bring this to the kind of situation we have right now, were there to speak against the bill -- there were none. I do hope that you will set all of that aside if you can and recognize the bill for what it is, a very simple bill, taking perhaps up to \$5,000 out of \$700,000 and whatever else it was, to honor a teacher in the future. It just simply makes it permanent rather than saying, perhaps money will be available. perhaps it won't.

The SPEAKER PRO TEM: The Chair recognizes the Representative from Kittery, Representative Soucy.

Representative SOUCY: Mr. Speaker, Ladies and Gentlemen of the House: When we heard the original bill, I had problems with giving \$4,000 to the Teacher of the Year. I have no problems with reimbursing him for travel expenses or substitute teachers when he is traveling throughout the state. I also asked a question -- how many applicants did they have for this honor? We have approximately 14,500 teachers and we had thirty-five or less people apply for this.

As I said, I have no problem with providing money, approximately \$1,000 for substitute teachers, travels, etc., but I have real problems if we are going to provide money so that the people can come up with a project.

The SPEAKER PRO TEM: The pending question before the House is the motion of the Representative from Gorham, Representative Brown, that the House accept the Majority "Ought to Pass" Report.

The SPEAKER PRO TEM: The Chair recognizes the Representative from Gray, Representative Carroll.

Representative CARROLL: Mr. Speaker, Men Women of the House: I wish to pair my vote with and the Representative from Orono, Representative Bost. If he were here and voting, he would be voting no and if I were voting, I would be voting yes.

The SPEAKER PRO TEM: The pending question before the House is the motion of the Representative from Gorham, Representative Brown, that the House accept the Majority "Ought to Pass" Report. Those in favor will vote yes; those opposed will vote no.

77 having voted in the affirmative and 56 in the negative with 16 absent and 2 paired, the motion to accept the Majority "Ought to Pass" Report did prevail.
