The House met according to adjournment and was called to order by the Speaker.

Prayer by Father Renald Labarre, St. Philip's Catholic Church, Auburn.

The Journal of Tuesday, February 10, 1987, was read and approved.

Quorum call was held.

SENATE PAPERS

The following Joint Resolution: (S.P. 122) JOINT RESOLUTION CALLING ON THE HEALTH-TEX CORPORATION

TO SEEK ALTERNATIVES

TO THE PROPOSED CLOSING OF HEALTH-TEX PLANTS IN MAINE WHEREAS, Health-Tex, Inc., announced on January 29, 1987, that their factories in Portland, Brunswick and Gardiner, Maine, will be closed by March 31, 1987, resulting in the loss of over 1,000 jobs in this State; and

WHEREAS, Health-Tex, Inc., has diverted work from its Maine factories to other worksites, causing the great majority of employees at those factories to be laid off from their jobs and the remaining employees to be laid off soon; and

WHEREAS, Health-Tex, Inc., has maintained its factories in Maine for over 30 years and the workers in these factories have worked diligently and loyally for that period of time, helping to make Health-Tex, Inc., America's largest manufacturer of children's clothes; and

WHEREAS, the closing of these plants will have a severe impact upon the dedicated workers at the Health-Tex plants, resulting in the loss of livelihood and income to those workers; and

WHEREAS, the closing of these plants will also have a severe impact upon Maine's economy, including an estimated loss of over \$33,500,000 from the State, which does not include other costs to the State, such as unemployment compensation, job relocation training costs, welfare and other costs; and

WHEREAS, the State of Maine has recently begun an effort to improve its business climate, including the formation of a Joint Standing Committee on Economic Development and initiatives within the Executive Department; now, therefore, be it

RESOLVED: That the Legislature make all efforts possible to minimize or avoid the human and economic costs associated with the closing of the Health-Tex, Inc., plants, including:

1. Strongly urging the Health-Tex corporation to immediately supply work to the Maine plants in order to keep the plants open and operating while discussions between the company and the union continue;

2. Strongly urging the Health-Tex corporation to continue discussions with emplovee representatives to find alternatives to the planned closings; and

Meeting with representatives the Health-Tex corporation, along representatives of the Governor's office and the State's congressional delegation, in order to seek a mutually satisfactory solution to the company's and the employees' problems which will save Maine jobs and keep a valued employer in the State; and be it further

RESOLVED: That copies of this resolution be made available to the employees of the Health-Tex, Inc., plants and the corporate officers of Health-Tex, Inc.

Came from the Senate, read and adopted. Was read.

The SPEAKER: The Chair recognizes Representative from Kennebunk, Representative Murphy.

Representative MURPHY: Mr. Speaker, Men Women of the House: This Resolution captures a sense of frustration in terms of the possibility of jobs leaving Maine but I think also it catches a tone, that gone are the days we throw up our hands and gone are the days that we make caustic comments to the distant board of directors.

You can feel the change down on the second floor and I hope that change of attitude is here in the legislature as well. Last week, when the first announcement of loss of jobs at Health-Tex came forth, there was a tone of confrontation; this week there is a different attitude. The hurt is still there but there is a tone of cooperation. I think today we have to look at how we work together labor, the executive branch and the legislature to keep Maine jobs in Maine.

I think it is very clear, ladies and gentlemen of the House, that we do not have a state plan, we do not have a state strategy to keep Maine jobs in Maine. We reel back and forth, based on the price of

oil and the tide of imports.

My good friend in the other corner, he and I, continually debate back and forth the business climate survey studies and statistics contained within but this week, on the second floor and here in the hall, we saw those statistics, the men and women of Health-Tex, have lost their jobs and we could see the hurt on their faces. The Governor has met with the labor leaders of Health-Tex and individual legislators have met with those displaced workers. The Governor, next week, is going to Boston to meet with management and talk about those Maine jobs but we also have a responsibility. The Governor is beginning those steps in terms of developing a state strategy or a plan, looking at our strengths, looking at our weaknesses, looking at those areas that we are no longer competitive in terms of other states but, men and women of the 113th, we have a responsibility as well — that when we identify those areas, be it taxes, workers' compensation, that when we identify those factors that make us non-competitive with the other states, our responsibility is to change those factors that, again, make us competitive.

The Chair recognizes

Representative from Bangor, Representative Diamond.
Representative DIAMOND: Mr. Speaker, Men and Women of the House: I was a little surprised that my friend in the other corner got up on this issue today. Obviously, every member of this body and the other body shares the concerns of the people affected by the Health-Tex situation and we hope, of course, that this thing can be resolved so that nobody is hurt and that all people are treated fairly.

I am a little concerned though about the

implication that the past legislature and the past administration might not have done enough in order to prevent such a situation and if I understood the gentleman correctly, that was indeed implied in his statement. I think that members who were here in the previous session understand full well that this legislature, through its Joint Select Committee on Economic Development, worked on addressing these issues in anticipation of a situation like this and in anticipation of the other problems that the state is facing.

The previous administration, I think, worked very diligently towards ensuring the security of Maine working people and I think the statistics, both unemployment and income statistics that were kicked

around in the last few years and developed over the last few years, demonstrate that they were successful in that approach. I think the concerns that have been expressed in the past few sessions by this legislature point to the real culprit in this and that being the policies in Washington that have had a negative effect on many Maine industries. of jobs in Maine have been affected by the unfair policies of the current administration in Washington and I think that this Resolution, while dealing with the problems directly involving Health-Tex and the parent company, I think that when members of this legislature examine the problems facing Maine workers, we have to look at the real culprit and that culprit lies about 2,000 miles south in Washington, D.C.

Thereupon, was adopted in concurrence.

At this point, a message came from the Senate, borne by $\underline{\text{Senator CLARK of Cumberland}}$ proposing a Convention of both branches of the Legislature to be held at 10:30 o'clock in the Hall of the House for the purpose of electing a State Auditor.
