Senator BALDACCI of Penobscot was unanimous consent to address the Senate on the Record. Senator BALDACCI: Thank you Mr. President and Members of the Senate. I was reading in this mornings newspaper, tucked away on the back pages, about Maine schools and the report that was published by the Secretary of Education, William Bennett. It talked about the recently past improvements, reforms. teachers certification and pay and how Maine had jumped from thirty-second to eleventh nationally in its high school graduation rate. Also, in how it improved in AST scores and SAT scores.

It was quite a good report card for the State of Maine. In noting in the Governor's address on his budget, and the lack of funds for education and the educational reforms that were passed, I hope the administration, as a matter of fact I would challenge the administration, to propose educational funding and reforms to maintain the momentum that we have gained in education. I am pretty proud of what we have been able to do in the last couple of years. I would hope that as a Member of the Legislature, I would welcome those reforms that were presented by the new Governor and any packages on education funding that would be proposed, because I think it is very important that we keep up the momentum that the State has already gained. By the report, I think that we can say that everybody has done a good job and we have to keep up the good work. Thank you Mr. President.
