The SPEAKER: The Chair recognizes the
Representative from Gray, Representative Carroll.

Representative GRAY: Mr. Speaker, Men and Women of the House: L.D. 84 is a Majority "Ought Not to Pass" Report. The Committee felt, in its wisdom, that to put in exceptions for a separate county into statute was an inappropriate way to deal with what we believe already could be done by department heads in that county so I would urge you to follow the majority and accept the "Ought Not to Pass" Report.

The SPEAKER: The Chair recognizes the Representative from Eastport, Representative Vose.

Representative VOSE: Mr. Speaker, Ladies and Gentlemen of the House: First, I would ask for a Division.

This is L.D. 84, a bill that I sponsored on behalf of the citizens of Washington County and I would like to explain some of the reasons behind this. On the same token, sometimes when a person puts in a bill for their county and their county alone, obviously, you don't want to interfere with the operations of other counties that are doing fairly well. Unfortunately, our county in 1985 and

1986, was subject to a real horror story as far as our commissioners were concerned.

We had one commissioner that socked the sheriff and was convicted on assault. Also, one of the things that the same commissioner was doing was harassing the Clerk and then, when it came time to bid on two cruisers that we put into a budget, the sheriff who had been doing this bidding and putting the bids out for specification for the last four years, (if not longer, that is the four years that he has been in) just simply did the normal thing and went out for bid but, in doing so, called me and I was chairman of the delegation at the time, to find out whether or not there was going to be sufficient money put into the budget that would buy these particular cruisers. I assured him that we had already voted on the two cruisers in the amount of \$22,000. He said, "Thanks, I will go out and see what I can do." He did, in fact, put the specifications out and it went out to bid, properly so, according to the Attorney General and District Attorney.

Then, when it came time to award the bid, which was around \$367 more than the \$22,000 allotted, the commissioners said, "No, you have done the wrong thing." That completely changed what they had been doing right in midstream and there was no question about it, it was a blatant attempt, in my personal opinion, to make the sheriff of our county, look like a donkey.

It ended up a little bit differently than that, however, because the gentleman that had already unsuccessfully bid low, was a gentleman by the name of Lenentine out of Calais, and he in turn, went to his lawyer and said he felt that he had had the low bid and should be awarded the bid, regardless of who did it.

The commissioners, on the other hand, took the other route and said, "No, we are going to re-bid" and they went out to re-bid and sure enough, here comes a lower bid than Lenentine's. Now we are faced with the possibility of buying four automobiles and a court case.

So, one of the things that we were asked as legislators during that time — can't we do something about the commissioners?

Just to give you an idea of what we had to contend with — at one of the meetings, the sheriff was arguing with the head honcho, the commissioner, and he said, "You are entering into a contract with juvenile delinquency." He said, "You should have notified me because that is within my territory and I should be handling that." Well, the commissioner said, "You are out of order. We did tell you that." He said, "No, you didn't tell me that." Well, yes he did and the commissioner started to bang him down and during the time he banged him down saying, "You are out of order, we will take a five minute recess." He proceeded to turn around, while I was present at the meeting, and look through his briefcase and whistle, "Zipperty Doo-dah" while the other commissioner leaped off the chair he was sitting on and took a chair and did a little dance around the sheriff, singing while the sheriff was trying to talk. That is what we had to contend with and that is why I am saying that this bill is a step in the right direction.

What this bill actually does is, after the sheriff or anyone else in the departments, go through the gauntlet and that the gauntlet you are all used to as far as the budgetary figure is concerned — once that is approved, then there is no reason why that particular department head can't go out to bid on his own and provided that that bid does not exceed

5 percent of the budgetary amount, he then can enter into a contract and buy that particular piece of equipment, whether it be a car, computer or whatever it is. Obviously, then the commissioners would have to sign the warrant, I am not taking that away from them.

It might be said sometime that that might open up a bucket of worms — maybe it opens up a way that there can be some hanky-panky going on but we do have a law on the books that tells you how to bid. The law says that it must be opened in public and if any of the department heads felt at ease or not at ease with this particular way of bidding, there is nothing to stop them from letting the commissioner buy it either.

Yes, this is a Washington County bill and it is a step in the right direction and what we are trying to do is trying to tell our constituents that we, as legislators, are on top of this thing and we want to do what we can to straighten the situation out.

Someone might say, now we have good commissioners and quite honestly, we do. We have two in particular and that is fine. I don't think anything is going to happen. To the contrary, this year, I think we have leveled off but who is to say what will happen the year after and the year after that. That is why this bill is here and there probably will be some more.

Ordinarily, I don't debate a 10 to 3 bill out of committee but I feel that if we, in Washington County, want to help our constituents in whatever way we can, I like to hope that you people will go along with it and defeat the motion to accept the Majority "Ought Not to Pass" Report.

The SPEAKER: The Chair recognizes the Representative from Jonesboro, Representative Look.

Representative LOOK: Mr. Speaker, Ladies and Gentlemen of the House: The issue before you strictly concerns Washington County. I appeal to you in recognizing that, if such legislation is passed, it may be conveyed in sessions henceforth, possibly to your county. I certainly hope you do not have to experience the trials and errors of Washington County.

I address the bill as it is written. It clearly excepts Washington County from being liable or operating within the preview of this particular section. The wording as written also eliminates the necessity for those who will be in the authority to purchase equipment from going to the competitive bidding process. I noted this last weekend and I called the legal research office, the legal analysis, and my concern was confirmed by them. Therefore, as this is written, it does take the necessity for those persons to abide by the competitive bidding process. I feel that this is not what we need in handling public funds.

In Washington County, prior to the experiences that Representative Vose has referred to, this has not been an issue. The department heads would make known to the commissioners their interests in acquiring equipment, they would be advised to seek out what they thought they would need, bring us in a ballpark figure on the price and then the commissioners put this to bid. The bids were received, opened in public forum, and decided on with the consultation of the department head.

I have conferred with, not only the county commissioners, but the present department heads and have found that the majority of those do not feel that this legislation is necessary nor do they want it. They feel it is not within the best interests of handling public funds for Washington County.

I have served as a county commissioner, as many of you know, and I speak from the angle as a

commissioner as well as a legislator, representing ten towns within that county.

The SPEAKER: The Chair recognizes the Representative from Madawaska, Representative McHenry. Representative MCHENRY: Mr. Speaker and Members of the House: I am from Aroostook County and whenever we deal with other counties I have, in the past, always gone along with the majority of the delegation. If somebody in Washington County tells me that the majority of the delegation is against the bill, I will vote that way; if they tell me they are for the bill, I will vote that way. Whatever the wish of the delegation is, I will vote that way.

I feel very uncomfortable voting on a county procedure for anything, very uncomfortable, because I am not involved in that county. I would like to have anybody from Washington County tell me what the stand of the delegation is.

The SPEÄKER: Representative McHenry of Madawaska has posed a question through the Chair to any member who may respond if they so desire.

The Chair recognizes the Representative from Eastport. Representative Vose.

Representative VOSE: Mr. Speaker, Ladies and Gentlemen of the House: I am the sponsor of the bill and it is cosponsored by Representative Moholland of Princeton and Senator Randall of Washington. I cannot speak for the rest of the delegation because I didn't poll them. The time that this bill was talked about was in 1986 — those of us that were on the delegation at that time, and at that time, we were pretty much in favor of snapping them just a little

bit in certain ways.

I would like to take exception of the statement that was made that you don't go through the bid process. I think if you read Section 304A, which is the change in Washington County, you will find that the purchasing of any vehicles or anything of that nature has to be done under Section 304, which says, "that all provisions of Title IV shall govern the purchase as far as applicable and the purchase through the state shall be governed by Title IV, Section 1816." Here it says—let me read this: "Except in the case a purchase through the state the county commissioners, except those in Washington County, shall make all purchases over \$1,000 of services, supplies, materials and equipment needed by the county, or any department or agency thereof, by competitive bidding," which is precisely what is referred to in 304A—it refers back to 304, which

says it has to be done by competitive bidding.

The SPEAKER: The Chair recognizes the
Representative from Madawaska, Representative McHenry.
Representative MCHENRY: Mr. Speaker, Members of

the House: I would like to have an answer to the question — does the majority of the delegation in Washington want to kill the hill or not?

Washington want to kill the bill or not?

The SPEAKER: Representative McHenry of Madawaska has posed a question through the Chair to any member who may respond if they so desire.

The Chair recognizes the Representative from Princeton, Representative Moholland.

Representative MOHOLLAND: Mr. Speaker, Ladies and Gentlemen of the House: I would like to invite some of you fine legislators down to Washington County some night when we have a meeting down there. They do everything but kill one another.

I don't think this is a 100 percent good bill but I think the bill will kind of straighten out the commissioners and the sheriff and some of the other people in the county. I have been over there to two or three meetings. I have been called everything but a man. The clerk has been called everything but a lady and there has been chair bouncing and yodeling

and singing and I think we have got to do something in Washington County.

I hope you will go along with Representative Vose

on this bill.

The Chair The SPEAKER: the recognizes Representative from Wells, Representative Wentworth.

Representative WENTWORTH: Mr. Speaker, Men and Women of the House: I would agree with my coworker here that it has been a policy to go along with the budget committee's recommendation. I have been a member of the Local and County Government Committee for nine years and it has always been our policy to accept the vote of the delegation in regard to the budget because it is their money and their county.
But in this case, it could affect any county in the state and I think it is actually a change in government up in that county and I do not think we should agree with it.
