SPEAKER: The The Chair recognizes the Representative from St. George, Representative

Representative SCARPINO: Mr. Speaker, Men and Women of the House: I have no illusions about what is going to happen to this bill. However, I would like to take this opportunity, perhaps, to present some information that I think this legislature, as a whole, should become aware of. Quite simply, over the past couple of years, there has been some major changes in the fishing industry and we are starting

to see the results of that now in gear conflicts and problems and concerns within all parts of the industry being able to operate in a compatible manner. That basically was the reason for this bill.

During the past five years, we have seen the Georges Bank decision, where we lost a great deal of traditional fishing ground. We have seen where an increase in the economic value of marine products and the increase in economic values led to an increasing intensity of the fishing of the inshore areas. The Georges Bank decision has taken marine operators, primarily dragmen, who normally used to be offshore operators and forced them into the inshore waters in order to maintain a livelihood, to keep their businesses operating.

This bill is one of probably many that we will be facing in the future because of the increased intensity in the fisheries and restricted areas that we have. It is an issue that this legislature is going to have to look at and deal with in order to ensure the long-term viability of the industry and the allowance of all aspects of the industry to operate in a complimentary rather than adversarial

manner.

House Amendment "C" (H-29) was read by the Clerk. The Chair SPEAKER: recognizes

Representative from Orrington, Representative Tupper. Representative TUPPER: Mr. Speaker, Ladies and Gentlemen of the House: As it was the pleasure of the House to make known the selling price of property to the public, I would like to offer this amendment for your consideration and that is having the disclosure of the Declaration of Value back at the Registry of Deeds as it always was before 1975.

I would hope that you would accept this amendment today, which, for many of us, who voted against L.D. 740 on behalf of our small municipalities, is more acceptable.

Mr. Speaker, I would request a roll call vote.

SPEAKER: The Chair recognizes Representative from Old Town, Representative Cashman. Representative CASHMAN: Mr. Speaker, Ladies and

Gentlemen of the House: I would move indefinite postponement of House Amendment "C."

The effect of this amendment is to put the bill back into the original form that it was when first referred to the Committee on Taxation.

The bill orginally sponsored would have required that this information be provided at the Registry of Deeds Office. The reason that the Taxation Committee chose to change that was, as we discussed the other day, that the primary purpose of this whole bill is to make this information available to appraisers and to do it in a manner that is cost effective for the

consumer, who is paying for the appraisal. I used the example the other day of a person ${\sf I}$ buying a house in Lincoln and their appraiser having to drive to Bangor to get this information and the

person paying for the appraisal paying for the cost of that trip, both in time and expense.

You can carry that into Millinocket, Medway or any of the other towns that are far removed from Bangor and, if this amendment were to pass, it would not address that problem where the consumer is paying the bill for that trip.

There is no requirement in the bill assessors offices in small towns be opened any more than they already are. There is no requirement in the bill that assessors in small towns make themselves any more available to appraisers or members of the public than they already do. I think that the argument that this will cost money in the

smaller towns doesn't really hold water.

Lastly, I guess, you all received a letter from a group of assessors saying they opposed this and I think you all received a letter on March 16th from the city of Bangor assessor written on his stationary that states that, unfortunately, there is a small group of assessors who oppose allowing public access to information upon which the assessor bases the assessment of property. Most professional assessors believe, however, that they have nothing to fear from public access of all the information they use to value property.

There is an old joke that says, "If you laid all the economists end to end, they wouldn't reach a conclusion" and perhaps that applies here. But I don't think that all assessors are against this bill and I think this letter indicates that.

I urge the House to join with me and indefinitely postpone this amendment and support the unanimous committee report.

The SPEAKER: The Chair recognizes Representative from Harrison, Representative Jackson.

Representative JACKSON: Mr. Speaker, Ladies and Gentlemen of the House: I, too, rise this morning to oppose the amendment that has been presented.

I would like to take Representative Cashmans' argument one step further. He spoke of the costs that are associated with ascertaining this information or obtaining it. I would like to bring to point one other case that could be argued. At the local level with your municipal assessors, when the Declaration of Value form is filled out and submitted to the local assessor, the computations, the figures, everything, is supplied at that time. If it were to go back to the county as the original bill stated and as this amendment attempts to do, then you would have the additional costs, the additional burden, of having those stamps or that figure placed on the deed at the county level. I think to keep in tune with the process, and I think the committee came up with a good and valid idea to keep it at the local level, I certainly hope that the members of this body today would reaffirm that decision and vote to defeat this amendment and put this bill in its proper place.

SPEAKER: The Chair recognizes Representative from Lisbon, Representative Jalbert.

Representative JALBERT: Mr. Speaker, Ladies and Gentlemen of the House: This bill has a lot of merit. Last year I spoke against it and I feel there is still a lot of work to be done. The idea of making this information available has a lot of merit.

I have been in contact with the Registry of Deeds and there is a problem that has arisen there because there is not a copy of the Declaration of Value kept at the Registry of Deeds. There are only two copies, they both go to the state assessor and the state assessor sends a copy to the municipalities. I would like to say again, I am not against the merits of this particular issue, but I contacted the assessor in Lisbon and a few other places and the problem is,

there should be some kind of a guideline set up. I know they have it within their power to do it, but there should be some kind of a guideline that the assessors can set when the information is to be made available.

One point that was brought up by the assessor is the fact that, since it is confidential, they must keep it forever — that part should be taken care of. I asked the assessors and they said, they usually use it for two years. I believe there should be some provision and, if possible, I would submit an amendment that there would be a provision that, after two years, this information could be disposed of by the local assessors. This kind of information after two years doesn't have much value anyway to anyone that is an appraiser.

At this time, I would like to bring out the fact that there is more work to be done on this bill before everyone will be satisfied.

The SPEAKER: The Chair recognizes Representative from Winthrop, Representative Norton.

Representative NORTON: Mr. Speaker, Ladies and Gentlemen of the House: I have had communications from four of the five towns that I represent urging me to vote against having further burdens placed upon them at the local level, which this bill would do. I feel that is valid. I would certainly go along with the amendment. I believe it belongs at the registry where most people have to visit anyway.

R epresentative STEVENS: Mr. Speaker, Men and Women of the House: I think it might be worthy to note that last year this bill was considered and Representative Cashman and Representative Jackson both voted that the Declaration of Value should be available at the Registry of Deeds, as Representative Tupper suggests. That was a unanimous committee report saying, the information should be available at the Registry of Deeds.

Representative MAYO: Mr. Speaker, Men and Women of the House: I find myself in a funny position this morning since I originally introduced this bill in the form that Representative Tupper wants to change it back to. Many people think that is a good idea.

We worked this bill in committee and the committee considered all the angles. I think we

spent a lot of time discussing what form this bill should take. The committee felt, and I agreed to go along with them, the best place for that information to be released would be at the local office.

I would like to point out to you and remind you that Maine is only one of two states in the country that does not allow this information, that if we pass the bill out as the committee recommended, we would be doing exactly what the state of Vermont does.

I think this bill is a good way to assist our home buyers in keeping their costs down and also in speeding up the closing on homes and that is why the

bill was introduced.

I would ask you to go along with the motion of the Representative from Old Town, Representative Cashman, that this amendment be indefinitely postponed.

The SPEAKER: The Chair recognizes the Rerpesentative from Lisbon, Representative Jalbert.

Representative JALBERT: Mr. Speaker, Ladies and Gentlemen of the House: I would like to pose a question through the Chair. Would there be any provision to instruct the Bureau of Taxation that, when they mail those Declarations of Value to the Registry of Deeds to be made out, that they will have an additional copy so that they can keep a copy in the Registry of Deeds? As it stands now, both copies that are made out are sent to the Bureau of Taxation and there is no way that the Registry of Deeds can have that information available.

The SPEAKER: Representative Jalbert of Lisbon has posed a question through the Chair to any member, who may respond if they so desire.

The Chair recognizes the Representative from

Biddeford, Representative Racine.

Representative RACINE: Mr. Speaker, Ladies and Gentlemen of the House: We seem to be forgetting one thing here this morning. It seems that everybody is talking about facilitating the appraisal process, that may be so — however, I feel that property owners that are having difficulty in getting answers on assessing practices have a right to know how assessors arrive at an evaluation. If I am going to have to go to the Registry of Deeds every time I have a discussion with my assessor, I don't think that is fair. People are forgetting that this information should be made available to everyone, not only assessors or people that are in the real estate business. I think that that information should be made available to everyone. If you put a restriction requiring us to go down to the Registry of Deeds every time there is a question on how property evaluations were arrived at, I think that you are defeating the purpose of the bill and it is one way to kill it.

I would urge you to go along with the motion that was made by Representative Cashman. I realize assessors are trying to protect their turf. They don't want to be questioned as to how they arrive at an evaluation and I think that is wrong. This is why assessors are opposed to this, those that are. They just don't want to divulge the information which we should have access to as property taxpayers.

The SPEAKER: The Chair recognizes the Representative from Orrington, Representative Tupper.

Representative TUPPER: Mr. Speaker, Ladies and Gentlemen of the House: I would just like to answer Representative Racine. Evaluation is not obtained at the Registry of Deeds, evaluation is obtained in the assessors office and all assessors are willing to share that evaluation. Selling price is what we are talking about here, not evaluation.

I also would like to have a roll call on Representative Cashman's motion.

This being an emergency measure, a two-thirds vote of all the members elected to the House being necessary, a total was taken. 108 voted in favor of the same and none against and accordingly the Bill was passed to be enacted, signed by the Speaker and sent to the Senate.
