Representative PARADIS: Mr. Speaker, Ladies and Gentlemen of the House: It is, with both pride and pleasure, that I arise this morning to call attention to a milestone event for one of the 13 towns in my district.

Eastbrook is situated in the eastern sector of Hancock County between Highway 9 and the Atlantic Ocean. It was settled by a group of hearty people following the Revolution and much of this settlement occurred in connection with the Massachusetts Bonus Land Grant Act.

These people took on a rugged and demanding assignment to earn the title to their land. Faced with the thin, rocky soil, these uncomplaining people developed a society which was a clear reflection of themselves and their character. They learned to cope with their surroundings and capitalized on the resources at hand. They produced a living, raised their families and passed on the rugged individualism.

After 10 generations, many are still there, having contributed to state and nation with their energy, their resolve and their resources. In time of need, they have given willingly and generously of

their manpower.

I would ask you to pause with me today as we recognize their accomplishments under the provisions of the Charter, which was granted to them by the 17th Legislature, 150 years ago this Spring. Truly, they have carried out the spirit and the intent visualized by that legislature — the town should be granted the freedom and the right to carry out their affairs and manage their business with the minimum of interference from far away governments located either in Augusta or in Washington.

It is, with this in mind, that we compliment the people of this town and we send this greeting in recognition for their accomplishments through the

JOINT RESOLUTION MEMORIALIZING THE CONGRESS OF THE UNITED STATES CONCERNING NUCLEAR EVACUATION ZONES

WE, your Memorialists, the Senate and House of Representatives of the State of Maine in the First Regular Session of the One Hundred and Thirteenth Legislative Session, now assembled, most respectfully present and petition the Congress of the United States, as follows:

WHEREAS, the staff members of the Nuclear Regulatory Commission have proposed removing state and local powers in regard to nuclear plant emergency

planning; and

WHEREAS, this same commission staff in Washington, D. C. has proposed that emergency evacuation zones be reduced from 10 miles to one

WHEREAS, the absurdity of this proposal is borne out by the fact that in the case of the Seabrook nuclear plant, the proposed evacuation zone would not

even reach to the plant gate; and

WHEREAS, Maine public officials, including Governor John R. McKernan and Congressman Joseph E. Brennan and Maine Public Utilities Commissioner Peter Bradford, himself a former member of the NRC, have spoken out against this usurpation of states' rights; and

WHEREAS, Legislators from the 3 states affected by Seabrook have called for an independent investigation of the construction work at Seabrook;

WHEREAS, Maine residents in communities closer to Seabrook than the 18 mile evacuation zone that was put into effect after Chernobyl have indicated they wish to see the evacuation zone extended, not

reduced; now, therefore, be it RESOLVED: That we, your Memorialists, do hereby respectfully urge the Members of the Congress of the United States to oppose in every manner possible the ill-considered staff recommendations of the Nuclear Regulatory Commission that emergency evacuation zones be reduced from 10 miles to one mile; further that the Congress is urged to investigate whether or not the Nuclear Regulatory Commission is exceeding its mandate to assure the American public of the safety of nuclear plants and instead is promoting the use of nuclear power at any cost, including the trampling on the rights of the states; and further that the commission act to insure that citizens of Maine will have an objective evaluation of the safety of the Seabrook nuclear power plant which, although located in a neighboring state, will have a devastating effect on the lives and property of Maine citizens and the economy of Maine should a nuclear accident take place; and be it further

RESOLVED: That suitable copies of this Memorial, duly authenticated by the Secretary of State, be transmitted to the President of the Senate and the Speaker of the House of Representatives in the Congress of the United States and to each Member of

the Maine Congressional Delegation.

Representative ROLDE: Mr. Speaker, Ladies and Gentlemen of the House: I won't belabor the Resolution — it speaks for itself. It, basically, deals with the issue of the evacuations zone around the Seabrook plant and the proposal of the Nuclear

Regulatory Commission to change that from 10 miles to mile which, in effect, has a very strong effect on states' right in these matters. I would point out, as the Resolution does, that Governor McKernan has spoken out against this, as other Maine officials have. I hope you will go along with this Resolution. Subsequently, was adopted and sent up for
