unfinished business:

Bill "An Act Relating to Absentee Balloting by Residents of Nursing Homes, Boarding Homes and Congregate Housing Units" (H.P. 705) (L.D. 947) TABLED - March 27, 1987 by Representative HANDY of Lewiston.

PENDING - Passage to be Engrossed.

Representative Handy of Lewiston offered House Amendment "B" (H-45) and moved its adoption.

House Amendment "B" (H-45) was read by the Clerk. The SPEAKER: The Chair recognizes Representative from Brunswick, Representative Priest. Representative PRIEST: Mr. Speaker, I move that

House Amendment "B" be indefinitely postponed.

Men and Women of the House: This amendment essentially would remove from the bill the provision which prohibits candidates from taking absentee ballots to nursing homes, boarding homes and congregate housing units, if their names appear on the ballot. If you recall, this bill was thoroughly debated the other day in this House and essentially the committee has proposed a balanced approach which says that the clerks will hold an absentee balloting procedure before Election Day in nursing homes, boarding homes and congregate housing units. In situations, candidates eliminated prohibited from witnessing ballots if, in fact, their names are on the ballots. If their names aren't on the ballots, obviously, they can witness ballots. The committee still allows full participation in campaigning by candidates. The committee still allows full public disclosure and allows candidates to be present when this takes place.

This amendment would, unfortunately, destroy the intent of the bill and, therefore, I would ask you to

support the indefinite postponement motion.
The SPEAKER: The Chair recogn recognizes

Representative from Bath, Representative Holt.
Representative HOLT: Mr. Speaker, Men and Women of the House: The motive behind this bill, as amended, is fine but I have reservations about it that I can't seem to overcome. Every notary knows the rules for absentee balloting. If anyone asks us as candidates, who are notaries, "Whom should I vote for? We all know the response has to be "well, I can't talk with you about that; if you are unsure, you may leave the items blank that you are unsure about. It does not spoil your ballot to leave spaces Also, when sealing is done by the voter, the candidate may not have seen the ballot before or after the person votes. The sealing is done in the presence but not in view of the notary, so the notary doesn't get to see how a person voted. In the case of a blind person or person who has bad arthritis of the hands, for example, who need help marking the ballot, a third person is called. The notary or candidate doesn't see how the person voted.

Now, if a candidate's very presence is improper influence, then a candidate should not be allowed at all in the nursing or boarding homes referred to in the bill.

Although some of us feel that this bill would protect candidates from the appearance and perhaps the temptations of wrongdoings, I am afraid that it can also be seen as demeaning to the intelligence and independent spirit of nursing home residents and others, as well as demeaning to the integrity of candidates for public service.

The SPEAKER: The Chair recognizes Representative from Rockland, Representative Melendy.

Representative MELENDY: Mr. Speaker, Men and Women of the House: I don't intend to debate this bill. It was well debated the other day. I merely ask the members of this House to please stick with your vote that we took last week.

The bill was watered down quite a bit in committee and let's keep what we have left.

The SPEAKER: The Chair recognizes Representative from Sanford, Representative Hale.

Representative HALE: Mr. Speaker, Men and Women the House: I rise today to ask you not to cast your vote as you did last week. I would use example that I ran into. It was the only absentee ballot that I took when I was a candidate on the

A very close and dear friend of the family had called and asked me to bring a ballot. First of all, I had to bring the authorization for an absentee ballot, go back to the town hall, go back to her congregate housing unit -- this very good friend was fighting cancer, she would not allow any other person to bring this to her. She wanted just me because she This does not mean that she wanted to vote knew me. for me, although naturally I am assuming she did want to vote me, as a very good friend of the family, but she would not have cast a vote if I had not taken it.

I have taken three in my tenure as a notary public. Two have not been in my district but they have always been at the request and I feel that if we do not allow people to call us to go and fill out a ballot, they will not cast a vote. This is depriving them of their right to vote as a citizen in the state of Maine and the United States.

The SPEAKER: The Chair recognizes Representative from Lewiston, Representative Handy.

Representative HANDY: Mr. Speaker, Men and Women of the House: I offered this amendment today as "the balanced approach" to this report from committee. I have to disagree with my good friend, Representative Priest, that the report out of committee was the balanced approach. In fact, that is not the balanced approach, that removes candidates exclusively from the process.

The approach that I suggest in this amendment would retain the provision in the committee's report, which would require clerks to go to boarding homes, nursing homes and congregate housing facilities to present their voting day for the residents of those facilities.

This amendment diverts only in that it removes from candidates from prohibition

participants in the absentee balloting process.

Let me refresh for you what we did last year with respect to absentee balloting -- we instituted absentee balloting by mail process that does not involve any other individuals except the clerk and the voter in that, a voter may, by phone or written request, contact their clerk, request an absentee ballot and the clerk would mail it to that individual. That individual would then complete the ballot, seal the envelope, put it in the mail to go to the clerk. That fairly removes the candidate from the process because it is a choice that the voter consciously makes by keeping the provision where clerks are required to go and have a voting day at the facility, that too, provides the residents of those three facilities, the opportunity to make a conscious choice, once again, to not have a candidate involved in the process.

If a voter chooses to have a candidate, who they trust or some other individual who may be on the ballot that they trust, bring them that ballot and see to it that their rights under the Constitution are carried through as they choose, then that is what this amendment would do. It would simply allow for them to make that choice.

I would ask you to oppose the motion before us today, which is to indefinitely postpone, so we may go on to accept House Amendment "B". Keeping in mind that candidates aren't any worse nor are they any better than any other individual who may be involved in the campaign. In fact, in some ways, I think people look at us to be held up to a higher standard, but by the same token, we should not be held to a lower standard simply because we put ourselves up for public scrutiny.

I would ask you today to oppose the motion of indefinite postponement so that we can accept House

Amendment "B".

The SPEAKER: The Chair Representative from Berwick, Representative Murphy.

Representative MURPHY: Mr. Speaker, Ladies and Gentlemen of the House: I urge you to support the motion to indefinitely postpone this amendment on this bill. This is a unanimous report out of committee, we gave it a lot of study and a lot of thought and we agreed, unanimously, that it was a good bill.

It does not stop the candidate from going in there and campaigning; they can be there at the time of voting, so I feel that it is not hurting any of us as candidates.

I ask for a roll call.

The SPEAKER: The Chair recognizes Representative from South Portland, Representative Anthony.

Representative ANTHONY: Mr. Speaker, Ladies and Gentlemen of the House: I believe it is incumbent upon us, particularly this year, in light of various allegations that have been made about one or more members of this House — to do everything we can to separate ourselves from the ballot collection process. We have an obligation to try and make it clear, not only that we will avoid all improprieties but to separate ourselves from all appearance or for impropriety. It seems to me that the potential original bill, as presented, does that and should be supported for that reason.

I would urge support for the motion

indefinitely postpone this amendment.

The SPEAKER: A roll call has been requested. For the Chair to order a roll call, it must have the expressed desire of more than one-fifth of the members present and voting. Those in favor will vote yes; those opposed will vote no.

A vote of the House was taken and more than one-fifth of the members present and voting having expressed a desire for a roll call, a roll call was ordered.

The SPEAKER: The pending question before the House is the motion of Representative Priest of Brunswick that House Amendment "B" be indefinitely Those in favor will vote yes; those postponed. opposed will vote no.

into congregate housing.

Those people in the congregate housing are not seriously ill or senile. They like to vote and they want to vote with the person that they request. would hope that you would honor that.

The SPEAKER: The Chair recognizes

Representative from Brunswick, Representative Priest. Representative PRIEST: Mr. Speaker, Men and Women of the House: I move that this amendment be indefinitely postponed.
