### (Off Record Remarks)

Representative Jacques of Waterville was granted unanimous consent to address the House:

Representative JACQUES: Mr. Speaker, Men and Women of the House: I think it would be proper today to make some comment on the quality and the caliber of people that have chosen to make the State of Maine their home. The last two nights I have spent most of my time in water up to my arm pits and I must say that I was extremely impressed with the kind of help that was going on, at least in the the greater Waterville-Winslow area and across the state.

I saw homes which were literally being washed down the river and some people chose to disregard their concerns in order to help their next door neighbor get his children and his pets out of their home before that home was washed away into the river.

Last night we had a local businessman in the town of Winslow come in to the Waterville Elks Lodge where they were having a cribbage tournament and expressed some concerns that the water was supposed to come up another seven or eight feet. He has a huge furniture store there and he asked for volunteers. Literally, every member that was there for the tournament said, "Let's cancel the cribbage tournament." They had 25 to 30 people in that furniture store and, in less than two hours, they had completely cleared the bottom floor of furniture, over 60 livingroom sets, I don't know how many bed room sets, washers and dryers and brought them up to the second floor. I know at least one gentleman that slept a little easier last A lot of these people were complete strangers that he didn't even know; yet, they were willing to take their time to help him out.

It is very easy to be happy-go-lucky and strong and proud when things are going good but it is when the tough times come along that really separate the kind of people that are your neighbors and separate what really makes people in the State of Maine the

people they are.

I think the last couple of days have shown that and I think we would be remiss if we didn't at least mention that and recognize these people for what they have done. It has only been through this neighborly help that everybody has been able to come through this major catastrophy in this state without a loss of life. I commend the citizens of this state for doing that. Thank you.

The following Joint Resolution: (S.P. 369) JOINT RESOLUTION MEMORIALIZING THE MEMBERS OF THE UNITED STATES SENATE TO VOTE TO OVERRIDE THE

PRESIDENT OF THE UNITED STATES' VETO OF THE FEDERAL HIGHWAY LEGISLATION

WE, your Memorialists, the Senate and House of Representatives of the State of Maine in the First Regular Session of the One Hundred and Thirteenth Legislative Session, now assembled, most respectfully present and petition the members of the United States Senate, as follows:

WHÉREAS. President Reagan \$88,000,000,000 federal highway bill passed by the United States Congress which would have provided the State of Maine with badly needed funds; and

WHEREAS, of the \$60,000,000 earmarked for Maine, \$25,000,000 has already been committed leaving a critical need for the remaining \$35,000,000 for 125 projects statewide which are threatened by the

President's action; and
WHEREAS, the \$35,000,000 generated for Maine
under this legislation must be received in time for Maine's short construction season, which work may not

be possible if delayed further; and

States WHEREAS. the United Representatives recognizing the plight of the states overrode in a bipartisan fashion, the veto by a vote of 350 to 73 and now the matter is up for final vote in the Senate; and

WHEREAS, yesterday, April 1st, the State of Maine was hit by record-breaking flood waters causing the Governor to call the State of Maine a disaster area that decommissioned numerous roads and bridges causing millions of dollars in damages; therefore, be it

RESOLVED: That We your Memorialists, do hereby respectfully urge the Senate of the United States Congress to vote to override President Reagan's veto of the Federal Highway bill so that this State can recover its roads and highways from its worst flood disaster of the century and to permit the start of the state highway construction program as planned which is otherwise in serious jeopardy; and be it further

RESOLVED: That suitable copies of this Memorial, duly authenticated by the Secretary of State, be transmitted to the President of Senate in the transmitted to the President of Senate Congress of the United States and to each Member of the Maine Congressional Delegation.
