The SPEAKER PRO TEM: The Chair recognizes the Representative from Yarmouth, Representative Foss.
Representative FOSS: Mr. Speaker, Ladies and

Gentlemen of the House: I hesitate to rise and speak today against a unanimous compromise bill out of the Judiciary Committee. However, I cannot, in good conscience, vote in favor of this measure to allow first cousins to marry if they receive genetic counseling. The ban on marriage between first cousins was passed only two years ago based on the unanimous recommendation of the Legal Affairs Committee. Testimony given at that time indicated that only 5 states allow this type of marriage. My recent research has found that 30 states have, in fact, civil sanctions against first cousins marrying, and 8 of those states even impose criminal sanctions. Based on the potential for genetic problems arising from a marriage of blood relatives, I cannot vote for L.D. 1348. To me, it is a giant step backward.

I request a roll call.

The SPEAKER PRO TEM: The Chair recognizes the

Representative from Augusta, Representative Paradis.
Representative PARADIS: Mr. Speaker, Ladies and Gentlemen of the House: The Representative is correct in saying this is a Unanimous Committee Report. The Judiciary Committee met in work session three times, three lengthy times, on this bill in order to craft a compromise that would not violate the spirit of the past legislature which voted to (without debate in this body) has the marriage of (without debate in this body) ban the marriage of first cousins. In the history of the entire state, up until 2 years ago, first cousins were allowed to marry. We heard testimony at the public hearing that there were very few problems with first cousins marrying and that a blanket disapproval, a law which would outlaw all marriages, was harsh and cruel on particular cases where there would be no problems. In the history of the state, we have always permitted individuals to marry. The state would, in fact, say yes, you can marry, we will not get involved in your marriage contract -- that you ought to be free to make that commitment to a man or woman based on your

I think for the State of Maine to say now, after 180 years of state history, no, we will never allow any two individuals who happen to be first cousins, whether they be twenty years old or fifty years old, to marry is harsh and cruel.

We were presented with testimony by a couple who lived in the district of the sponsor and cosponsor of the measure, who were beyond childbearing age and wanted to marry. I see no problem with that particular case. My church has always allowed the marriage of first cousins, marriage of the first degree to occur, providing that the bishop of the church granted his consent. In other words, it would not be an automatic marriage.

We put in the bill that those couples who do seek marry would have to be counseled to see if there would be any problems in that marriage and in the

offspring of any potential marriage.

A person testified at the hearing that there were no more reasons for genetic disability in first cousins marrying, who had no problems in their lineage, than there would be in a marriage of non-relatives that had problems. In other words, if I wanted to marry someone and I had, for example, Downs Syndrome in my family, or any other genetic based disease, my offspring, regardless of whom I marry, would have a potential to have that. It wouldn't matter if it was a first cousin or not, a second cousin would have the potential for that to a lesser degree, a third cousin would have the potential for that to a lesser degree and so on. I think you understand, fellow colleagues, what I am saying.

To make a blanket disapproval, without knowing the particulars and without allowing exemptions to this, is harsh and cruel. If people want to marry, and they are aware of the potential conflicts and problems that might arise, genetics being one of them, and they are appraised of that by professionals, then I think, in my judgment, and in the judgment of the committee, it is best to allow those people to make that informed consent on their own and not to disallow by fiat of the legislature, all those types of marriages.

I would ask you to vote for enactment of this measure, it in not a partisan measure, it is not cast in partisan terms, it is a bill that affects only a few individuals. There aren't going to be 3,000

marriages of first cousins in the first year of this bill. You may see two or three, that's how much impact that it has. To say no to those two or three, I do not have it in my heart to say that, and I cannot, in the deepest search of my own conscience, say that it would be wrong. I would ask you to enact this measure.

Representative FOSS: Mr. Speaker, Men and Women of the House: I just want to remind you that the action before you today is not to impose the ban, this very body did that two years ago based, again, on the unanimous recommendation of the Legal Affairs Committee. In my opinion, the Judiciary Committee acknowledged the potential problem by requiring genetic counseling.

The SPEAKER PRO TEM: The Chair recognizes the Representative from Berwick, Representative Murphy.

Representative MURPHY: Mr. Speaker, Ladies and Gentlemen of the House: In the 112th Legislature, the Legal Affairs Committee had this bill brought before us and it was brought before us because of some problems. We gave it a lot of study and we spent hours on it. We had a genetic specialist come in, who started from the top and brought us right down through of the dangers of first cousins marrying. I don't think any of us, when the bill first came in, thought there was much of a problem, but we were certainly convinced that it was not a good practice and that it could create some problems. I guess I believe that if we passed a law that saved one child from being born with a handicap, that it was worth it. That is one reason why I voted to ban first cousins from marrying.

The SPEAKER PRO TEM: The Chair recognizes the

Representative from Augusta, Representative Paradis.
Representative PARADIS: Mr. Speaker, Men and Women of the House: I said, a few minutes ago, in answer to comments that were made previously that the ban which the Legal Affairs Committee voted out two years ago, and which this legislature adopted, prohibited all first cousin marriages. I stated this afternoon that, if a marriage of two persons fifty, sixty, or seventy years old who were first cousins wanted to take place, I would ask you, in your own mind, would there be potential offspring to that marriage? I think the chances are very, very slim. Why should that marriage be prohibited? The ban that now exists is state law and prohibits all. This bill, as carefully as it is worded, hopes to permit those people to make that decision in light of counseling and looking into their own particular situation. We allow exemptions to many, many things in the law. We have books that are this thick to allow certain exemptions. To pass a blanket rule, I think, is wrong. That is why the sponsors came to us in this Legislature. We are not bound by the actions of any previous Legislature to say that we are going to correct an unfortunate happening. The spirit is still there in the law, but in every particular circumstance, I think that law went far beyond what even the geneticists were asking the legislature to do.

The SPEAKER PRO TEM: The Chair recognizes the Representative from Orono, Representative BÖTT.

Representative BOTT: Mr. Speaker, Men and Women the House: I wish to pose a question through the

I would like to ask the Chairman of the Judiciary Committee or a member of that committee if this bill only affects first cousins that are beyond childbearing years?

The SPEAKER PRO TEM: The Representative from Orono, Representative Bott, has posed a question through the Chair to anyone who may respond if they

so desire.

The SPEAKER PRO TEM: The Chair recognizes the Representative from Augusta, Representative Paradis. Representative PARADIS: Mr. Speaker, Men and

Women of the House: In answer to the Representative from Orono, this bill is carefully worded. We do not want to fall into the same pitfall that was created two years ago by the previous legislature. It deals with all first cousins and asks them all to go to genetic counseling and they make an individual determination. We believe the people of this state are intelligent enough and informed enough to make their own decisions. They need not be told by the legislature that we in this body have more knowledge than the people out there.

The SPEAKER PRO TEM: The Chair recognizes the

Representative from Presque Isle, Representative

MacBride.

Representative MACBRIDE: Mr. Speaker, Men and Women of the House: The Judiciary Committee had a choice. We could recommend letting people live together without the benefit of marriage, we could recommend letting first cousins marry and be sterilized, we could recommend not letting first cousins marry, which again, would recommend living together, or we could recommend the procedure that you have in the bill today. That is to require people to have genetic counseling. The committee decided that that was the fairest and the best route to take.

The SPEAKER PRO TEM: The Chair recognizes the Representative from Orono, Representative Bott.

Representative BOTT: Mr. Speaker, Men and Women of the House: I guess that if the answer to my question had been yes, that this only affected people that were beyond childbearing years, then I would support this; however, it doesn't. It really is going to circumvent the unanimous bipartisan committee stand that we took on Legal Affairs last session. We felt that this was a very significant problem in terms of potential birth defects, in terms of the unintended consequences that could result with the marriage of first cousins. I strongly urge you to vote against this bill.

The SPEAKER PRO TEM: The Chair resentative from Frenchville, The Chair recognizes the Representative Representative Paradis.

Representative PARADIS: Mr. Speaker, Men and Women of the House: This arrived on my doorstep and I ran with it because my husband and I have been through the "genetic counseling" and counseling sounds like such a safe procedure in a sense. But it is extensive -- it's blood tests, we hired a genealogist. I mean there was nothing that was not looked into. If I thought for one moment there was a chance that a child could ever evolve from anything we would do here that would not be 100 percent, $\check{\mathbf{I}}$ certainly would not be standing here. What does happen though is that they can get right down to the wire. I did my homework on this. I went all over the place. The head of the Eastern Maine Genetic Clinic thought it was a ridiculous bill. If we would

be consistent with worrying about birth defects, we would be eliminating a lot more dangerous categories of people that are getting married now. I don't hear anybody bringing forth new laws to impede some of these people that are at high risks and having children. I can reassure you that I have done my Nobody will survive this procedure if homework. there is any possibility of ever producing anything but a healthy child. There are cases in point that are sterile. There is no way they will have children.

The SPEAKER PRO TEM: The Chair recognizes the Representative from Bath, Representative Holt.

Representative HOLT: Mr. Speaker, Men and Women of the House: I just have a couple of quick things to say on this issue. I didn't expect that there would be any debate on it. In New England, many of us are related, especially families who didn't migrate out west. My husband's hobby is genealogy. My husband and I are related as cousins about twenty time over, but that happens a lot in New England. More important than that, I think you should remember but perhaps you don't know, that the United States Nuclear Regulatory Commission, before it went fullscale with nuclear powered generation of electricity, stated that it allowed a 10 percent increase in the genetic mutation rate. That is on record.

The SPEAKER PRO TEM: The Chair recognizes the Representative from York, Representative Rolde.

Representative ROLDE: Mr. Speaker, Men and Women
