It is our understanding that this change came about when sometime prior to this session we formed the Economic Development Committee and gave that Joint Standing Committee jurisdiction over FAME and the Maine State Housing Authority -- those confirmations now go to State and Local Government. We don't hear those bills before that committee anymore — they go to Economic Development Committee; hence, the change in confirmation procedures.
