In Senate Chamber Saturday July 6, 1991

Senator MCCORMICK: Thank you Mr. President. Ladies and Gentlemen of the Senate. I just wanted to say that I voted for this Budget compromise with some misgivings. My misgivings were triggered when I picked up this mornings paper and read that our Governor had said that he was not confident at all that a compromise will materialize. I certainly hope that after all the blood, and sweat, and toil, and tears of all of us in getting this compromise, that everybody is going to put their all into making this work. I was called by a constituent, a state employee this morning, who has so much mistrust in the Governor that she's worried that this is just a ploy to keep state employees from getting unemployment next week, and worried that they'll be put back to work for three days and then the Budget compromise will fall through, and that they will be a long way away from a check yet again. I certainly hope that every member of this Body and on the second floor will try their best to make this happen, because we do not want to be back here on Wednesday. Thank you.
