Senator ESTES: Thank you Mr. President, Ladies and Gentlemen of the Senate. I rise this afternoon to urge you to vote yes to overturn the tying recommendation for Mr. Philip Dionne of Brunswick for the State Board of Education. I would like to give you what I think are some important reasons for your consideration of a yes vote. I have to say that this nomination has generated the most intense response of any that I have been involved in my five and a half years as the Chair of the Education Committee. Not only telephone calls but a great deal of mail, both pro and con, but I found that there was a much more extensive support for Mr. Dionne's nomination, and I think for some good reasons. The nomination has, undoubtly, been clouded by the local construction issue revolving around the site of the new Brunswick High School and I think that it was unfortunate that

July One of the things that I think is important that you realize is that unlike the Board of Trustees of the University of Maine system or the Board of Trustees of the Technoial College System, the State

it also clouded the confirmation hearing back in late

Board of Education functions considerably different. I have for years, with a number of colleagues in this Chamber, attempted to strengthen and enhance the position and role of education with not much The Board of Education is a lay board that is broadly representative of the public of the State of Maine and broadly representative of the regions of the State. Normal term of appointment is five years and in this particular nomination, Mr. Dionne would be replacing Michael Aube who resigned recently after he was confirmed as the Commissioner of Economic and Community Development. If Mr. Dionne is confirmed today he will not be serving a full term but will only serve out the remainder of Mr. Aube's term until December 1994, which is just a little over two years.

The Board is also defined as being an autonomous body which has primary responsibility for formulating policy by which the Commissioner of Education shall administer certain regulatory tasks, advising the Commissioner and Adminstration of all the mandated responsibilities of that position and enforcing regulatory requirements to School Administrative Units. Thats it. Simple. One of the things that particularly impressed me about Mr. Dionne is his long term of public service, both at the local level and at the State level, and his involvement with vocational education at the national level. I think his particular knowledgeable background in the field of vocational education and his very strong demonstrated advocacy for voctional educational students are two very important assets to bring to the Board. Those assets will be much needed with the departure of Mr. Aube who was the vocational advocate and conscience on the State Board. I urge you to vote yes on this nomination. Thank you.
