Senator KANY: Thank you Mr. President. and Gentlemen of the Senate. It just seemed appropriate to recognize some of the many contributions of our Senate Majority Leader, Nancy Clark, who served the Maine Senate and the Maine House with grace for many years. Speaking about being brief, Mr. President, I've noticed that in the last several years our Senate Majority Leader has even learned to be brief, so it's really too bad that once she's accomplished that she will not be here next term. She has many accomplishments and has made many contributions for a number of years, especially in the House. She chaired the Legislature's Business Legislation Committee, where she provided leadership as a consumer advocate in the complex areas of banking and insurance, and consumer credit. She sponsored the Manufactured Housing Act, the Used Car Information Law, prior approval of hospital rates and Maine's consumer credit code. At the same time she understood and appreciated the needs of the business community and made certain its views were listened to carefully and considered in the development of public policy. Senator Clark has served as an eloquent spokesperson on behalf of the handicapped, the spokesperson on benalf of the nandicapped, the elderly and the abused. Among the laws she sponsored were the elderly low-cost drug program, funds for emergency shelters and services for victims of domestic violence, accessible polling places, and a long term care plan for the physically handicapped and elderly and minimum standards for Medicare supplement insurance policies. In the area of education she sponsored student educational loans, the Teacher of the Year Program, energy conservation improvements for the University of Maine and public schools and the establishment of the Women's Training and Employment Program. She sponsored our animal welfare law, and income tax check-off for non-game wildlife management and guidelines for genetic engineering experimentation. Senator Clark is an environmental leader in the state, sponsoring water quality laws, the Maine Clean Indoor Air Act and the produce labeling requirement for post-harvest treatments. Most recently she sponsored the Constitutional Amendment providing State funding for any mandates imposed on municipalities which was approved by Maine citizens at the ballot box on November 3.

So as one State Senator serving with Senator Clark, I have had the opportunity and privilege of witnessing first hand her ever present grace under fire and her statesperson approach to negotiating and problem solving and her deep caring for the people of her Senate district and all of Maine. Thank you.

Senator $\mbox{\bf DUTREMBLE}$ of York was granted unanimous consent to address the Senate on the Record.

Senator DUTREMBLE: Thank you Mr. President. Ladies and Gentlemen of the Senate. I also want to echo the remarks of the Senator from Kennebec, Senator Kany about my boss, Senator Clark. I've enjoyed working with her for the past six years. I guess there is no finer person that I have had the opportunity to work so closely with and I appreciate all she has done and all of her guidance and all of her advice. We will certainly miss her.

I also, before leaving want to say a few words about our President. I think it's really important before we leave, Charlie, that we all pay tribute to the work that you have done on behalf of this state.

You've been a fine President, a great President. You've been a good Senator, a great Senator. You've been an advisor to a lot of us, a counselor, a companion and most of all, to all of us you've been a friend. Regardless of what the situations were I think that you were able to hold out that sort of friendship with Democrats or Republicans, whatever the occasions, to bring things together in the Senate over the past years, especially in the last two. I will certainly remember, as all of us will, how you rose to the occasion of the last two years and pulled this Legislature and this thing back together. The people of the State of Maine should always remember that. During your years here you have done a lot for the State and the State is better for it, the people of the State of Maine are better for it and this Chamber is better for it. I'm sure that when you leave today you will always look back on this day and on these years that you have spent in the Senate, and you will remember all the good times that we had, like the little office in the back when I first got here, trying to squeeze in a number of people to try and decide what we were going to do for the day, to the bad times. So on behalf of the Senate members, and I think I speak for both sides of the aisle when I say that we thank you sincerely for all that you've done for us, for the State, for the Chamber. We thank you for your years of service, we thank you for your sacrifices. We know that during those years you have sacrificed time with your wife and your two sons and your home, I think that should be mentioned. That you have made those sacrifices and so have they and we want to thank your family for the sacrifices they made during those years and allowing us to share your great leadership here in the Senate. So, Mr. President, good luck to you and best wishes. Thank vou.

THE PRESIDENT: I guess since I came in each time that you chose me as your leader with a few remarks I would just as soon close with a few remarks. The conclusion of this confirmation session marks the end of legislative service for many of us in the body. Each of you deserve recognition for the dedication that you have given to this state with your service. The conclusion comes to some by choice, and some not by the choice of themselves but by the choice of others. For myself it does mark the end of eighteen years of service to this Senate, and the last eight years as your presiding officer. Before anybody thinks I'm going to start reminiscing about the last eighteen years let me tell you I'm not. I simply want to say that beyond the joys of home and family I've found my years of service in the Senate to be the richest, most rewarding years of my life. I still can walk into this building and this chamber and feel the excitement of helping people, of serving State and Country. It has been rewarding not only for what we have accomplished, and I think that we have accomplished a great deal on behalf of those that we represent, on behalf of those who elected us, but also the people who made up the Senate for the past two decades that I've had the privilege of serving, both in the minority and the majority. I have always attempted to use the lessons that I learned from my predecessors, Republican and Democrat. The years of Joe Sewall's four terms as presiding officer was something I always used as a benchmark for the way that we conducted the Senate. My mentor, in some sense, Gerry Conley, Sr. who I served as the Assistant Minority Leader to and under his tutelage and his constant advice learned to respect and appreciate each and every one of you for having your own particular perspective on what we should do in resolving the problems of the people in this state, that each one of us has the right to have an opinion that may differ from everybody else and we could still be a minority of one. I received a card from my former seat mate the other day, Dick Pierce. I sat in what is now Senator Collins' seat and Senator Pierce sat in what is now Senator Matthews' seat, we went from those two seats to both being assistant leaders, but in the closing days of us sitting in that chair we were on an issue that the vote was 31 to 2 and in his note to me he said that there are worse things than losing an election, you could always be on the losing side of a 31 to 2 vote, of which he and I had debated for several hours trying to win. I think the more we talked the more votes we lost but never the less a reflection from those members whom I have served with in the past, those members whom I have served with in the past, many of them who have sent cards and to each and every one of them I want to express my appreciation because it was a sign of friendship that crossed party alliances. I've had the good fortune to serve in this body with a very special group of men and women. Each and every one of you who are here today and those who have served in the past. Special because you've had the courage to get involved in the process rather than sit on the sidelines and process, rather than sit on the sidelines and complain about it. Special because you saw the problems facing our citizens and you were willing to try to solve them. Special because you saw society's wounds and tried to heal them. Special because you had the compassion to put the welfare of your fellow human beings ahead of personal and financial gains, of which many of you have sacrificed to serve in this body. I'm still taken back by the number of people who think that somewhere at 2:00 a.m. in the morning we voted to give ourselves a \$38,000.00 pay raise, I'm constantly being reminded of that in and out of coffee shops. And you're all special because although we didn't solve every problem we did meet every task head on and never stopped trying from our own particular perspective. There have been good own particular perspective. There have been good times, difficult times, there have been successes and there have been failures but through it all over the past eighteen years I can truly say that the membership of the Maine Senate have never shied away from the challenges that were placed before them. always rose to the occasion . You have acquitted yourselves quite well in this body and I want to tell you that it has been a privilege and an honor to stand at this rostrum and to wield this gavel on behalf of trying to conduct the business of this state. I would give one word of concern, and that is the constant attack that the institution of the Legislature itself is under. Under because many have failed their civic responsibilities and understanding the role of an elected official in the chamber and the other house to represent them, to carry out the charge of the public. It is an institution that deserves your respect and your protection with the citizens. You need to educate and enlighten them to the true facts. It is my hope that I have been worthy of the confidence and the faith and the trust that you have put into me over the last eight years. I would point out, always using Joe Sewall as a benchmark, in his four terms as Senate President he presided over this body for 659 days. I've had the privilege of working with Sally Tubbesing and the non-partisan staff, and with the partisan offices here trying to make the Legislature more accountable and responsible. In my eight years I have presided over this body for 604 days. We have reduced the amount of time while we've had an increase of around 25% in the number of bills, we've almost reduced 10% of the amount of time that we spend in session and accomplishing 25% more.

I want to thank you for the assistance, the direction, the understanding, the kindness, and particularly the friendship from both sides of the political aisle that you have given me over these many years. I'll never forget any of you. God bless each and every one of you.
