Representative **CLOUGH**: Mr. Speaker, Ladies and Gentlemen of the House. Howard Burdwood was born in Swamscott, Massachusetts and his family moved to Maine when he was in his teens. He graduated from high school in Bangor. He was a veteran of World War II and he served in the Air Force as a flight engineer on Sea 47 Cargo Planes. During the Korean War he was master Sergeant in the Marine Corp. He was a member of the Scarborough American Legion for many years. Howard met his wife Alice while in the Air Force in Nebraska. After the war he and Alice were married and moved to Maine and lived in the Portland area where they brought up a family of three daughters and a son. They moved to Scarborough in 1956. A long-term resident of Scarborough, he was active in community affairs. He stood up for the things that he believed in and gave much of himself for the good of his town, his neighbors and his friends.

In 1958, he was a charter member of the Scarborough Taxpayers Association and was active in that organization as its treasurer for many years. Concerned about the rapid commercial and residential growth in Scarborough, in 1989, he spearheaded the drive for a building moratorium, which was to put in permanent controls to control the rapid growth and development. He was a long-time member of the Scarborough Sanitary District and served on the board until his death. Howard retired in the early 80s from his job as an engineer for the former General Electric Manufacturing Plant in South Portland. After retirement, he continued to be active and operated his own machine shop business in a workshop next to his home.

He enjoyed private time, hunting and fishing, at his camp on Parlan Pond near Jackman. For over 40 years he pursued his hobby of raising and racing homing pigeons. With all of this, Howard still had time for his family. He was a devoted family man and enjoyed special times with his wife and children at his home on Maple Avenue in Scarborough. Howard Burdwood will be remembered as a man who stood up for his principles and his beliefs and he will be missed by all who knew him.

Representative LOVETT: Mr. Speaker, Ladies and Gentlemen of the House. I guess I didn't rise quick enough, but

I had a few words I would like to speak on. It is a great honor for me to stand before you today to recognize Howard A. Burdwood. Mr. Burdwood was a committed, honorable man. Most of all, he deserved being recognized by this body. As he was also a distinguished leader. Mr. Burdwood always worked very hard to support all things important to him. He was a dedicated family man and a community leader and a veteran of two foreign wars.

Many people in the Scarborough community will remember Howard Burdwood as a passionate man, never afraid to stand up and fight for a cause that he truly believe in. I can think of no better example of his passion than the effort that he made to organize and to save a historic elm tree. A road bridge project threatened the survival of this 175 year old elm tree at Oak Hill in Scarborough. As you drive through the next time on Route 1, I want you to glance to the right after you go through the Oak Hill intersection and you will see this historic monument. Though some people openly question the importance of his defending the tree, Mr. Burdwood believed in the importance of preserving the landmark by organizing citizens and eventually proving to officials that the tree did not have to be a casualty of the construction project. Today, the tree is marked with a plaque designating it as a historic landmark.

Mr. Burdwood's determination in saving the elm tree should be a lesson to all of us. If you believe in it, then it is worth fighting for. This is the way Howard Burdwood lived his life, whether it was defending his nation, raising his children or training his fleet of homing pigeons. Mr. Burdwood was an honorable man who will be sorely missed by his family and his community. I am glad some of his loved ones were able to be in attendance with us today. I am most honored to have been able to celebrate his life. Thank you.

JOINT RESOLUTION MEMORIALIZING THE UNITED STATES DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT TO PROVIDE FUNDING FOR MAINE'S EMERGENCY SHELTERS FOR THE HOMELESS

WE, your Memorialists, the Members of the One Hundred and Nineteenth Legislature of the State of Maine now assembled in the First Regular Session, most respectfully present and petition the United States Department of Housing and Urban Development as follows:

WHEREAS, the United States Department of Housing and Urban Development awarded \$800,000,000 in funding nationwide this year to states to provide relief to the homeless from the misery of living on the streets; and

WHEREAS, in 1998, the State of Maine received \$3,500,000 from the United States Department of Housing and Urban Development to provide services that helped Maine children and families at risk of death, injury or illness; and

WHEREAS, just 2 days before Christmas Day, 1998, the State of Maine received the news that there would be no funding for 1999 homeless relief, which is shocking and heartbreaking

news for a state that counted almost 15,000 homeless people in the previous year; and

WHEREAS, this funding cut is devastating to the State of Maine, where 30% of the people staying in shelters are young people and 21% of these young people are between 5 and 12 years of age with the average age of youth in shelters being 13 years of age; and

WHEREAS, the funding cut makes no sense since Maine has harsh and bitter winters and the need to protect its neediest citizens is as important this year as in any past year; and

WHEREAS, Maine provides more funding on a per capita basis for the elderly, disabled, mentally ill and the poor for services and support than most states, despite ranking 36th in per capita income, making this loss of funding a serious crisis; now, therefore, be it

RESOLVED: That We, your Memorialists, respectfully request that the United States Department of Housing and Urban Development restore the funding, of at the very least \$3,500,000, to the State of Maine, in order that we may treat the homeless in Maine with at minimum the same services they would receive in larger urban areas; and be it further

RESOLVED: That suitable copies of this resolution, duly authenticated by the Secretary of State, be transmitted to the Honorable Andrew Cuomo, Secretary of the United States Department of Housing and Urban Development and to each Member of the Maine Congressional Delegation.

READ.

The SPEAKER: The Chair recognizes the Representative from Portland, Representative Quint.

Representative **QUINT**: Mr. Speaker, Men and Women of the House. In September of this year, Andrew Cuomo, Secretary of the Department of Housing and Urban Development made a special trip to Maine to acknowledge our collaborative and innovative ideas of dealing with people experiencing homelessness. Just four months later, applications for funding were not renewed. This is devastating news to us and to Maine in general. People who were experiencing homelessness are not just men with drinking problems. This is devastating to 30 percent of people staying in shelters who are young people. Twenty-one percent of them are between the ages of five and 15 years of age with 13 years of age being the average.

This morning I got up and went out to walk my dog at about 5:30 and it was pretty darn cold this morning. So cold that I stayed out for about three or four minutes and came back inside. I do a lot of volunteer work for the Prebble Street Resource Center and even through all of that work, I find it very difficult to imagine how difficult it must be to be homeless and not have a place to stay. With that in mind, I would appreciate everybody's support in this Joint Resolution. Thank you.

The SPEAKER: The Chair recognizes the Representative from Kennebunk, Representative Murphy.

Representative **MURPHY**: Mr. Speaker, Men and Women of the House. When the good Representative from Portland came around with the request for the introduction for this resolution, I was supportive and had indicated that he was much quicker than I was. I think it had to do with my age. I very much wanted to get this resolution in as well. It appears that maybe here in Maine we have done something wrong. We have seen with the ice storm the pittance that was returned back to the state and we have seen what has happened here with the homeless shelters. This is an opportunity for the House to be on record. Maybe drawing the secretary's attention that something dramatically is

wrong. I think the good Representative from Portland, if you can imagine someone in a car this morning or a cardboard box, my seat mate had indicated that in his home street it was 19 below this morning. I would hope that we could have a unanimous vote on this resolution and forward it and get this funding problem corrected as quickly as possible.

ADOPTED.

ORDERED, the Senate concurring, that the Joint Rules be amended by amending Joint Rule 105 to read:

Rule 105. Salary and Benefits of Legislative Employees is Public Information.

Salary and benefit information regarding employees and officers of the Legislature is public information and when requested must be provided within a reasonable time by the Secretary of the Senate for Senate employees, the Clerk of the House for House employees and the Executive Director of the Legislative Council for other legislative employees.

; and be it further

ORDERED, the Senate concurring, that the Joint Rules be amended by repealing Joint Rule 203-A.

; and be it further

ORDERED, the Senate concurring, that the Joint Rules be amended by amending Joint Rule 205 to read:

Rule 205. Filing after Cloture.

Any request for a bill or resolve submitted to the Revisor of Statutes by a Legislator, the Governor or a department, agency or commission after the appropriate cloture date must be

transmitted to the Legislative Council. The council shall ascertain from the sponsor or the Governor the facts supporting the request notwithstanding cloture. If a majority of the council approves, the legislation is eligible for introduction as other legislation that is in compliance with Rule 202 or 203.

; and be it further

ORDERED, the Senate concurring, that the Joint Rules be amended by amending Joint Rule 206 to read:

Rule 206. Sponsorship.

- 1. Number; Governor's Bills. A bill, resolve, order, resolution or memorial may have up to 10 sponsors: one primary sponsor, one lead cosponsor from the other chamber and 8 cosponsors from either chamber. Each bill or resolve requested by the Governor or a department, agency or commission must indicate the requestor below the title.
- 2. Duplicate Requests; Chamber of Origin. For duplicate or closely related bills or resolves, the Legislative Council may establish a policy for combination of requests and the number of cosponsors permitted on combined requests. A bill, resolve, order, resolution or memorial having cosponsors must originate in the chamber of the primary sponsor.
- 3. Indian Representatives. The member of the Penobscot Nation and the member of the Passamaquoddy Tribe elected to represent their people at each biennial Legislature may sponsor or cosponsor legislation specifically relating to Indians and Indian land claims, may cosponsor any other legislation and may sponsor and cosponsor expressions of legislative sentiment in the same manner as other members of the House.

; and be it further

ORDERED, the Senate concurring, that the Joint Rules be amended by amending Joint Rule 301 to read:

Rule 301. Joint Standing Committee Responsibilities and Jurisdiction.

Joint standing committees are formed to assist the Legislature in the performance of its constitutional duties and are vested with the general authority granted in the Maine Revised Statutes, Title 3, section 165 and certain other specific authority granted from time to time by the Legislature. The responsibilities of joint standing committees include, but are not limited to:

- 1. Pending Legislation. Considering and reporting to both chambers on legislation pending before the Legislature;
- 2. Budget and Fiscal Policy Issues. Reviewing and making recommendations on budgeting and fiscal policy issues concerning State Government;
- 3. Actions of Departments and Agencies. Conducting oversight and review of the actions of departments and agencies of State Government, including, but not limited to, review of agency rules under Title 5, chapter 375, subchapters II and II-A and agency evaluations under the State Government Evaluation Act;
- 4. Gubernatorial Appointments. Reviewing and making recommendations on gubernatorial appointments that require legislative confirmation under Title 3, chapter 6; and
- 5. Other Tasks. Performing other tasks assigned to them, including, but not limited to, reviewing specific provisions of law, conducting studies on assigned topics, issuing reports on policy and legal issues of interest to the Legislature, reporting out specific legislation pursuant to joint order and authorizing the annual budgets of certain counties.

As authorized by title 3, section 165, there There are 17 joint standing committees, which must be appointed at the

commencement of the first regular session and which exercise jurisdiction in the following areas:

Agriculture, conservation and forestry

Appropriations and financial affairs

Banking and insurance

Business and economic development

Criminal justice

Education and cultural affairs

Health and human services

Inland fisheries and wildlife

Judiciary

Labor

Legal and veterans affairs

Marine resources

Natural resources

State and local government

Taxation

Transportation

Utilities and energy

; and be it further

ORDERED, the Senate concurring, that the Joint Rules be amended by adding a new Joint Rule to read:

Rule 312-A. Constitutional Resolutions.

A committee may submit the question to be voted on under a resolution proposing to amend the Constitution of Maine to the Secretary of State for review prior to reporting the resolution out of committee with a recommendation other than "Ought Not to Pass" or "Referral to Another Committee." The Secretary of State shall apply the same standards of clarity to that question as to questions for the people's veto and initiative referenda under the Maine Revised Statutes, Title 21-A, section 906, subsection 6 and advise the committee and the sponsor of the resolution as to the recommended wording of the question.

; and be it further

ORDERED, the Senate concurring, that the Joint Rules be amended by repealing Joint Rule 405.

; and be it further

ORDERED, the Senate concurring, that the Joint Rules be amended by renumbering the Joint Rules to read consecutively.

READ.

The SPEAKER: The Chair recognizes the Representative from Naples, Representative Thompson.

Representative **THOMPSON**: Mr. Speaker, Men and Women of the House. The Joint Order which I have just introduced is the report of the Rules Committee, which met to consider proposed changes to the Joint Rules. This order is a Joint Order and pertains solely to the recommended changes to the Joint Rules. The Joint Rules met and considered a number of items and are recommending those items to you today. The first item is rule 105 and the text to each of these changes is directly in your calendar on page 31 under item 4-2. The change to Rule 105 is simply a clarification of the process for disseminating information under freedom of information requests. It simply indicates that for employees of the House of Representatives that information would be distributed by the Clerk, for the Senate, by the Secretary of the Senate and for all other legislative employees, by the Executive Director of the Legislative Council. That simply clarifies who is responsible for releasing the information. That item passed by a vote of 8 to 0 in the Rules Committee.

The next change is in rule 205, filing after cloture. This is a change which reflects upon the rule, which we adopted, establishing a cloture date for the Chief Executive. The Rules

Committee reviewed that rule change and in response to a letter from the Governor, which set forth a proposal to the presiding officers, the Rules Committee reviewed the cloture date for the Chief Executive and voted to remove the cloture date for the Chief Executive from the Joint Rules. The letter to the presiding officers sets forth the procedure that will be followed for the filing of bills by the Governor. The Governor indicated to the presiding officers that a date would be established. That date is six weeks prior to the date set by the presiding officers for the reporting out of all bills from the committee. The presiding officers have set a date of. I believe, it is April 15th or 16th to have all bills reported out of committee and backing up from that date, six weeks earlier, sets a date of approximately March 5th for the Governor to file all of his legislation. What this does is enable the Legislature to have the Governor's bills in a timely manner to consider these bills and by reaching this agreement and by removing the rule it also prevents what would be potentially an appeal to the law court by the Chief Executive to test the application of our rule. The Rules Committee voted on these changes and also voted by a vote of 8 to 0 to remove the cloture date from the rules. After the March 5th date, the Governor further went on in his letter to indicate that he would consult closely with the presiding officers on any other matters which he felt were necessary to bring forward to the Legislature after that date. Based upon his representations, the committee voted 8 to 0 to remove the cloture date for the Governor.

The next change is in rule 206 on sponsorship of legislation. The recommendation of the committee is to amend rule 206 by that the Indian Representatives, the representatives, will be able to, in the future, if this rule is adopted, cosponsor legislation. Currently the rules provide that they may introduce legislation pertaining to the Indians or to the Indian Land Claims Settlement Act directly relating to those areas. They may sponsor or cosponsor. A proposal was set forth to allow them to sponsor all legislation. The committee amended that proposal and would allow the Representatives to introduce legislation as is the current practice on matters directly pertaining to the Indians or the Indian Land Claim Settlement Act. To be allowed to cosponsor or sign onto other bills introduced by other legislators on any matter. This bill, as the person who proposed a change, arose out of the dioxin bills which we heard in the 118th Legislature where one of the Representatives was not allowed to enter on as a cosponsor even though, obviously, the water quality, the dioxin levels in the Penobscot River could dramatically affect the Indian Tribe. The committee recommended on an 8 to 1 vote to adopt the change to rule 206.

Rule 301 is actually a technical change and does not make any substantive change. It removes the beginning of the first part of the first sentence in rule 301 by striking the reference to Title 3 of the Maine Revised Statutes. By doing so, it removes the reference to the statute clarifying that solely this Legislature has the authority to establish Joint Standing Committees and the number of Joint Standing Committees that it so chooses. It is not necessary to refer to the statute and, in fact, might be a bit misleading because we do not have any requirement to conform to Title 3 when we are establishing our Joint Standing Committees. It is totally up to the 119th Legislature to determine how many committees and what those committees shall be. That recommendation passed by a vote of 8 to 0.

The fifth proposed rule change is a proposal which allows Joint Standing Committees to refer proposed constitutional amendments to the Secretary of State's Office to be reviewed for language. That is when you have a proposed constitutional amendment the Secretary of State's Office has a procedure in affect for reviewing initiative petitions for being placed on a ballot to ensure that the language is clear and is specific to the question trying to be asked. This enables the committees to refer a matter to the Secretary of State's Office. It does not require them to do so and asks the Secretary of State for an opinion on how they would suggest the matter to be worded. This does not place a requirement on the committee and once suggested by the Secretary of State, there is no requirement that we absolutely have to follow their recommendation.

Those are the five changes, which the committee is recommending. By the way, that last item passed by a vote of 7 to 0. Those are the changes we are proposing. I hope that you will support these changes. Thank you.

The SPEAKER: The Chair recognizes the Representative from Waterboro, Representative McAlevey.

Representative MCALEVEY: Mr. Speaker, Men and Women of the House. It is my pleasure to serve on that committee also. Depending on where you come from, rules can be very, very exciting or very, very dull. If you don't have much of a life, I guess they are exciting. We did have some very frank discussions. In two or three incidences, members came before us with requested orders and we were able to, through the discussion with the Speaker and the President of the other body, agreed that we didn't need to implement rules to accommodate those changes. I want to compliment all the members of the committee. It was truly a bipartisan effort. I would ask that when we do vote on this that you would support the unanimous report. We did have some very frank discussions. Everything that was presented to us was, I believe, debated very thoroughly and into enough depth that could understand whether we needed to make the changes or not. You must remember that some changes require a gradual approach. I do want to commend the members of the committee for their hard work. It was hard work. I would urge that when the vote is taken that you support the unanimous committee report. Thank you.

PASSED.

Sent for concurrence. ORDERED SENT FORTHWITH.

On motion of Representative VOLENIK of Brooklin, the following Joint Order: (H.P. 357)

ORDERED, the Senate concurring, that Joint Rule 301, last paragraph is amended to read:

As authorized by Title 3, section 165, there are $\frac{17}{16}$ joint standing committees, which must be appointed at the commencement of the first regular session and which exercise jurisdiction in the following areas:

Agriculture, conservation and forestry Appropriations and financial affaire Banking and insurance Business and economic development Criminal justice Education and cultural affairs Health and human services Inland fisheries and wildlife Judiciary Labor Legal and veterans affairs Marine resources Natural resources State and local government

Taxation Transportation Utilities and energy

; and be it further

ORDERED, the Senate concurring, that Joint Rule 314 is repealed and replaced to read:

Rule 314. Participation in Budget Hearings and Work Sessions.

As used in this Rule, "policy committee" means a joint standing committee or joint select committee having subject matter jurisdiction.

In each year of the biennium, any budget bill submitted to the Legislature by the Governor is subject to the following procedures.

- 1. Budget Recommendations. Budget recommendations made by the Governor on areas within the jurisdiction of a policy committee must be heard initially by the policy committee having jurisdiction over the subject matter presented.
- 2. Policy Committee Recommendations. Each policy committee shall report out the policy committee's recommendations regarding the relevant part of the Governor's budget. These recommendations must be reported out within a time period set by the presiding officers after consultation with the chairs of the policy committee.
- 3. Reconciliation Authority. Notwithstanding Joint Rule 406, following final enactment of each policy committee's recommendations, the Joint Standing Committee on Taxation shall receive and review the revenue and expenditure recommendations as enacted and reconcile the budget to reflect those recommendations. In performing this reconciliation, the Joint Standing Committee on Taxation shall propose changes in taxes in order to balance the enacted expenditure recommendations against the expected revenue. The Joint Standing Committee on Taxation shall report out its recommendations within a time period set by the presiding officers after consultation with the chairs of the Joint Standing Committee on Taxation.
- 4. Enactment by Legislature; balancing. The reconciliation recommendations of the Joint Standing Committee on Taxation must be voted on by both chambers and may be amended as long as the reconciliation recommendations as finally enacted have the effect of balancing the enacted expenditures against anticipated revenue. Following final enactment of the reconciliation recommendations, the enacted expenditures and the enacted reconciliation recommendations must be presented to the Governor pursuant to Joint Rule 406.

READ

The SPEAKER: The Chair recognizes the Representative from Brooklin, Representative Volenik.

Representative **VOLENIK**: Mr. Speaker, Men and Women of the House. This rule would eliminate the Appropriations Committee. It would give jurisdiction for each section of the Executive's budget to the committees of jurisdiction and it would change the way bills with fiscal notes pass through the process. I have no quarrel with the Appropriations Committee. They are all honorable citizens. Many are good friends and they strive harder than most of us to serve, often long into the night, with the best interests of this institution and of their constituents. I will argue that the committee that they serve and that they try their hardest to make work for the rest of us. That committee and its mission are flawed. It is the system that we have created over generations and that we have the power today to recreate. We all know how the system works. On second

thought, maybe some of you new Representatives only have an inkling of how the system works and does not work.

It is simple. This body passes a bill. The other body passes the bill and it goes on to the Executive for signature. Right. Along comes a bill with a fiscal note. We pass it. The other body passes it on a silver platter to the other branch, the appointed branch, the Appropriations Committee. When we are done and when the other body is done passing what we chose to make into law, we are at the mercy of the Appropriations Committee in conjunction with leadership and in conjunction with the Executive's Office and in the face of sometimes intense lobbying by known and unknown interests in late night public and private negotiations that ultimately ends up in this chamber at 4 a.m. when the Speaker gavels through in the space of minutes a legislative package deal that we, numbly and often with toothpicks holding our evelids open, gratefully accept, on both sides of the aisle with exhausted relief while holding our noses at parts of what we have unanimously passed. It is a fun process that you will have nightmares about as vivid as those dreams of sleeping through you final exams or dreams of the death of a loved one or the death of your own highest principles or of your soul.

There is another way. We have it in our power to eliminate the Appropriations Committee and one of our worst nightmares. Without that committee, we can have truly democratic, truly worthy of a republic, legislation. Legislation that all of us vote on in the normal legislative manner. Think about it, if only for a brief moment, before you vote this proposal away into the dust heap of what might have been. Imagine that we pass a bill with a fiscal note. We send it to the other body, which also passes it and at the end of the session, after we have rejected some bills and passed others, we add up the total cost. If the cost is greater than projected revenues, the Taxation Committee determines what taxes must be adjusted to make up for the shortfall, then it gives its recommendations to us and to the other body and we either pass those changes or we amend them on the floor and pass alternative tax changes that balance the budget. If the total cost of all bills with fiscal notes is less than projected revenue, the Taxation Committee would similarly recommend tax cuts in some form, which we would, again, vote in or amend.

We, and the other body, would begin to be prudent on what we pass as legislation. No longer could we say to each other, I don't like the bill that I just voted for, but what the heck. We know Appropriations will kill it before it finally sees the Executive's signature. We would lose that political cover, but we would gain the high ground of voting on our principles. Think about it. This rule change is not to be taken lightly. This is a radical change. Just as our forefathers 224 years ago practiced radical change when they excitedly and fearfully converged in overwhelming numbers upon the marching columns of red coated soldiers who had shot down their neighbors on that electric April morning in Concord and Lexington. Think about it as you picture in your minds eye how you want this session to end. Do you want to feel good about battles won? Battles hard and well fought that you might have lost or do you want to watch bleary eyed, resentful of the process in some late night at the end of the session as, again, the Speaker hammers down the last minute sausage deals that you will then struggle to explain to the people of your district.

I simply ask you to think about it. Thank you.

Representative THOMPSON of Naples moved that the Joint Order be **INDEFINITELY POSTPONED**.

The SPEAKER: The Chair recognizes the Representative from Penobscot, Representative Perkins.

Representative PERKINS: Mr. Speaker, Colleagues of the House. I commend my friend from Brooklin for having the courage and foresight to bring this to us. Representative Volenik and I have talked about this for about four years. He finally had the courage to come forth with this. I agree with just about everything he said. I have felt since I have been here that the Appropriations Committee, with all due respect that Representative Volenik gave them for all their hard work, that is not the point. The point is it seems to me that they are almost a separate branch of government or a separate branch of the Legislature. I have felt helpless to do anything about it. This is a simple straightforward thing. I am sure there would be a few details to work out. My instinct tells me it will probably fail miserably to pass. I ask you to really take a close look at this. Just having the debate, I would like to keep the debate alive a little bit here and hopefully people will share their feelings on it, if anybody else feels similarly. Thank you.

Representative PERKINS of Penobscot **REQUESTED** a roll call on the motion to **INDEFINITELY POSTPONE** the Joint Order.

More than one-fifth of the members present expressed a desire for a roll call which was ordered.

The SPEAKER: The Chair recognizes the Representative from Naples, Representative Thompson.

Representative **THOMPSON**: Mr. Speaker. Men and Women of the House. This proposal was brought forth to the Rules Committee and was voted down on a 7 to 0 vote and clearly voted to recommend not to pass this proposal. I have been here for a four-year period and I can understand people's frustrations with the appropriation process. I am not sure that this rule would change anything other than naming the Taxation Committee as the committee that does the final reconciling of the budget. The truth is over the last four years that the Rules Committee has worked to gain increasing input into the budget process by the policy making committees. If you talk to people that have been here, going back further than that, they were never given the input that we have now. We are now having the policy committees meet with the Appropriations Committee in a joint public hearing. We are meeting as policy committees and making recommendations regarding the supplemental budget first and we will then make recommendations regarding the budget for the next biennium. We are listing our priorities for our committees recommendations of priorities for the proposed new spending in the part II budget.

Anyone that has been here any length of time knows that the key to this process is you have to be there. You have to put the time in. You have to stay on top of it every day. You can't assume that because something is put in one day, it is going to stay there to the next day. You can't assume that it is because something is rejected one day that it is out of the budget forever. It is an ongoing moving document that is constantly changing until it is finally enacted. It is not pretty, but I don't know of any better way to do it. It is hard work and it is a lot more work than most of us are willing to do to shepherd something through the whole appropriations process. I certainly don't begrudge the people on the Appropriations Committee and the time that they spend in session in their committee. I know and I learned from my first term that when I thought I had something that was going to get funded and then didn't follow through on it, that it takes more work than I gave the initial try. I have learned that you have to follow things. I appreciate the concerns of

Representative Volenik and I can only tell you that his message was heard by the Rules Committee and I expect, in the future, that the Rules Committee will be looking at this process to see if there are additional steps that can be taken to empower individual members of the Legislature to give you more input into the process.

I would ask, at this time, that you join me in voting for the motion to Indefinitely Postpone.

The SPEAKER: A roll call has been ordered. The pending question before the House is Indefinite Postponement of (H.P. 357). All those in favor will vote yes, those opposed will vote no.

ROLL CALL NO. 5

ORDERED, the Senate concurring, that the Joint Rules be amended by amending Joint Rule 304 to read:

Rule 304. Procedures for Public Hearings and Work Sessions.

At the beginning of each legislative biennium, all committees shall adopt procedures that govern public hearings, work sessions and confirmation hearings. Copies of the procedures must be sent to the presiding officers, the Secretary of the Senate, the Clerk of the House and the Executive Director of the Legislative Council upon adoption and must be posted and made available upon request at all public hearings and work sessions.

The rules of procedure in committee are the same as the rules of the Senate and the House of Representatives to the extent applicable. Committee procedures must be consistent with these rules.

The presiding chair shall decide all questions of order, subject to appeal to the committee. The chair's ruling stands

unless overruled by a majority vote of the committee membership.

Scheduling of bills to be considered in public hearings and work sessions must be arranged by the Senate chair with the agreement of the House chair; if agreement is not reached, the committee shall decide by majority vote of the membership.

At public hearings, the chair may limit testimony as necessary for the orderly conduct of the hearing. Members may question witnesses to clarify testimony and to elicit helpful and pertinent information. While aggressive and probing questions may sometimes be appropriate, members shall exhibit respect for the witnesses and for one another. Members shall refrain from interrogation that is argumentative, oppressive, repetitive unnecessarily embarrassing to hearing participants. Advocacy and discussion among members are not appropriate at public hearings. A committee member who is the primary sponsor of a bill and any member who testifies for or against the bill should ordinarily refrain from questioning other witnesses. A witness testifying before a committee shall provide a statement that includes the amount and source of any federal or state grants, appropriations or allocations or any federal or state contract received during the current fiscal year and previous 2 fiscal years by the witness or an organization the witness represents.

READ.

The SPEAKER: The Chair recognizes the Representative from Standish, Representative Mack.

Representative MACK: Mr. Speaker, Right Honorable Men and Women of the House. My amendment to the Joint Rules copies a rule adopted by Congress in Washington two years This rule would bring even greater openness to the lawmaking process by making you and I, as legislators, aware of the individuals, groups and special interests receiving government money. More important, it gives the taxpayers of Maine this information. The taxpayers deserve to know exactly what is going on here. It requires any witness appearing before a Joint Committee or Subcommittee to disclose the source and amount of any state or federal grant that they or their organization received. Many agencies exist to spend state money and administer state programs. They exist through state money alone. The testimony of these individuals, groups and special interests are often an important guide used to determine the effectiveness of state programs.

You and I need to know how much government money is given to organizations and special interests for lobbying for rules that affect them and for even more government money to pay for state programs they get paid to administer and hire executive salaries as a result. It is critical to determine whether witnesses are testifying as truly impartial advocates of a particular policy program or if they may personally stand to benefit from the new regulation or expanded program they are testifying on. This is information that the taxpayers as well as you and I deserve to know. I urge your support of this amendment. Thank you.

Representative THOMPSON of Naples moved that the Joint Order be INDEFINITELY POSTPONED.

The SPEAKER: The Chair recognizes the Representative from Naples, Representative Thompson.

Representative **THOMPSON**: Mr. Speaker, Men and Women of the House. This matter was also worked by the Rules Committee and was voted down by a vote of 7 to 0 and did not receive any support in the Rules Committee. I suggest to you, first of all, that this rule is unnecessary in that if a member of the committee wishes to ask these questions of

someone standing before them, they have the right to do so. However, I think there is even a broader and a more important issue to be discussed and that is simply that are we going to start placing requirements on people that come before us in public hearings before they are allowed to testify? Who is this requirement on? If someone refuses to give this information, are they going to be refused the right to testify at our public hearings? I think it is the wrong method to take. Our public hearings, we pride ourselves in giving every bill before us a public hearing, whether someone or an organization they work for receives federal funds or state funds, does not do anything to take away from the fact that they are, in fact, a member of the public. It may be a bill solely pertaining to one of their personal interests, not pertaining to the government funding and yet we are still going to require them to make a disclosure before they are allowed to testify. I think it is a huge mistake to go down that road and secondly. I think it is also wrong to direct reporting requirements at one group of people, groups of people that are receiving state funding. Should we then require everyone to file written reports, all of the lobbyists on every one of their clients and how much they received that month. Maybe that is already reported to the Governmental Ethics Commission, but we don't require that to come forward every time they testify. If we want to know that, we can ask them. I would ask that you join me in Indefinitely Postponing this Joint Order.

The SPEAKER: The Chair recognizes the Representative from Standish, Representative Mack.

Representative MACK: Mr. Speaker, Right Honorable Men and Women of the House. This would not prohibit anybody from coming and testifying before any committee. Any average citizen could still come in and testify. Anybody from an agency could still come in and testify. They would just know that before they came to the committee, they would have to have made available the amount of money they already get from the government. Anybody can ask this to anyone right now, but how often have you asked something and they promised they would get it to us in the work session and they never do and we have to wait for the work session for something. This would have this information available on the day of the public hearing and I think would be very helpful for us to have beforehand. Also, I ask that when the vote is taken, that it is taken by the yeas and nays.

Representative MACK of Standish **REQUESTED** a roll call on the motion to **INDEFINITELY POSTPONE** the Joint Order.

More than one-fifth of the members present expressed a desire for a roll call which was ordered.

Preamble. These rules of the House of Representatives are adopted pursuant to the Constitution of Maine to assist in carrying out the responsibilities of the House of Representatives. These rules take precedence over the Joint Rules, statutes enacted by a prior Legislature relating to the proceedings of the House and other rules used in Legislative assemblies. These rules govern the proceedings of the House in all matters, subject only to the requirements of the Constitution of Maine.

ORDERED, that the House Rules be amended by adding a new House Rule to read:

Rule 107. Legislation establishing House proceedings statutorily. A member may question the appropriateness of a bill that attempts to establish proceedings of the House in statute. Such legislation may be ruled not properly before the House by the Speaker.

; and be it further

ORDERED, that the House Rules be amended by amending House Rule 507 to read:

Rule 507. Printing and distribution of amendments. An amendment to a bill or resolve may not be acted upon by the House until the same has been printed and distributed to the members under the direction of the Clerk, unless the same bears the recommendation of the Committee on Rules and Business of the House that such printing be dispensed with; and any amendment not so printed or bearing such recommendation

must lie on the table until printed or until the Committee has recommended that such printing be dispensed with. All amendments filed with the Clerk for printing must bear the signature of the member filing the same.

A House amendment that strikes and replaces in total a committee amendment is not properly before the House.

: and be it further

ORDERED, that the House Rules be amended by amending House Rule 517 to read:

Rule 517. Engrossed bills. All engrossed bills and resolves must be committed to the standing Committee on Engrossed Bills to be strictly examined; if found by the committee to be truly and strictly engrossed, the committee shall so report to the House, and the question must be taken without any further reading. The Speaker of the House may order any bill or resolve to be engrossed upon its introduction to the House.

READ.

The SPEAKER: The Chair recognizes the Representative from Naples, Representative Thompson.

Representative **THOMPSON**: Mr. Speaker, Men and Women of the House. This House Order is the report of the Rules Committee pertaining to recommended changes in the House Rules. Each of these recommended changes were made by unanimous vote of the committee in a 5 to 0 vote. There were five members on the House aspect of the Rules Committee.

The first change to the rules would be to add a preamble to the rules which sets forth in the rules that the Rules of the House take precedent over all other areas that try to set forth House procedure. It sets forth clearly that the House Rules are subject only to the Constitution of the State of Maine under which we operate. The House Rules take precedent over the Joint Rules and over any attempt by a prior Legislature to enact rules or procedures into statute.

The second change is to rule 107. It is a new rule, adding rule 107 to the House Rules. That is that any member may question the appropriateness of a bill that attempts to establish proceedings of the House in statute and such legislation may be ruled not properly before the House by the Speaker. That rule is an attempt to create statutes that conflict with what rules this Legislature may set and to falsely present to the public, perhaps, that an item that we put into statute may have some affect on the next Legislature. For example, we could pass a statute that indicates that there shall be 20 standing committees, but when the 120th Legislature comes to be sworn in and they establish their own rules they, and they alone, according to the Constitution, have the right to set forth what will be the rules for the proceedings in that Legislature. Therefore, that statute would only be a misleading representation to whoever would read it that it was applicable law when, in fact, it has no affect, no binding affect on a subsequent Legislature. The reason that was put in was to keep such proposals from going forth from this body.

The next proposed rule is a technical rule of procedure to rule 507, which adds the sentence. "A House Amendment that strikes and replaces in total a Committee Amendment is not properly before the House." When you propose an amendment that strikes a Committee Amendment and substitutes the House Amendment, what you are doing is prohibiting any further amendment of that legislation because then you would be placed in the position of amending an amendment, which we are not, by the rules we follow, we cannot amend to the second degree. You can amend the original document, be it the

committee report or a bill, but we are not to amend to the second degree. Therefore, if you completely strike the Committee Amendment and substitute an amendment, that ends all further attempts to amend that legislation. Placing it in rule would prevent that practice. In essence, also would conform to the procedure that the Revisor's Office has been trying to follow.

The next proposal is to rule 517. It adds language pertaining to the Speaker's ability to order a bill Engrossed. This is necessary because we have stricken from the Joint Rules language pertaining to Engrossment of bills and placed it more properly . . .

At this point, the Speaker placed the House at ease and the members exited the building due to a fire alarm.

(After Fire Alarm)

The House was called to order by the Speaker.

The SPEAKER: The Chair recognizes the Representative from Naples, Representative Thompson.

Representative **THOMPSON**: Mr. Speaker, Men and Women of the House. And for the foregoing reasons, I ask that you join me in voting for this House Order. Thank you.

Subsequently, the House Order was PASSED.

On motion of Representative GLYNN of South Portland, the following House Order: (H.O. 9)

ORDERED, that House Rule 510 be amended to read:

Rule 510. Yeas and nays. A call for the yeas and nays is in order at any time before a vote is made certain and declared; except that a call for the yeas and nays is mandatory on any vote on final enactment of a bill.

READ.

The SPEAKER: The Chair recognizes the Representative from South Portland, Representative Glynn.

Representative **GLYNN**: Mr. Speaker, Men and Women of the House. This issue that is before you, I regard as a truth in voting amendment. As many of you are aware, under our current rules and regulations of the House, many votes are not taken and recorded in a way for the public to be able to have access to them and know how their legislator voted. On each one of your desks is a yellow sheet of paper that I have asked to have distributed. It is facts on roll call enactment votes. During our last session, during the 118th Legislature, there were 1,018 measures that were enacted to law. These aren't the bills that were presented to the Legislature, these are the actual things that made it all the way to the end of the process where they were enacted into law.

During that same session there were 653 roll calls taken during this Legislature. Of the 1,018 only 112 of these roll call votes were taken on Enactment. In other words, ladies and gentlemen of the House, one out of every 10 votes that the people of Maine are living under that rule, that regulation, that tax or that policy, that resolve, were voted on in a recorded manner in which that member of the public can look at your voting public. I believe that what we need is more accountability

in the Legislature and that we need good government legislation. If we looked to other levels of government, for instance, local city councils and board of selectmen and board of aldermen, our school boards and our county commissioners. When we pick up the minutes to the meetings, we can see how each and every member voted on each and every issue. That is the accountability that is at the local level. I want to see that same accountability at the state level.

The people of Maine do have a right to know. We look at the Legislative Record on any issue in particular and you will open it up and you will see the bill is presented by a legislator and you will see supporting documents in there on how that bill went through the process. You will see how the committee voted on that issue. You will see their recommendations. You will see debate on the floor of this House, but if you want to see how your member voted, it is not in that record unless a member stands and asks for a call.

I have a feeling that this policy has been in place so long in Augusta and it has taken place for such a long period of time that I don't believe anybody here or at least enough people here have, in the past, believed it was important or know that it was wrong that votes aren't recorded. I stand before you today and ask that you consider that our actions should be public and that each and every action should be public and there should be a record and a recorded vote as such. I ask for the support of this amendment. Thank you Mr. Speaker, I would ask for a call of the yeas and nays on this so that the people of Maine do know who supports their right to know.

The same Representative **REQUESTED** a roll call on **PASSAGE**.

More than one-fifth of the members present expressed a desire for a roll call which was ordered.

The SPEAKER: The Chair recognizes the Representative from Naples, Representative Thompson.

Representative THOMPSON: Mr. Speaker, Men and Women of the House. I will speak briefly so that I don't interrupted this time. This House seems to have operated since I have been here quite nicely under the existing rule. The House is very courteous to its members and extends the right to a roll call when one is requested. Many of the bills that were enacted probably had roll calls at an earlier stage, for example, at the first reading, second reading, when attempts were made to amend it or at the acceptance of the committee report. People are clearly on record on many of those issue. The truth is if we add 900 roll calls to our time here, a simple issue would be that we better crank up the budget and give us some more money. If you take five minutes for each roll call, which is a short amount of time, you are talking about over 70 hours of session time just at five minutes per roll call. If you doubled that to 10 minute average per roll call, obviously you are looking at 140 hours of session time. I would tell you that in my opinion it is not necessary. It would be costly and if a roll call is required, then one can be requested. Mr. Speaker, I am going to move the Indefinite Postponement of the House Order.

Representative THOMPSON of Naples moved that the House Order be **INDEFINITELY POSTPONED**.

The SPEAKER: The Chair recognizes the Representative from Portland, Representative Saxl.

Representative **SAXL**: Mr. Speaker, Men and Women of the House. I just briefly want to stand and speak on this proposed House Rule today just to give you some perspective. As the good Representative from South Portland requested a roll call on this vote, the Speaker followed immediately and said that in

order to order a roll call, we need the express consent of onefifth of those members present and voting. At the most, that is 30 members of this body. In my experience in this body, nobody has ever refused to grant somebody else a roll call. If they did and they brought it to the floor of the House, they would only need 30 members of this body to join with you to have a roll call. In my experience in this body, we often have roll call votes on Engrossment or on House Amendments or on Committee Amendments. The reason we don't have them on Enactment is because the debate has already been held. In my experience in this body, when people don't call for a roll call, it is because everybody agrees. The thing that we don't know and maybe the public doesn't know as well as they should know is that almost every position we take in this body is agreed on almost unanimously because the system works. Bills are referred to committee and each and every one of them that we had referred to committee today was unanimous. Before the session, I sit down with the Speaker of the House and members of the minority leadership and we talk about reference of bills. The bills go to the committees of jurisdiction and those committees get together. Democrats and Republicans, and most often they unanimously agree to a piece of legislation or they unanimously kill a piece of legislation.

The system works as we have it. The public has a right to know and each and every one of these meetings is open to the public. When we have a roll call vote, they get that report. When we don't have a roll call vote, they know it is a unanimous consent of the entire elected body. If you ever want a roll call vote on the floor of this House and there is no fire alarm at the time, you need only stand on the floor of the House and request the yeas and nays. It is a great tradition. This Legislature has run very well for 119 sessions that way. I urge you to support the Chairman of the House Rules Committee and support the Indefinite Postponement of this measure.

The SPEAKER: The Chair recognizes the Representative from Northport, Representative Lindahl.

Representative **LINDAHL**: Mr. Speaker, Men and Women of the House. What we really need is a rule to define brief. Thank you.

The SPEAKER: The Chair recognizes the Representative from Lewiston, Representative Mendros.

Representative MENDROS: Mr. Speaker, Colleagues of the House. I rise in support of this amendment. It is a simple issue of good government. I will be willing to be held accountable to our constituents for our votes. As my colleague from South Portland pointed out, they do it with local government, you see it on CSPAN. It is an opportunity to tell the people of the State of Maine we are willing to take accountability for the final passage of bills. That is all it is about. Right now we can cast our vote and we can say we don't care about the final passage, we don't care about letting you know how we vote because we are above that or we can say, yes we do care and we are willing to put our name and our vote on any law that gets passed. As far as the 70 session hours, I think if we are doing this, we are all going to be in here and all these bills that go under the hammer and go under quickly, well, if we are in here and they go under the hammer, we can be in here and cast our vote right away. I don't think it will take even five minutes if we have six or seven that would be going under the hammer. I know that my opponent would gladly put in those 70 session hours to be here and doing it and I know almost everyone else in here has an opponent who would gladly take the time to spend extra 70 session hours if they had the opportunity to be here to do it. I encourage you to vote for good government and have the State of Maine take a stand that we believe in being accountable to the citizens of the people of Maine. Thank you.

appointed by the Speaker of the House. The first-named Senate member is the Senate chair; the first-named House member is the House chair.

The committee shall meet at least once annually and at other times agreed upon by the President of the Senate and the Speaker of the House to review the joint rules and recommend changes the committee determines necessary.

The committee shall invite the participation of the Secretary of the Senate, the Clerk of the House, the Executive Director of the Legislative Council, the Director of the Office of Fiscal and Program Review, the Director of the Office of Policy and Legal Analysis and the Director of the Office of the Revisor of Statutes. The Secretary of the Senate and the Clerk of the House shall provide necessary staffing services to the committee.

The committee shall report annually by October 15th with any suggested changes to the Joint Rules.

Representative **THOMPSON**: Mr. Speaker, Men and Women of the House. The reason this wasn't in our calendar today is because it was the one rule change proposed by a Senator to the Joint Rules.
