The SPEAKER: The Chair recognizes the Representative from Sanford, Representative Tuttle.

Representative **TUTTLE**: Mr. Speaker, Men and Women of the House. The bill before you today appeals the section of the alcoholic beverage law which permits a public broadcasting station to accept gift certificates from a brewery, winery or wholesaler for the purposes of an auction. Current law requires that the bureau be notified of any donation to a public broadcasting station, which shall include a description of a donation, the estimated value and the state of which the donation was made. Current law also requires that the station ensure that the recipient of the donated item is 21 years of age or older. We heard much testimony at the public hearing on this issue.

As many of you are aware, this issue was before us last year. The proponents feel the issue of minors having access to alcohol is a serious issue and that the state should do all it can to prohibit youth access, even if it hurts someone's profit margin. Also, auctioning alcoholic beverages on television sends the wrong message. They feel as many of you do here from other testimony, they consider it inconsistent in the law against the advertising of alcoholic beverages being prohibited. If we are going to ban advertising, we must ban the sale through auction as well. Also the proponents of this bill feel similar to states by banning casinos for gambling, but supporting a state lottery. We also received testimony at the public hearing that this bill, if passed, would negatively impact the number of small micro-breweries and family owned wineries throughout the state. We had testimony from many areas of the state from the small Maine companies and they expressed their concerns. Opponents to this bill said it is crucial for the Maine Public Broadcasting Company to maximize public and private fundraising, auction proceeds from beer and wine, campus certificates are relatively low in dollar amount. They feel that any small amount can significantly add to helping Maine Public Broadcasting.

As many of us are aware, Maine Public Broadcasting has put thoughtful consideration policies governing the auction of these products, such as eliminating what they call the superlative description of the product and announcing the item for auction only after 10 p.m. at night to name just a few. Maine Public Broadcasting Company is required to prove that the recipient of the gift certificate is at least 21 years of age and also one such certificate is granted if the person would have to go through the facility to receive the product, they would also have to present identification of age 21. For a small business, such as a local winery, this auction provides advertising that would be otherwise available. Wineries, breweries, etc., have worked with Maine Public Broadcasting to ensure youth do not have access to the project distributed in this way.

Mr. Speaker, men and women of the House, this is not a partisan issue. I ask that you listen to the debate and vote your conscience. Thank you.

The SPEAKER: The Chair recognizes the Representative from Madawaska, Representative Ahearne.

Representative **AHEARNE**: Mr. Speaker, Ladies and Gentlemen of the House. I ask you to follow my light and reject the pending motion. In the previous Legislature, we had a lengthy debate on the law in question. LD 147 would repeal the law that permits broadcasting stations to auction alcoholic beverages. What is the law? I believe my good friend from Sanford gave us a description, but I will go over it again.

Under current law, a licensed brewery, winery or wholesaler may donate a gift certificate to purchase this product through a broadcasting station for the purpose of an auction. The bureau must be notified in writing of any donation and must include a description of the donation, the estimated value and the date it was donated. The public broadcasting station must ensure that the recipient of the item is 21 years of age or older. It sounds simple enough. No actual alcohol is being auctioned and there is an age verification clause.

There is a problem, allowing the auction of alcohol, even in the form of gift certificates, while not permitting the auction of tobacco products, yes, that is right, tobacco products, could lead to court action of even an introduction of legislation to permit the auction of tobacco products. This double standard is unwise at best. By accepting the pending motion, what message is this Legislature sending? It sends the message that Maine is not serious about drinking problems. It contradicts the emphasis on preventing OUI. It contradicts the efforts to curb underage drinking. It implies that money comes first. Allowing the option of alcohol and not tobacco products implies that alcohol is less of a health risk than tobacco.

In a series of articles by the *Maine Sunday Telegram* and the *Portland Press Herald*, they outline the issue of alcohol and its effects on Maine. What really caught my interest was the articles on minors and alcohol. Figures compiled in 1997 by the Maine Office of Substance Abuse showed that the young binge drink. That is consume at least five drinks in a row more than kids throughout the Northeast and often the rest of the country. When asked, 27 percent of Maine 10<sup>th</sup> graders said they had binged in the past two weeks compared to 22 percent of other 10<sup>th</sup> graders in New England. In the 12<sup>th</sup> grade, 35 percent of Maine kids had binged in the past two weeks compared to 31 percent in the Northeast and 30 percent elsewhere in the country. These statistics are startling to say the least. This is why I firmly believe that any means to restrict or firmly control the access of alcohol by miners should be taken.

I feel that by allowing broadcasting stations to auction alcoholic beverages, even with gift certificates, sends the wrong message, especially to our youth. We should value the health and well being of all Mainers, even if that means a cut to somebody's profit margin. I ask you to reject the pending motion. Mr. Speaker, when the vote is taken, I request the yeas and nays.

Representative AHEARNE of Madawaska **REQUESTED** a roll call on the motion to **ACCEPT** the Majority **OUGHT NOT TO PASS** Report.

More than one-fifth of the members present expressed a desire for a roll call which was ordered.

The SPEAKER: The Chair recognizes the Representative from Bath, Representative Mayo.

Representative **MAYO**: Mr. Speaker, Men and Women of the House. I, too, rise to urge that this motion be defeated. I listened to the debate on the Legal and Veterans Affairs Committee when it came up. It bothers me that we are allowing a state supported entity to advertise even if it is after 10 p.m., beer and wine. The total take for this part of their auction, ladies and gentlemen, is slightly in excess of \$1,400 on an auction that takes in in excess of \$100,000. Really, how important is it for the Maine Public Broadcasting to need this income? I urge you to follow my light and that of Representative Ahearne and others who feel that it is about time that Maine Public Broadcasting no longer be allowed to advertise beer and wine at any time during their public auction. Thank you.

The SPEAKER: The Chair recognizes the Representative from Eliot, Representative Wheeler.

Representative **WHEELER**: Mr. Speaker, Men and Women of the House. I find myself in a difficult situation rising in opposition to my good friend from Madawaska, Representative Ahearne. I rise today in support of this legislation, the Majority Ought Not to Pass Report. I represent a winery in York who does donate to the public broadcasting systems from time to time. It uses this as a form of advertising for his business. He has a very small winery. He doesn't get a lot of chances to advertise throughout the State of Maine because of the laws the way they are. With this, it is a chance for him to get his name out. We regulate small businesses enough around here. By not allowing him to auction off wine on public broadcasting stations, it is just another regulation that will hurt his small business.

During the public hearing when the commissioner was asked if he had any problems or complaints about this, he said, "No. Everything is working just fine the way it is going." Let's leave it the way it is and support the pending motion, the Majority Ought Not to Pass. Thank you.

Representative LINDAHL of Northport **REQUESTED** that the Clerk **READ** the Committee Report.

The Clerk READ the Committee Report in its entirety.

The SPEAKER: The Chair recognizes the Representative from Cumberland, Representative McKenney.

Representative **MCKENNEY**: Mr. Speaker, Men and Women of the House. Let my crystallize this issue for you, if I could. This is not about whether you like alcohol or dislike alcohol. It is also not about public TV. What it is about is the consistent state enforcement policy regarding alcohol. Many of you are parents and I would dare say that if you don't have a consistent enforcement policy in your home, your children will let you know about it. There is no other entity in this state that is allowed to auction off alcohol to the highest bidder from an unlicensed facility. A vote for this is a vote for consistent alcohol policy. I urge you to follow Representative Ahearne's light. Thank you.

The SPEAKER: The Chair recognizes the Representative from Augusta, Representative O'Brien.

Representative **O'BRIEN**: Mr. Speaker, Ladies and Gentlemen of the House. I, too, rise today to ask you to oppose the Majority Report. I was on the commission. We just received something on our desks this morning from the Maine Association of Substance Abuse Programs outlining the legislation that will be coming to us during this session as a result of the report of the Task Force on Substance Abuse. I was a member of that task force. We, as a result of the aforementioned Portland Press Herald articles on alcohol and alcohol abuse in Maine, we have found this to be an enormous, enormous problem. As you recall, those of you who were here before recall this was a long, long debate last time. I spoke on it. I was chided for my love of public TV and the public auctions, but we won't get into that. To me, it is a matter strictly of \$1,500 coming from alcohol sales on a state subsidized entity. To me, it is strictly hypocrisy. Thank you.

The SPEAKER: The Chair recognizes the Representative from Crystal, Representative Joy.

Representative **JOY**: Mr. Speaker, Ladies and Gentlemen of the House. I, too, urge you to support the good Representative from Madawaska, Representative Ahearne, and his position on this. I think it is sending a very inconsistent message about advertising alcohol and alcoholic beverages on television. We have some very strong laws in that regard. To allow a public broadcasting station the ability to advertise for a small brewery is really inconsistent. I urge you to follow the good Representative from Madawaska's light. Thank you.

The SPEAKER: The Chair recognizes the Representative from Sanford, Representative Tuttle.

Representative **TUTTLE**: Mr. Speaker, Men and Women of the House. Briefly, at the public hearing we received a memo from Maine Public Broadcasting that I would like to share with you.

Last year when speaking on behalf of a bill now being considered for repeal, we spoke about Maine Public Broadcasting's need to maximize its private fundraising by

seeking support from the entire Maine community. We were also assured that Maine Public Broadcasting Board of Trustees would consider this guestion carefully, which they did at the two meetings. Accepting a written policy on the subject at their January session. This policy is conservative and more restrictive than the legislation, Mr. Speaker. Prior to the last auction, although we have built relationships with breweries and wineries and wholesalers, they have been limited in their ability to contribute in the same manner as the thousands of other businesses that participate in the auction each year. Although the numbers are not large, they are not insignificant. For the 1998 auction these 30 items, as have been mentioned, are worth approximately \$1,800. From about 10 different donors, Maine Public Broadcasting received a total, as Representative Mayo told you, I believe the figure was \$1,423 for bid for sale.

As specified in the policy, they do not sell merchandise, but only certificates for the purchase, as I mentioned before. It requires an individual who is 21 years of age to produce identification twice. These certificates may only be auctioned on air after 10 p.m.

In closing, they feel the sale of these certificates is a valid way for them, as a business, to support public broadcasting as they do for other public TV auctions. As I mentioned before, we did receive a number of communications from a number of small businesses from around the state who feel that this marketing tool is very important. These businesses may be small, but every little bit helps for those businesses. It is for that reason that I would encourage you to support the Majority Ought Not to Pass Report. Thank you Mr. Speaker.

The SPEAKER: The Chair recognizes the Representative from Hampden, Representative Plowman.

Representative **PLOWMAN**: Mr. Speaker, Men and Women of the House. The latest revenue forecast dated December 1998 projects that the State of Maine will, by fiscal year end 1999, collect \$20,530,129 from the sale of liquor. The mixed messages that are already involved in the sale of liquor, I don't see until we solve that problem, why we shouldn't allow Maine broadcasting to make \$1,400 a year. The State of Maine is already promoting liquor. We are already sending mixed messages. We have a big problem to fix. I think we need to leave this to a time when we aren't able to be hypocrites about it. Thank you. I ask you to support the pending motion.

The SPEAKER: The Chair recognizes the Representative from Wayne, Representative McKee.

Representative **MCKEE**: Mr. Speaker, Men and Women of the House. We have been down this road before. I stand in opposition to the Majority Ought Not to Pass Report and urge that we move on to accept the Minority Report to prohibit the auction of alcohol by public broadcasting stations. I realize the need for public broadcasting to raise money. Indeed they have already begun limited advertising on such shows as Teletubbies, Sesame Street and other of our favorite shows.

During the auction, it is advertising as the good Representative stated before. I do not think that it sends the proper message. I am a mother of four children. For at least 15 years, this is the only channel that my children were allowed to watch. It is very important to me that we remain steadfast in the message that we, as the legislative body, send to a public broadcasting company. In our body before, one of our states leading importers of wine products stood here also to oppose such auctioning. It is advertising. I urge that we move on to accept the Minority Report and continue to send the message that we always have to public broadcasting, regardless of what time it is, we do not want to see alcohol advertised on public television. Thank you.

The SPEAKER: The Chair recognizes the Representative from Eliot, Representative Wheeler.

Representative **WHEELER**: Mr. Speaker, Men and Women of the House. Just to clear up a little confusion on this matter. The sale of these certificates cannot take place until after 10 p.m. at night. Most children are in bed before 10 p.m. This is in the Maine Public Broadcasting policy regarding donation on related alcohol. Thank you.

The SPEAKER: A roll call has been ordered. The pending question before the House is acceptance of the Majority Ought Not to Pass Report. All those in favor will vote yes, those opposed will vote no.
