SENATE PAPERS

The following Joint Resolution: (S.P. 650)

JOINT RESOLUTION MEMORIALIZING THE CONGRESS OF THE UNITED STATES TO INCREASE INTERSTATE TRUCK WEIGHT LIMITS

WE, your Memorialists, the Members of the One Hundred and Nineteenth Legislature of the State of Maine, now assembled in the First Regular Session, most respectfully present and petition the President of the United States and the United States Congress, as follows:

WHEREAS, the issue of interstate truck weight limits is of great concern for a number of reasons; and

WHEREAS, economic development interests in northern and central Maine are increasingly frustrated at their loss of transportation productivity due to the disparity in weight limits between the state highways and the Interstate Highway System; and

WHEREAS, this disparity has resulted in the diversion of heavy through trucks from the Interstate Highway System to more congested State highways, raising safety concerns in the Legislature and in municipal groups. A fatal crash on Route 9 in Dixmont and a fuel truck crash in Augusta have further raised concern; and

.WHEREAS, an increase in the interstate gross vehicle weight limit for 6-axle combination vehicles, from 80,000 pounds to between 90,000 and 95,000 pounds, is supported by an engineering review that was recently conducted by the Maine Department of Transportation; and

WHEREAS, a recommendation to increase interstate weight limits is also supported by the Maine State Police, the Maine Department of Economic and Community Development, the Maine Turnpike Authority, the Maine Better Transportation Association, the Maine Chamber and Business Alliance and the Maine Motor Transportation Association: now, therefore, be it

RESOLVED: That We, your Memorialists, request that the President of the United States and the United States Congress amend federal law to increase the interstate gross vehicle weight limits for 6-axle combination vehicles to between 90,000 and 95,000 pounds and maintain the current freeze on longer combination vehicles; and be it further

RESOLVED: That suitable copies of this resolution, duly authenticated by the Secretary of State, be transmitted to the Honorable William J. Clinton, President of the United States; the President of the United States Senate; the Speaker of the House of Representatives of the United States and each member of the Maine Congressional Delegation.

WE, your Memorialists, the Members of the One Hundred and Nineteenth Legislature of the State of Maine, now assembled in the First Regular Session, most respectfully present and petition the Secretary of the Navy, the Honorable Richard Danzig and the Secretary of Defense, the Honorable William Cohen as follows:

WHEREAS, the Bath Iron Works Corporation is currently developing and constructing the United States Navy's newest surface combatant, along with the Avondale Shipyard in Louisiana; and

WHEREAS, the 3rd ship to be constructed and launched at the Bath Iron Works Corporation facility in the City of Bath, Maine is identified as LPD 19; and

WHEREAS, the Bath Iron Works Corporation is now in its 115th year of constructing and launching superior quality ships on the shores of the Kennebec River in the City of Bath; and

WHEREAS, the City of Bath has an international reputation for its shipbuilding heritage and shipbuilding activity, which is exemplary of the maritime legacy of the State of Maine; and

WHEREAS, the maritime heritage of the City of Bath is intrinsically linked to the history of the city itself because the success and growth of the city is so closely intertwined with the shipbuilding industry; and

WHEREAS, it would be entirely appropriate and fitting to honor the maritime history and heritage of the City of Bath by naming LPD 19 the U.S.S. Bath; now, therefore, be it

RESOLVED: That We, your Memorialists, request that LPD 19 be named the U.S.S. Bath after the City of Bath, Maine, where it was built, in order to properly honor that city for its role in the shipbuilding industry of the State and for its role in the shipbuilding history of our great seafaring nation; and be it further

RESOLVED: That suitable copies of this resolution, duly authenticated by the Secretary of State, be transmitted to the Honorable Richard Danzig, Secretary of the Navy; to the Honorable William Cohen, Secretary of Defense and to each Member of the Maine Congressional Delegation.

Representative MAYO: Mr. Speaker, Ladies and Gentlemen of the House. The City of Bath has been building ships for over 350 years and, to date, we have never had a ship named after the City of Bath. That is the reason for this Joint Resolution memorializing the Secretary of the Navy and the Secretary of Defense. I would also remind you that the first wooden ship built in this country in 1607, in those days what we now consider to be a part of the lower end of the City of Bath. We have had a proud tradition of shipbuilding. I am honored to be involved in sending this forward to Washington. Thank you.

Representative BERRY: Mr. Speaker, Men and Women of the House. In one's lifetime many of us have the opportunity to walk with individuals and to work with individuals who have great impact upon all of us. Sted Hills was one of those people. He was appointed to the Naval Academy in June 1940 and his class was accelerated so that he could graduate in 1943. The reason for the acceleration, of course, is very clear to all of us, war. At that time he was assigned to the Battleship Arkansas and conveyed US troops and took part in the landing and the Normandy invasion. He returned to the United States aboard the Arkansas and was ordered to flight training school. He was designated in 1945 a Naval Aviator. He joined VHS1, the Air Sea Rescue Squadron based in Saipan. The next went to VP27, patrol squadron based in Hawaii and his next tour was as Professor of Naval Science and Tactics Tufts College in Boston, Massachusetts. At the start of the Korean War he was ordered to Fleet Air Wing Six in the Pacific. He was next assigned to the Anti-submarine Warfare School in San Diego as officer in charge of that school and of the Ground School at Saufley Field in Pensacola. He transitioned to the helicopter flight training and served in the helicopter squadrons three, nine and ten and finally returned to Squadron Nine as its commanding officer. After a tour of duty as its commander, his last two tours were in

Washington at the Naval Department. He retired in September, 1969.

He returned to serve the people of the State of Maine. That service involved, as mentioned before, serving as Mayor of Belfast, working as an active member in moving back to his home in Searsport. At that point working hard for the development of the dock system at Searsport. This person was a great friend and a wonderful individual serving both the Navy and this state very, very adequately. Thank you ladies and gentlemen.

MATTER PENDING RULING

Bill "An Act to Require Legislative Approval to Lease Land to the Federal Government"

(H.P. 275) (L.D. 383)

TABLED - March 10, 1999 by Speaker ROWE of Portland. PENDING - **RULING OF THE CHAIR**.

The SPEAKER: The Chair has considered the question of the Representative from Naples, Representative Thompson, as to the propriety of L.D. 383 under Rule 107 of the House Rules

L.D. 383 attempts to require the approval of two-thirds of the members of the House in order for the State to lease public lands to the federal government.

House Rule 107 states:

A member may question the appropriateness of a bill that attempts to establish proceedings of the House in statute. Such legislation may be ruled not properly before the House by the Speaker.

The Chair finds that L.D. 383 attempts to establish the proceedings of the House in statute and is thus not properly before the House.

House Rule 107 is based upon the Maine Constitution, Article IV, Part Third, Section 4, which reads in part, "Each House may determine the rules of its proceedings." As the Chair has said before, the working principle upon which the Chair must rely is provided by reading the constitutional phrase, "Each House may determine the rules of its own proceedings," in conjunction with the House's parliamentary manual, Mason's Manual of Legislative Procedure (1989 ed.) (hereinafter Mason's), at section 3, part 4. The principle may fairly be summarized:

Each house may determine:

- the rules of the proceedings of the body in ordinary legislative matters; and
- B. the propriety and effect of any action taken by the body in:
 - 1. the exercise of any power;
 - 2. the transaction of any business; or
 - 3. the performance of any duty conferred upon it by the constitution.

The rules of the proceedings of the House in ordinary legislative matters are implicated by L.D. 383 to the extent that it would require a two-thirds vote of approval from the House as a prerequisite for the leasing of State lands to the federal government.

Moreover, the House cannot by its own act require a twothirds vote to take an action when the Maine Constitution requires only a majority vote. <u>Mason's</u> discusses two-thirds votes in section 512. The parts of section 512 relevant to this ruling are parts 6 and 10:

- 6. A deliberative body cannot by its own act or rule require a two-thirds vote to take any action where the constitution or controlling authority requires only a majority vote. To require a two-thirds vote, for example, to take any action would be to give to any number more than one-third of the members the power to defeat the action and amount to a delegation of the powers of the body to a minority.
- 10. Since it is a fundamental principle of parliamentary law that the deliberative will and judgment of the majority shall prevail in the decision of such questions as can properly come before the legislative body, the requirement of a two-thirds vote is exceptional. Such a vote is not required except in the particular cases in which it is prescribed by a controlling authority.

See also Mason's §51(6)

Mason's also provides at section 50, under the heading "Majority Control":

6. The power that establishes a public body can require the vote of more than a majority to take certain actions, but unless more than a majority vote is clearly required a majority vote can take any action which the body has the power to take.

The House is established by the Maine Constitution and, in its internal affairs, is constrained only by the Maine Constitution. Rules of the House, 119th Legislature preamble; See also Mason's §19(3) and §22(3). It is instructive to note that the Maine Constitution does require two-thirds approval for certain actions. For example, the Constitution requires two-thirds approval: to pass emergency measures, Me. Const. art. IV, pt. 3, §16; to impose state mandates on municipalities, Me. Const. art. IX, §21; to propose a general obligation bond issue question to the voters, Me. Const. art. IX, §14; to propose a constitutional amendment to the voters, Me. Const. art. X, §4; to call for a constitutional convention, Me. Const. art. IV, pt. 3, §15; to enact a reapportionment plan, Me. Const. art. IV, pt. 1, §3; and to override the governor's veto, Me. Const. art. IV, pt. 3, §2; among others.

The Chair is aware that the Maine Constitution does require at Article 9, Section 23:

State park land, public lots or other real estate held by the State for conservation or recreation purposes and designated by legislation implementing this section may not be reduced or its uses substantially altered except on the vote of two-thirds of all the members elected to each House. . .

The propriety of L.D. 383 under the Maine Constitution depends on the meaning of the phrase "[State land]. . . may not be reduced." Clearly, the State's interest in land is reduced when it grants leasehold interests to the federal government, though the size of the land is not reduced. The Secretary of State published a pamphlet entitled Maine Citizen's Guide to the

Referendum Election for November 2, 1993, the election at which the people of Maine adopted this Constitutional amendment. The official pamphlet includes a section called "Intent and Content" for the questions. It reads, in relevant part:

This proposed constitutional amendment would enable the Legislature to specify that certain parcels of land owned by the State for conservation or recreation purposes may not be reduced *in size* or substantially altered as to use without the prior approval of two-thirds of the members of each House.

Therefore, the Chair finds that the State transfer of leases falls outside the Constitutional provision requiring two-thirds votes to transfer other interests in land. To summarize, since L.D. 383 proposes to change from a majority to a supermajority the requisite vote necessary for the House to take an action, it attempts to establish the proceedings of the House in statute. It is therefore the ruling of the Chair that L.D. 383 is not properly before the House.

Subsequently, the Chair **RULED** the Bill was not properly before the body pursuant to House Rule 107.
