The following Joint Order:

H.P. 1183

WHEREAS, the Legislature funds that the Governor Baxter School for the Deaf is a unique institution in Maine, a state-funded school for the deaf and hard-of-hearing, with a statewide obligation and role to help local schools educate deaf and hard-of-hearing children and a critical role as the centerpiece of deaf culture in the State: and

WHEREAS, the Legislature finds that to take best advantage of its unique features, the Governor Baxter School for the Deaf needs a governance system and management powers that reflect the school's unique status; and

WHEREAS, the Committee to Review the Governance Structure of the Governor Baxter School for the Deaf concluded that the current governance system of the Governor Baxter School for the Deaf does not fit the Governor Baxter School for the Deaf School Board's need to effectively and efficiently govern the school and further recommended that a new governance system must be designed to give the school greater autonomy in managing its affairs; and

WHEREAS, the Legislature finds that there is an urgent need for a task force to redesign the governance system of the Governor Baxter School for the Deaf; now, therefore, be it

ORDERED, the Senate concurring, that the Task Force to Redesign the Governance System of the Governor Baxter School for the Deaf is established as follows.

- 1. Task force established. The Task Force to Redesign the Governance System of the Governor Baxter School for the Deaf, referred to in this order as the "task force," is established.
- 2. Task force membership. The task force consists of 11 members as follows.
- A. The President of the Senate shall appoint 3 members from the Senate, including one member who serves on the Joint Standing Committee on Education and Cultural Affairs, one member who serves on the Joint Standing Committee on Health and Human Services and one member who serves on the Joint Standing Committee on Agriculture, Conservation and Forestry.
- B. The Speaker of the House of Representatives shall appoint 3 members from the House of Representatives, including one member who serves on the Joint Standing Committee on Education and Cultural Affairs, one member who serves on the Joint Standing Committee on Health and Human Services and one member who serves on the Joint Standing Committee on Agriculture, Conservation and Forestry.
- C. The President of the Senate shall appoint 2 members from the Committee to Review the Governance Structure of the Governor Baxter School for the Deaf who represent the deaf community.

- D. The Speaker of the House shall appoint one member from the Committee to Review the Governance Structure of the Governor Baxter School for the Deaf who represents an interested party other than a state agency or the deaf community.
- E. The Commissioner of Education or the commissioner's designee must be a member of the task force.
- F. One of the school board co-chairs of the Governor Baxter School for the Deaf or the school board co-chairs' designee must be a member of the task force.
- 3. Chairs. The first Senate member named is the Senate chair and the first House member named is the House chair.
- 4. Appointments; convening task force. All appointments must be made no later than 30 days following the effective date of this order. The appointing authorities shall notify the Executive Director of the Legislative Council upon making their appointments. When the appointment of all members is complete, the chairs of the task force shall call and convene the first meeting of the task force no later than July 1, 1999.
- 5. Duties. The task force shall design a new governance system for the Governor Baxter School for the Deaf and shall prepare a plan that will help the school develop the capacity to implement a system that is more autonomous from the State than the current governance system. In conducting this review, the task force shall:
- A. Request, as appropriate, the assistance of the Department of Education, the Department of Administrative and Financial Services, the Bureau of Parks and Lands within the Department of Conservation, the Department of the Attorney General, the School Board of the Governor Baxter School for the Deaf, the College of Education within the University of Southern Maine and other appropriate state agencies and educational institutions;
- B. Invite the participation of experts and interested parties;
- C. Hire an impartial consultant to help the school, the Department of Education and other state agencies to redefine their roles and shift responsibilities;
- D. Define the basic structure of the new governance system by addressing what it means for the school to have autonomy from State Government and defining the respective roles and responsibilities of the school board, school administrators and state agencies;
- E. Identify the resources needed for the school board to develop the capacity to perform functions that the school would take over from state agencies, such as personnel and budget management functions. If the School Board of the Governor Baxter School for the Deaf is to bargain directly with employee unions and is to address employee relations issues such as grievance proceedings, the school must build the capacity to undertake these functions as well. This may involve securing additional staff for the school to strengthen its personnel management capacity;

- F. Develop a plan to address the recommendations from the Department of Education's basic school approval review conducted in December 1998 and conduct any other necessary reviews, such as a comprehensive review of the residential program at the school. A plan to address the results of these reviews should be developed and factored into the transition planning for the new governance system;
- G. Consult with Governor Baxter School for the Deaf employees and their representatives so that their interests can be taken into account in designing a new governance system. Employees have an interest in the potential for changes in salary, benefits and working conditions. The task force must take into account existing employee rights under union contracts or state law that may impact the timing or scope of change that may occur at the school:
- H. Develop strategies for properly managing state-owned facilities and the natural resources of the island. The deed from Governor Baxter granting Mackworth Island to the State requires the island to be used and managed in a certain way. The strategies must address what role, if any, state agencies play in managing school property and Mackworth Island, what improvements are needed in the school's physical plant, who should make the improvements and whether a state agency should continue to be involved in managing the island or only in overseeing the school's compliance;
- I. Establish benchmarks to measure the school's progress toward a more autonomous governance system and require that the consultant, the school and the Department of Education make progress reports to interested parties, including the Joint Standing Committee on Education and Cultural Affairs; and
- J. Draft legislation to create the new governance system in Maine law. The redesigned governance system must be implemented by July 1, 2000. The legislation must be submitted to the Second Regular Session of the 119th Legislature by December 3, 1999.
- 6. Staff assistance; interpreter services; consultant. The task force may request staffing assistance from the Legislative Council. The task force, with the approval of the Legislative Council, may contract with interpreter services to provide appropriate interpreting services for the deaf and hard-of-hearing and shall contract with a consultant to provide professional services for reviewing and analyzing the status of the governance system of the Governor Baxter School for the Deaf.
- 7. Expenses. Legislative members of the task force are entitled to receive the legislative per diem and reimbursement of necessary expenses for their attendance at authorized meetings of the task force. Public members not otherwise compensated by their employers or other entities whom they represent are entitled to receive reimbursement of necessary expenses and a per diem equal to the legislative per diem for their attendance at authorized meetings of the task force.
- 8. Report. No later than December 3, 1999, the task force shall submit a report that must include its findings, together with any recommendations for legislation to the Joint Standing Committee on Education and Cultural Affairs or for supplemental budget appropriations to the Joint Standing Committee on

Appropriations and Financial Affairs. The Joint Standing Committee on Education and Cultural Affairs is authorized to report out any legislation during the Second Regular Session of the 119th Legislature concerning the findings and recommendations of the task force. If the task force requires an extension of the reporting deadline, it may apply to the Legislative Council, which may grant the extension.

9. Task force budget. The chairs of the task force, with assistance from the task force staff, shall administer the task force's budget. Within 10 days after its first meeting, the task force shall present a work plan and proposed budget to the Legislative Council for its approval. The task force may not incur expenses that would result in the task force exceeding its approved budget.

Upon request from the task force, the Executive Director of the Legislative Council or the Executive Director's designee shall provide the chairs and staff with a status report on the task force budget, expenditures incurred and paid and available funds.

Senate at Ease.

Senate called to order by the President.

Senator **AMERO** of Cumberland was granted unanimous consent to address the Senate on the Record.

Senator AMERO: Thank you, Mr. President, ladies and gentlemen of the Senate. It's a great deal of pleasure to receive today, the fifth year in a row, Maine's Kids Count book. I always like to look at what's going well in the State of Maine with our kids. There are a lot of good things happening in the State of Maine that we need to point out and I think we should be proud of. First of all, early childhood indicators - we have many scores that are very high. Our infant mortality rate continues to decrease and is the lowest in the United States. That is a real achievement for the State of Maine. The percentage of live births in Maine for which prenatal care began in the first trimester continues to increase and remains one of the highest. Tied only with Massachusetts, Maine has the highest immunization rate among 2 year old children. The percent of low birth weight infants born in Maine continues to decline and remains less than the National rate. I'm pleased to say that school based health centers in Maine are expanding and that we now have 16 of these health centers based in schools across the state of Maine providing health services to many young people who would otherwise not have access to such care. We all know that Maine's high school graduation is one of the highest in the whole country. In fact, our drop out rate is the sixth lowest, another way of looking at that. But another figure that we're all concerned about is the fact that our high school graduates do not go on to higher education in the numbers that high school graduates do in

the rest of the country. We, as the Legislature, I think are taking many actions that will help to encourage more students, more of our graduates, to go onto higher ed. I'm particularly excited about the concept of a community college system in the state of Maine that will make access to higher education more affordable for Maine students. Another program providing grants and low interest loans to students also will provide such encouragement. Another factor that I think the Legislature can help take a little claim for providing some impetus for better health care coverage for children is in the number of children who were not covered back in 1997, it was an astronomically high number that we read about and that was over 30,000 of our children at that time who were not insured. Due to action taken by the Legislature and also by the Department of Health to try to make more families aware of the fact that they could receive Medicaid coverage for their children. We have reached out to over 5,000 children who are now receiving health care insurance and we know that there are another 10,000 children who are eligible who still need to be signed up. So we're making progress in that regard and I'm pleased that in the state of Maine we are making our children a priority and I know that through this legislative session we'll be passing more legislation which will, I'm sure, show up in future Kids Count data books as moving in a positive way in this state. Thank you, Mr. President.

Senator LONGLEY of Waldo was granted unanimous consent to address the Senate on the Record.

Senator LONGLEY: Thank you, Mr. President. Colleagues in the Senate, I'd like to add to what the good Senator from Cumberland just said and specifically focus on Cub Care, which in addition to the expanded Medicaid program, is a program that reaches families up to 185% of poverty which is our middle class in Maine. Basically, as you talk to your constituents, if you could remind them that it's compliments of our entire Federal delegation, Republicans and Democrats in this Chamber and in the other Chamber and signed by the Governor, we have this Cub Care program and compliments of work with the Department of Human Services it's a simple, one page application and families can fill it out and get their kids to a doctor and we're all better off in the end. Thank you.

Senator **BENNETT** of Oxford was granted unanimous consent to address the Senate on the Record.

Senator BENNETT: Thank you, Mr. President. Fellow members of the Senate, I too want to add my voice to those before me who have talked about some of the good news in this book. Too often in this building we focus on the bad things. It's sort of the nature of our undertakings here that we try to deal with problems and solve them. One that I noted in this book in particular was the question of access to dental care, which, as we know, has plagued the people of the state and kids around the state for some time. It's reared it's head through various public policy issues that have come before us in the Legislature. The two primary roadblocks to dental care for children are money and availability. Low income families with children are often unable to pay for dental care at the time services are delivered. Access is also a problem for children covered by Medicaid. It is estimated that no more than 1/3 of the children accessed preventive oral health services in 1997. There are over 400 general practice dentists and orthodontists practicing in Maine but less than 275 provided preventive services to children with Medicaid coverage

in 1997. Reasons for lack of participation by dentists in the State Medicaid Program include various social, economic and administrative issues that frustrate not only the dentist, of course, but also the families covered by Medicaid. This is particularly a problem in rural Maine where dentists are even rarer to be found. One key in this is the problem of reimbursement rates. I just want to remind this Legislature that within the last two years we've taken some positive steps in that area increasing the reimbursement rates so that kids will have more access to dentists because more dentists will be willing to make the sacrifices necessary to serve Medicaid kids. I think that once in a while we ought to step back and use this book that comes before us every year as a yardstick for our own achievements and here's one area where I think that we've done something pro-active, done something positive. So my message today is simple. Books like these come across our desks all the time, we get reports and studies benchmarking our progress in various areas. Too often those books are just shelved and gather dust somewhere in an office. I just want to say thank you to the people who collaborate to put this information together. It's very useful and at least in one area, dental services, this Legislature is recognizing a problem and dealing with it. We have a long way to go but every step counts and I want to thank the Senate and thank the Legislature for attending to this particular issue. Thank

Senator CATHCART of Penobscot was granted unanimous consent to address the Senate on the Record.

Senator CATHCART: Thank you, Mr. President. I too want to recognize the importance of having healthy children for Maine's 21st century and to congratulate the Maine Children's Alliance on this 1999 Kids Count Data Book. The data book highlights the impact that child abuse can have on early brain development. What can we do to protect our children? The need for stronger child protective services must be addressed. In addition, Maine needs to focus resources at the front end to prevent child abuse and neglect by supporting and educating parents to better meet the challenging task of raising their children. Early intervention programs that help educate and support families in their child rearing responsibilities starting even before a child is born have proven highly effective. Working to improve the economic well-being of families with small children is also vital. Thank you, Mr. President.

- 1. Task force established. The Task Force to Study the Implementation of Alternative Programs and Interventions for Violent and Chronically Disruptive Students, referred to in this order as the "task force," is established.
- 2. Membership. The task force consists of 7 members appointed jointly by the chairs of the Joint Standing Committee on Education and Cultural Affairs after consultation with members of the committee. At least 2 of the appointees must be members of the public.
- 3. Chair. The chairs of the committee shall name a chair for the task force at the time they make the original appointments.
- 4. Appointments; convening task force. All appointments must be made no later than 30 days following the effective date of this order. The appointing authorities shall notify the Executive Director of the Legislative Council upon making their appointments. When the appointment of all members is complete, the chair of the task force shall call and convene the first meeting of the task force no later than June 15, 1999.
 - 5. Duties. The task force shall:
- A. Study the availability of a continuum of interventions for violent and chronically disruptive students, including the

existence of positive behavioral supports in classrooms, the availability of alternative educational settings for disruptive students and alternative community placements; and

- B. Recommend a plan and strategies to develop an appropriate continuum of interventions.
- Staff assistance. Upon approval of the Legislative Council, the Office of Policy and Legal Analysis shall provide necessary staffing services to the task force.
- 7. Compensation. Members of the task force are entitled to receive the legislative per diem, as defined in the Maine Revised Statutes, Title 3, section 2 and reimbursement for travel and other necessary expenses for attendance at meetings of the task force.
- 8. Report. The task force shall submit a report on the plan developed along with any recommended legislation to the Joint Standing Committee on Education and Cultural Affairs no later than December 15, 1999. The committee has authority to introduce legislation during the Second Regular Session of the 119th Legislature. If the task force requires an extension of time to make its report, it may apply to the Legislative Council, which may grant the extension.
- 9. Task force budget. The chair of the task force, with assistance from the task force staff, shall administer the task force's budget. Within 10 days after its first meeting, the task force shall present a work plan and proposed budget to the Legislative Council for its approval. The task force may not incur expenses that would result in the task force exceeding its approved budget.

Upon request from the task force, the Executive Director of the Legislative Council or the executive director's designee shall provide the task force chair and staff with a status report on the study budget, expenditures incurred and paid and available funds.

1. Task force established. The Task Force on Transportation Access, Air Pollution Reduction and Family Self-sufficiency, referred to in this order as the "task force," is established.

- 2. Membership. The task force consists of the following 8 members:
- A. One Senator, who is a member of the Joint Standing Committee on Health and Human Services, appointed by the President of the Senate;
- B. One Representative, who is a member of the Joint Standing Committee on Health and Human Services, appointed by the Speaker of the House of Representatives;
- C. One Senator, who is a member of the Joint Standing Committee on Natural Resources, appointed by the President of the Senate:
- D. One Representative, who is a member of the Joint Standing Committee on Natural Resources, appointed by the Speaker of the House of Representatives;
- E. One Senator, who is a member of the Joint Standing Committee on Transportation, appointed by the President of the Senate;
- F. One Representative, who is a member of the Joint Standing Committee on Transportation, appointed by the Speaker of the House of Representatives; and
- G. One Senator and one Representative, appointed respectively by the President of the Senate and the Speaker of the House of Representatives.
- 3. Chair and officers. The task force shall choose one of its members to serve as chair. The task force may select other officers and designate their duties.
- 4. Appointments; meetings. All appointments must be made no later than 30 days following the effective date of this order. The first meeting of the task force must convene no later than October 1, 1999. The task force may hold up to 6 meetings.
- 5. Duties. The task force shall study the feasibility of establishing a program to remove older polluting vehicles from the roads by providing newer and less polluting used vehicles through purchase or lease. The task force shall examine how such a program could complement the State's Temporary Assistance for Needy Families program and the State's so-called welfare-to-work program by making reliable transportation accessible to working people who qualify for Temporary Assistance for Needy Families. The task force shall examine market incentives, including tax incentives and emission trading, to encourage businesses, rental car companies and others to donate vehicles to such a program. The task force shall identify funding sources and management strategies. It must seek the input of the Department of Transportation, the Department of Economic and Community Development, the Department of Human Services, the Department of Environmental Protection, the Maine Technical College System, the Temporary Assistance for Needy Families Advisory Council and representatives of auto dealers, public health agencies, environmental organizations, women's organizations, low-income families and business organizations.
