Joint Orders

The following Joint Order: H.P. 1457

ORDERED, the Senate concurring, that the Joint Select Committee to Ensure Accountability in the Legislature is established as follows.

1. Committee established. The Joint Select Committee to Ensure Accountability in the Legislature, referred to in this order as the "committee," is established.

2. Membership. The committee consists of 5 members appointed as follows.

A. The President of the Senate shall appoint 2 Senators who serve on the Joint Standing Committee on State and Local Government, at least one of whom is a member of the party with the 2nd highest number of Senators.

B. The Speaker of the House of Representatives shall appoint 3 members from the House who serve on the Joint Standing Committee on State and Local Government, at least one of whom is a member of the party with the 2nd highest number of members in the House.

3. Chairs. The first Senate member named is the Senate chair and the first House member named is the House chair.

4. Appointments; convening committee. All appointments must be made no later than 30 days following passage of this order. The appointing authorities shall notify the Executive Director of the Legislative Council upon making their appointments. When the appointment of all members is complete, the chairs of the committee shall call and convene the first meeting of the committee no later than June 1, 1999.

5. Duties. The committee shall examine methods to ensure accountability in the Legislature, including but not limited to:

A. The mandatory use of roll calls for votes of final enactment in the Senate and the House of Representatives; and

B. Term limits for officers in the Senate, including the Secretary of the Senate and the Assistant Secretary of the Senate, and in the House, including the Clerk of the House and the Assistant Clerk of the House. 6. Staff assistance. Upon approval of the Legislative Council, the Office of Policy and Legal Analysis shall provide necessary staffing services to the committee.

7. Compensation. Members of the committee are entitled to receive the legislative per diem, as defined in the Maine Revised Statutes, Title 3, section 2, and reimbursement for travel and other necessary expenses for attendance at meetings of the committee.

8. Legislation. The committee shall submit a report along with any recommended legislation to the Joint Standing Committee on State and Local Government by January 7, 2000. Following receipt of the report, the Joint Standing Committee on State and Local Government may introduce legislation to the Second Regular Session of the 119th Legislature. If the committee requires an extension of time to make its report, it may apply to the Legislative Council, which may grant the extension.

9. Committee budget. The chairs of the committee, with assistance from the committee staff, shall administer the committee's budget. Within 10 days after its first meeting, the committee shall present a work plan and proposed budget to the Legislative Council for its approval. The committee may not incur expenses that would result in the committee's exceeding its approved budget.

Upon request from the committee, the Executive Director of the Legislative Council or the executive director's designee shall provide the committee chair and staff with a status report on the study budget, expenditures incurred and paid and available funds.

ORDERED, the Senate concurring, that the Task Force to Develop a Plan to Implement a Pilot Program for a Public Defender's Office is established as follows.

1. Task force established. The Task Force to Develop a Plan to Implement a Pilot Program for a Public Defender's Office, referred to in this order as the "task force," is established.

2. Task force membership. The task force consists of 5 members appointed as follows:

A. Two Senators appointed by the President of the Senate; and

B. Three members of the House of Representatives appointed by the Speaker of the House.

3. Chair. The first named Senate member is the Senate chair and the first named House member is the House chair.

4. Appointments; convening task force. All appointments must be made within 30 days of the enactment of this order. The appointing authorities shall notify the Executive Director of the Legislative Council upon making their appointments. The chairs shall call and convene the first meeting of the task force within 30 days from when the appointment of all members is complete.

5. Duties. The task force shall meet with court administrators, judges, criminal defense lawyers, Pine Tree Legal Assistance, the Maine Bar Association and other interested parties, gather information and study public defender programs of other jurisdictions in order to develop a plan to implement a pilot program for a public defender's office to be located in Cumberland County.

6. Expenses. Members of the task force are entitled to receive the legislative per diem and reimbursement for necessary expenses for their attendance at authorized meetings of the task force.

7. Report. By December 1, 1999, the task force shall submit its report, together with any necessary implementing legislation, to the Joint Standing Committee on Criminal Justice.

RESOLVED: That We, the Members of the One Hundred and Nineteenth Legislature now assembled in the First Regular Session, on behalf of the people we represent, commend the National Rifle Association for developing the Eddie Eagle Elementary Gun Safety Education Program and making it available for use in the communities of this State; and be it further

RESOLVED: That we encourage civic and community service organizations that are concerned about the safety and well-being of the children of this State to help provide funding for the implementation of the Eddie Eagle Elementary Gun Safety Education Program at the local level; and be it further

RESOLVED: That we encourage the Department of Education to promote the use of the Eddie Eagle Elementary Gun Safety Education Program in the public schools to help prevent accidents related to firearms that involve children; and be it further

JOINT RESOLUTION MEMORIALIZING THE PRESIDENT OF THE UNITED STATES AND THE UNITED STATES CONGRESS TO ALLOW THE STATES TO KEEP THEIR TOBACCO SETTLEMENT MONEY

WE, your Memorialists, the Members of the One Hundred and Nineteenth Legislature of the State of Maine now assembled in the First Regular Session, most respectfully present and petition the President of the United States and the United States Congress, as follows:

WHEREAS, the State of Maine settled its litigation against the tobacco industry on November 23, 1998; and

WHEREAS, the Federal Government, through the federal Health Care Financing Administration, has asserted that it is entitled to a significant share of the state settlement on the basis that it represents the federal share of Medicaid costs; and

WHEREAS, the Federal Government asserts that it is authorized and obligated, under the United States Social Security Act, to collect its share of any settlement funds attributable to Medicaid; and

WHEREAS, the state lawsuit was brought for violation of state law under state law theories, and the state lawsuit did not make any federal claims; and

WHEREAS, the State bore all the risk and expense in the litigation brought in State Court and settled without any assistance from the Federal Government; and WHEREAS, the State is entitled to all of the funds negotiated in the tobacco settlement agreement without any federal claim; now, therefore, be it

RESOLVED: That We, your Memorialists, request that the President of the United States and the United States Congress work together to support and sign legislation to allow the states to keep their tobacco settlement funds; and be it further

RESOLVED: That suitable copies of this resolution, duly authenticated by the Secretary of State, be transmitted to the Honorable William J. Clinton, President of the United States; the President of the United States Senate; the Speaker of the House of Representatives of the United States; and to each Member of the Maine Congressional Delegation.

THE PRESIDENT PRO TEM: The Chair recognizes the Senator from Penobscot, Senator Ruhlin.

Senator RUHLIN: Thank you Madam President. I'd like to point out some concerns that I have with this particular legislation that is presently before us. It's not on the pros or cons of milk pricing. I feel that the Committee of jurisdiction has the expertise there and I don't question their expertise. Where I do take great concern is how there is a process under which we work in this building and that is the separation of powers of the Legislative branch and the Judicial branch. Presently there is a court case pending involving this issue in the State of Maine and I have always had great concern. I know in the Taxation Committee, we as a routine, do not recommend that pieces of legislation come out an Ought to Pass Report on cases pending. That's because we feel that the Judicial branch should proceed to their conclusion without interference, or the potential of interference, or the perception of interference from the Legislative branch. In this case I feel passage of this legislation at this point in time would in fact at least give the perception of interference from this Legislative branch of government to the Judicial branch of government. Nope, no concerns after the Judiciary has made their decision, they've taken corrective action, or taken action at some future time. But with a case pending I feel it's unwise utilization of the process to go forward with a Bill at this time, preempting any potential judicial decision. I will be therefore voting against Enactment.

THE PRESIDENT PRO TEM: The Chair recognizes the Senator from Lincoln, Senator Kilkelly.

Senator KILKELLY: Thank you Madam President. Men and women of the Senate, with all due respect to my colleague, I'd like to point out that the title of this Bill is An Act to Clarify the Authority of the Maine Milk Commission. This Bill does not change policy but clarifies a position that was taken by Legislatures previous to us. What the clarifying point is, is that milk that is grown in the state of Maine, milk that is processed in the state of Maine and milk that is sold in the state of Maine, should in fact make sure that the farmer is receiving the price set by the Maine Milk Commission. When a dairy starts selling milk out of the state and they exceed 10% of their total sales out of state they are able to purchase their milk at a lower price because they are saying that they are then outside of the Maine Milk Commission. What we're saying is for that percentage of milk that is purchased in Maine, processed in Maine and sold in Maine that they would stay under the Maine Milk Commission. Since 1935 this Legislature has seen fit to protect the stability of the dairy industry in this state. We spend a lot of time in this Legislature talking about sprawl. We spend a lot of time talking about rural life. I contend that the best way to contend with sprawl is to allow people to earn a living from their land. We are not going to be allowing dairy farmers to earn a living from their land if we don't provide a reasonable amount of stability in the price for milk. In just the last month we've seen the price of milk drop \$6 to \$8 a hundred pounds. That is a tremendous burden for farmers.

One of the other things that concerns me very much in both of my Committees, in Agriculture and also Inland Fisheries and Wildlife, is a diversity in our economy. We need to make sure that the policies of this state support a variety of economic activities so that people that want to be herdsmen, people who want to run dairy farms and people who want to sit behind a computer at MBNA, or go to veterinary school or be a doctor, all have an equal opportunity to live in the state of Maine. We've also had a big focus on local food. Local food also means local milk. If we don't clarify what the previous Legislatures have said, which is milk that is grown, processed and sold in the state of Maine ought to come under the Maine Milk Commission, than we will allow two of the dairies to pay a lower price for their milk. Right now what one of the dairies is doing is they're giving a bonus which in fact equals the price set by the Maine Milk Commission. But there's another little tiny dairy in the state that's never going to be able to sell 10% of their milk out of state and they're always going to have to pay the higher price. So there is a tremendous problem that those folks are going to be facing. This is a clarification. I agree that we shouldn't go in and try to pull the rug out from under another branch of government when their making a decision. But I think that we also have an obligation that when we see a decision that's being made and we believe that the decision is being made in a way that does not reflect the position the Legislature has taken, that we have an obligation, we have an absolute obligation, to clarify the position. This Bill came out of Committee as a unanimous Ought to Pass Report. After a lengthy public hearing and after work sessions, the Committee is very concerned about the future of agriculture and very concerned about the ability of this state to maintain it's rural culture and maintain opportunity. This Bill is essential for that purpose and I urge your support. Thank you.

THE PRESIDENT PRO TEM: The Chair recognizes the Senator from Somerset, Senator Mills.

Senator MILLS : Madam President, men and women of the Senate, I too want to join in expressing my sentiments behind this Bill, the significance of the Bill and the necessity for it and perhaps I can make one point that can help. As I understand the proceedings, there is a case pending not in another branch of state government, but in a branch of the Federal government. In Federal court there is a piece of litigation which seeks to challenge whether the Maine Milk Commission can Constitutionally regulate milk that is produced in Maine, processed in Maine and then sold to Maine consumers. And one of the problems in that litigation is a lack of clarity, about whether it is the intention of one of our preceding Legislatures to give the Milk Commission that power, that authority. The Agriculture Committee, and I think most of us in this building, would agree freely that the Maine Milk Commission should have that power. If not that power, than what other power would we give them? So what we're doing by passing this legislation is to clarify Maine Law. Clarify the intention with which it was created and with which it's being maintained and to answer a question that is pending so that the court case can go forward to address the more substantial issue of whether there's a Constitutional impediment to our regulating milk in this fashion. It will actually accelerate the process of the litigation to have this question answered in this Chamber and the other Chamber as they proceed. For that reason it is presented as an Emergency Measure. It's an Emergency Measure because it will facilitate the work of another branch of our Federal government and not impede it. Thank you.

Off Record Remarks

THE PRESIDENT PRO TEM: The Chair recognizes the Senator from Penobscot, Senator Michaud.

Senator **MICHAUD**: Thank you Madam President. I'd like to pose a couple of questions through the chair.

THE PRESIDENT PRO TEM: The Senator may pose his questions.

Senator **MICHAUD**: Thank you Madam President. It's my understanding that there's a differential price between the Federal order and what we pay at the state. Does this Bill affect that at all, and what is that price? The second question is if Grants stops processing, which I understand might happen, if they did stop processing what effect will this have on the Holton Dairy Farm? Thank you Madam President.

THE PRESIDENT PRO TEM: Senator Michaud of Penobscot poses a question through the Chair to anyone who may wish to answer. The Chair recognizes the Senator from Androscoggin, Senator Nutting.

Senator **NUTTING**: Thank you Madam President. I'll attempt to answer the good Senator's questions. First off the difference in the two prices currently is around 75 cents per 100 pounds of milk. Ironically, the particular dairy involved that is now waiting for the final vote to try to unclarify this clarifying piece of legislation is currently paying this 75 cents, even though

technically they may not have to. That's what this suit is about. If this Bill passes it will not effect their current practice one iota. The second question is Houlton Farms Dairy. Houlton Farms Dairy is a very small dairy in Aroostook County, family owned. A dairy very important to the State of Maine. All dairies have problems, what's called balancing. Sometimes, either they have too much milk or sometimes they don't have enough and they work with other dairies to ship milk back and forth to help their needs. I know this particular dairy in Bangor has, I don't want to use the words threatened, so I won't, told Houlton Farms that they will not balance for them anymore. I do know that the Agrimant Milk Co-op and Oakhurst Dairy in Portland have both made the offer to Houlton Farms Dairy that they will balance for them. So they'll be covered in this respect and I guess while I'm on my feet, Madam President with permission, I can't resist to say that this really is no longer Grant's Dairy, this is Sousa Foods, the largest dairy conglomerate in the United States, owned by a company headquartered in Texas. The former owner of Grants Dairy told me several times in the 70's and 80's when I used to come here occasionally as a private citizen dairy farmer, that his stomach would turn if any dairy in Maine tried to do what Sousa Foods is currently trying to do in court. And I couldn't resist clarifying that as well for the members of the Chamber. Thank you.

THE PRESIDENT PRO TEM: The Chair recognizes the Senator from Penobscot, Senator Murray.

Senator **MURRAY**: Thank You Madam President. May I pose a question through the Chair?

THE PRESIDENT PRO TEM: The Senator may pose his question.

Senator **MURRAY**: Thank you. There is a reference to a current law I guess or regulation dealing with this 10 % threshold. The question I have is whether or not that 10 % threshold would then make a processor under Federal regulation? Is that a Federal statute and if so, is there a preemption question that is part of what's being considered in the Federal court case at this time?

THE PRESIDENT PRO TEM: Senator Murray of Penobscot poses a question through the Chair to anyone who may wish to answer. The Chair recognizes the Senator from Androscoggin, Senator Nutting

Senator **NUTTING**: Thank you Madam President. I want to thank the good Senator for posing this question as well. I meant to cover this while I was up and forgot. This clarification does not effect the 10% Rule at all because that is Federally set. What this clarification is attempting to do is to say that whatever percentage of milk be it 85%, or 80%, or 89% that is produced and sold in Maine, that comes under the authority of the Maine Milk Commission. We would not have any authority to change the Federal 10% Rule. Ironically some of these dairies know that they're out-of-state owned, are moving approximately 11% or 12% of their milk out-of-state it just happens to be 1 or 2 percentage points over the 10%. But that's how it happened to work out. So this doesn't effect the 10% Rule at all. This just clarifies that milk processed and sold in Maine will come under the authority of Maine Milk Commission. **THE PRESIDENT PRO TEM:** The Chair recognizes the Senator from Somerset, Senator Mills.

Senator **MILLS:** Fellow members of the Senate, a brief response to the Senator from Penobscot's question, it seems to me that the issue of preemption or Constitutionality are blended questions that are properly before that court. You can't clearly reach that issue unless there is a clear understanding of what Maine law provides. In other words, is it our intention that the remaining percentage, the 85% or what have you, be subject to regulation by the Maine Milk Commission and until that intention is made manifest, the court will have difficulty getting to the issue that really brings the parties into litigation. That is whether it is appropriate for the Maine Milk Commission to have that power and whether it's Constitutional, or whether it is preempted by Federal law. Thank you.

This being an Emergency Measure and having received the affirmative vote of 27 Members of the Senate, with 5 Senators having voted in the negative, and 27 being more than two-thirds of the entire elected Membership of the Senate, was **PASSED TO BE ENACTED** and having been signed by the President Pro Tem, was presented by the Secretary to the Governor for his approval.
