**JOINT RESOLUTION DECLARING MAY 7, 1999
AS STAND UP FOR RURAL MAINE DAY**

WHEREAS, there are over 50 nonprofit community-based development groups hard at work improving housing and economic conditions in the State's rural communities, while preserving the rural communities' natural and cultural heritage and the values and quality of life that define rural Maine; and

WHEREAS, Maine's nonprofit community-based developers are recognized as leaders in development in the State and their efforts and determination are appreciated by members of the Maine Legislature and the Maine residents they represent; and

WHEREAS, Maine is the 3rd most rural state in the Union with 55% of its population living outside urban areas; and

WHEREAS, 17% of rural Maine residents live in poverty compared to 13% in urban areas and per capita personal income in rural Maine in 1989 was 79% of that in urban areas; and

WHEREAS, 60% of unemployed Maine residents live in rural areas; and

WHEREAS, Maine's community-based development groups support the Stand Up for Rural America Campaign, a national initiative to strengthen rural community-based development organizations and secure additional federal, banking and philanthropic resources to help these development organizations; and

WHEREAS, to promote greater awareness of the needs of rural Maine residents, Maine's community-based development organizations, the Maine Rural Development Council and the Stand Up for Rural America Campaign are recognizing May 7, 1999 as Stand Up for Rural Maine Day; now, therefore, be it

RESOLVED: That We, the Members of the One Hundred and Nineteenth Legislature, now assembled in the First Regular Session, declare May 7, 1999 as Stand Up for Rural Maine Day, a day for all Maine residents to celebrate the accomplishments of community-based development groups, recognize the need for more private and public support for the efforts of these groups and call on the Federal Government, banks and philanthropic organizations to invest more resources in helping these groups help Maine residents help themselves.

WHEREAS, the Black Bears were unbeaten in 13 consecutive games during the 1998-99 season despite several serious injuries to key players; and

WHEREAS, Black Bears Coach Shawn Walsh's strategic changes in the lineup of starting players and key contributions from freshman and sophomore players kept the team's winning record going during the season and allowed the younger players to gain crucial experience for the playoffs; and

WHEREAS, the Black Bears ended their season with an impressive 31-6-4 record and a berth in the NCAA championship tournament; and

WHEREAS, the Black Bears won a seat in the NCAA title game by beating Ohio State 4-2 in Round One of the tournament, Clarkson 7-2 in Round Two of the tournament and Boston College 2-1 in the tournament's Final Frozen Four; and

THE PRESIDENT: The Chair is pleased to recognize in the rear of the Chamber the University of Maine Black Bears men's hockey team. Would they please rise and receive the greetings of the Senate.

SHAWN WALSH: Thank you very much. I brought the trophy. I thought people would want to see it. I would first apologize, and it's a nice apology because I think it speaks highly to the emphasis on academics at Maine. I say this because today is the last day of final exam week. I can remember in my 15 years at Maine a while back before Peter Hoff came to Maine I would probably have the whole team here. But $\frac{3}{4}$ of our team are still in finals. In the old days you just didn't give a final, you just let the kids go before finals. I often wondered about that. Things have changed dramatically. I'm pleased for that. So I apologize in one way that some of our people aren't here but at the same time I think you understand. It's always pleasing to me to speak to this group and before I do I would like to introduce who is with us. I'll just go from my left over to my right. The first gentleman over here is Kevin Clauson who is a Defenseman with our team from, appropriately enough, the state of New Hampshire; next to Kevin is Adam Tate, another Defenseman from Ontario who will be graduating next year, a great student; our Athletic Director, Dr. Suzanne Tyler, who has done a great job solidifying our entire department and leading us to some of these great heights and doesn't get a lot of credit and deserves it; one of our Freshman Forwards from Massachusetts, the state of that school called Boston College, is Ed Boudreau; a key player who didn't score a lot but didn't have to, you have many roles in your Senate, this gentleman had a role in our team to be a Defensive Specialist and I think he's a terrific guy, Jim Leger; everybody remembers the championship goal and if you didn't remember it we're going to present you with it, I'll kind of get ahead of myself to break up the introductions. I see all these lovely pictures and paintings and I think these pictures and paintings represent Maine very well. You've got scenery. Maybe most importantly of all, you've got great people, which is the state. But you're missing a little of athletics. I decided to make sure we presented you, and maybe you'll find it appropriate, it's up to you to put it here. It's called 'The Goal' and it's signed by Marcus Gustafsson who scored the goal. Unfortunately Marcus is right now at Eastern Maine Medical Center awaiting the birth of his son or daughter any minute now. He could not come down and join us but he's at the hospital right now waiting. But the guy that set up the goal is my next introduction and he will say a few remarks later on. He's our Captain next year and our second leading scorer this year, comes from a sister area to us, from Campbellton New Brunswick, Cory Larose. This gentleman here scored the first goal in the National Championship game. A big strong powerful Forward but also a tremendous student. Just like Cory, a member of the Dean's list at the University of Maine, Ben Guite; our Head Athletic Trainer for Hockey at the University is a native Mainer from Auburn, Paul Culina. The gentleman who recruits for us, I consider him our Director of Personnel. He goes out and finds the guys that we want to represent the University of Maine. He's a tremendously sage and intelligent guy and I think it's a privilege for you to meet Grant Standbrook. Finally, last but not least, not only the Captain of this year's team, not only the player who was a First Team All American but maybe more importantly,

especially to you young people sitting out there, he's an Academic All American. He's one of those twenty people honored Nationally not just in ice hockey but in every winter sport that's given by the NCAA. Steve Kariya was considered such a great student and athlete that he was recognized as an Academic All American.

It is an inspiration to be here. Clearly we all respect what you do and we certainly appreciate everything you do for higher education. Steve and I actually two days ago spoke at the Weatherby School in Hampden, Maine. It's about the tenth different school I've spoken to since the season ended and it's non-stop. But that's a message I want to get out. You may not know that this particular team had the highest grade point average in the history of ice hockey at the University of Maine. They also are going to the White House May 20th. We're excited to represent the state there. I'm going to be a little more proud tomorrow morning. All five of our Seniors will be graduating on time, which is very difficult to do when you've got a two semester sport. It's an honor for them, but maybe more importantly, the rest of our team has decided they want to honor those five leaders of our team and they're all going to graduation as well. We're going to sit together and honor the graduates from the University of Maine tomorrow morning. So that's going to be a wonderful tie-in, much like you've tied-in higher education funding and education funding to the mission of the State of Maine. What do we do for the state, what do you do for the state? I'll give you one little story. ESPN told me that the Maine-New Hampshire game on national television was the highest rated college hockey game in history and nearly 3.5 million viewers nationwide saw that game. I like the fact that they saw one word across the front of our jersey and that word is Maine. I want to thank you for what you do for higher education, for education around the state for these little guys and girls right over here and the rest of them in their age group. Just on behalf of our team I want to say thanks. Corey Larose if you'd come up I think you have a presentation to give to the Senate as well.

COREY LAROSE: First of all, I'd like to say it's a pleasure and an honor. I represent the rest of the team. Unfortunately a lot of the guys couldn't be here this morning because of exams. The guys take our academics very seriously, as Coach said we did really well the past couple of semesters and I'd just like to say that it's an honor. I appreciate the opportunity to speak here. Without you people and all your help none of us would have the opportunity to go to the University of Maine and represent not only the University but the State of Maine in athletics as well as academics. I appreciate it very much. Thanks. I'd just like to present this goalie stick signed by all the guys and I hope you can put it somewhere really nice as a memento. Thanks a lot.

SHAWN WALSH: Maybe save that stick for a couple of hours because there's a rumor that the Governor from the state of New Hampshire will be parading around this building with a Maine jersey on. So you may want to save that stick for a couple of hours. Thank you again very much and have a great day.

So I had the privilege of living, to some extent, a couple of days a week with Marcus and you can't imagine how I felt when he moved to the right side of the goal keeper and was the only person on that side of the ice, and was able to push in his own rebound. I think I jumped right through the roof. I know that he is graduating tomorrow and I would like to make a special request if I could, Coach Walsh, of you and the team.
