**THE PRESIDENT:** The Chair recognizes the Senator from Penobscot, Senator Michaud.

Senator **MICHAUD**: Thank you Mr. President. Men and women of the Senate, out of all the nominations we have today, this is one I've heard a lot about. Not particularly this nominee but the position. Mr. President, may I pose a question through the Chair?

THE PRESIDENT: The Senator may pose his question.

Senator **MICHAUD**: Thank you Mr. President. My three questions are: number one, did the Committee look at whether or not they needed this position, i.e. when former Colonel Skolfield was there, Colonel Skolfield did the job of three people, the Colonel's position, the Commissioner's position, plus, they added a new one, Assistant to the Commissioner. Did the Committee look at whether or not, as far as the make-up of this Department?

My second question is, I did happen to look at the files and read a letter from the Maine State Trooper's Association and in it, I'd like to quote, it says make no doubt about it, we are at the lowest point in the history of the State Police. My question is how does the nominee plan to address that issue?

My final question is that we all hear a lot of rumors and one of the rumors we heard as far as this particular position is who might be the second in command, which is also a very important process and without getting into that specific point my question is is what process does this nominee plan to implement in order to pick a Lieutenant Colonel?

Thank you Mr. President.

**THE PRESIDENT:** The Senator from Penobscot, Senator Michaud poses a series of questions through the Chair to anyone who may wish to answer. The Chair recognizes the Senator from Penobscot, Senator Murray.

Senator **MURRAY**: Thank you Mr. President. Men and women of the Senate, I will be happy to attempt to address the questions that have been posed and if I don't get them all, I encourage the Senator from Penobscot or anyone else to ask them again.

Let me begin first by explaining a little bit about the Hearing, at least where I came into that Hearing, and I think where, quite frankly, some of the other Committee members did as well and it's probably for the same reasons that the good Senator from Penobscot, Senator Michaud, suggests. There were some questions being raised about this particular nominee and, perhaps more importantly, about the Department and how things were going. I came into that process yesterday, which is when the Confirmation Hearing was, very much with an open mind, at least with regards to this particular nominee, as to whether that was the appropriate selection for that very important position. I came away with my vote and my position being very comfortable and confident that a good selection had been made in the choice of Lt. Sperry. I'd be happy to address those reasons why as well, but I want to address the specific questions raised by the Senator from Penobscot, Senator Michaud.

We did not address, in the context of the Hearing for this particular individual, the broader issue this position, the Head of the State Police, needed. That's a legitimate question to ask, perhaps not necessarily the best place to ask it in the context of a review of a particular nominee, it's a perfectly legitimate question to ask in the context of a Legislative Hearing or Legislative Bill or discussion. I think, quite frankly, that position is a position that is needed. It may, in fact, be statutorily required so that without a separate Bill dealing with that we wouldn't be in a position to deal with that question in a nomination. But I think the good Senator has raised some interesting points with regards to some of the positions, especially Administrative level positions, underneath the Head of the State Police. I certainly hope that that is one of the issues that this new nominee, if confirmed, will address.

The second question, I believed you referred to a quote from the State Trooper's Association specifically dealing with the issue of low moral. That is very much an issue that a number of us on the Committee, including myself, zeroed in on and asked not only the nominee about but also the Governor's representative, the Commissioner, who was there to testify on behalf of the Governor. The issue is one that is of great concern for all of us on the Committee, and I suspect all of us here in this Chamber with regards to the moral issue. It was addressed by the nominee as well as the Commissioner and also the individual who wrote that letter who was a Line Officer among the State Police. Based upon what we heard, vesterday at least, much of the issue, as you expect, centers around financial issues, wage issues, and, as you may know, those Troopers are still in midst of mediation and negotiations. So that, quite frankly, was one of the key issues around that moral question. How that gets resolved depends on all of us to some degree. But specifically, the nominee indicated his intention to address the issue straightforwardly and as soon as he takes the reins, if confirmed, because, coming from basically the ranks and working his way up and being Head of the Criminal Investigation Division in the Southern part of the State, he's very much coming from an area where he is on the front line and has an appreciation, I think, of the moral issues. One of the key things, other than the financial issues that related to moral, is this issue of where the resources are being allocated within the Department. What we heard vesterday from the nominee was a commitment to the line officers and getting the Troopers out on the road as opposed to spending an inordinate amount of time dealing with paperwork issues, driving literally too and from Head Quarters in order to file reports, and issues that are taking resources away from where they need to be on the front lines.

The last question I think the Senator from Penobscot raised was the issue of the Second in Command. That too was addressed specifically and squarely by the Committee in the context of the Hearing yesterday. He was asked point blank about what his intentions were with regards to who his Second in Command would be. He did not indicate during the Confirmation Hearing who that person would be because, quite frankly, he has not made that decision. He indicated during the Hearing that he thought it might be a bit presumptuous of him to be out actively participating in that process prior to actually being confirmed. which I think is a legitimate response for him to make at this time. However, he did indicate what his preference would be with regards to the process and his intention to go out and interview and speak with all of the Commissioned Officers who would potentially be in line for that position to determine, first of all, what the interest level is among those potential candidates and then to talk about what the vision of those individuals would be. Finally, he also talked about looking for someone who would compliment both his strengths and his weaknesses as the leader of the State Police, which I think made a good amount of sense. He recognized his weaknesses, both personal as well as with regards to experience, and indicated that that would be one of the key things he'd be looking at for the Second in Command to complement his skills and leadership. So all of those things, I think, address the questions you have raised and I'd be happy to respond to other questions if you have them but based upon what we heard yesterday and what we heard from a number of individuals, not just the nominee, I am confident that the choice that was made was a good choice. That's not to say that there are not issues that we need to look carefully at with regards to this Department. In fact our Committee has asked and invited this nominee and the Commissioner of Public Safety back to our Committee in early January to lay out for us what that specific vision will be for that Department. We look forward to that happening. But for now I would urge you to join me in voting no on the pending motion so that this confirmation can move forward.
