At the request of Senator **MITCHELL** of Penobscot, the Resolution **READ**.

THE PRESIDENT: The Chair recognizes the Senator from Penobscot, Senator Mitchell.

Senator **MITCHELL:** Thank you Mr. President. Good morning, ladies and gentlemen of the Senate. It is a pleasure and honor this morning to rise and ask you to join me in celebration of the life of our Senator Alton E. Cianchette. Chuck was no stranger to any of us here and he is a legion to the people of our State. He brought his leadership, management skills, and people skills to this Senate after serving seven years as the first Chair of the Maine Indian Tribal State Commission. There, I'm told, his even-tempered and strong leadership provided his ability to negotiate through exceedingly complex State and Tribal situations and issues of jurisdiction. Chuck touched the lives of many as a friend and a mentor. I'm no exception. His warm smile and his big bear hug quickly erased any fears or lack of confidence you might have and his wise words of wisdom quickly enabled you to proceed with being able to be successful in the endeavors that you sought. During his time here in the Senate, his leadership and abilities provided the guidance to provide a better State government for the people of Maine. His accomplishments during his life exceed the goals and dreams of most of us. In his memory, I would like to share with you today the following parable.

In a beautiful blue lagoon, on a clear day, a fine sailing ship spreads its brilliant white canvas in a fresh morning breeze and sails out to the open seas. She is an object of beauty and strength and I stand and watch until at last she grows smaller and smaller as she nears the horizon. Finally, where the sea and sky meet, she slips silently from sight. Someone near me says there, she is gone. Gone where? Gone from sight. That is all. She is still just as large in mast and hull and sail as she was when she left my side. She is just as able to bear her load of living freight to the place of destination. Her diminished size is in me, not in her. We can be sure that as we say there, she has gone, there are other eyes watching her coming and other voices ready to take up the glad shout of here she comes.

THE PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Harriman.

Senator **HARRIMAN:** Thank you and good morning Mr. President. Ladies and gentlemen of the Senate, it is indeed a pleasure, in fact an honor, to rise this morning to say a few words in celebration of the life of Senator Chuck Cianchette. Like so many of us in this hallowed chamber and many others well beyond, I feel fortunate to have become a friend and colleague of his. If it pleases the Senate, allow me just a few moments to share with you some of my more memorable experiences with him.

And let me say at the onset, for the benefit of the public who are with us here this morning, that the most cherished seats in this chamber are the seats along the back. They're reserved for the veterans, if you will, and the newcomers to this chamber get to sit in the front. When I first arrived, Senator Cianchette sat actually here to my left where Senator Ferguson from Oxford sits and I sat where the good Senator from Penobscot, Senator Mitchell, now sits. Well, as the newcomer, I was constantly turning around in my seat asking Senator Cianchette what was on the agenda, what the motion was, and usually he was very helpful. Occasionally, he would give me the wrong answer. So I would have to go through the painful parliamentary procedure of asking the President to reconsider our actions whereby, etc., etc. That was in 1992. Times were tough for Maine. We were in the midst of what I called an economic forest fire. There were too many unmet needs and even fewer dollars to pay for them. As we began that session of the Maine Legislature in January of 1992, we were made aware that we were facing a budget deficit of one billion, two hundred million dollars. It reminds me of the story of the father who told his son that if he had borrowed \$50,000 from the bank and couldn't repay, that he had a big problem. But if he had borrowed \$5 million from the bank and couldn't repay, the bank had a big problem. Well, we were the bank and we were facing big problems. In his statesman-like way, Chuck told me that he had a plan. And it was a good one. And that it would get us out of the mess that we were in and move Maine forward. So, perhaps like many of you here at the time, over the next several weeks I watched with curiosity as he traversed around this building, going from the Governor's Office to the Speaker's Office to the President's Office. He was a picture of constant motion in a flurry of papers. Finally one day, he took me aside, in fact we sat right here, and he said I want you to take a look at my plan and see if it makes sense to you. And before I could take the papers from his hand, he was assuring me that he had double checked his numbers and that they had been looked at by the fiscal office and they had been cross-checked by an economist from UNUM, a man by the name of Keith Forrest. What Chuck had come up with was so simple it was brilliant. He had calculated the economic benefit of someone leaving the social services we have in favor of a good job. The swing in Maine's financial picture from its dismal reality to its brighter future was found by creating more tax payers. He said Phil, if every Maine employer would hire just one new employee, we'll put over 30,000 people back to work. Indeed, it was a good plan. And it was one that everyone understood and could embrace. In fact, it was such a great plan that our current Governor used it as a major initiative of his economic development policy. He called it Plus One. I called it Chuck's Plan. Since then we've seen 40,000 net new jobs. Our \$1.2 billion deficit is now a \$250 million surplus. So today, in honor of Chuck's Plan, I'm wearing my Plus One pin that Governor King gave me when my little company hired a new employee.

Mr. President, I also did a little research on Senator Cianchette's legislative record. I was impressed by how many of the Bills he sponsored or co-sponsored actually became law. And those of us who sit in these seats know that many of the Bills we sponsor never see the light of day, let alone get onto the law books. His name in support was on a wide ranging number of Bills from creating the Purple Heart license plate, access to capital for small businesses, educational needs for children with special needs, improving childcare services, workable environmental laws and rules, stabilizing our electric rates, and

assuring a sustainable forestry and paper industry, and many, many other Bills that he sponsored that became law.

And, as we all know, the hours and days here sometimes become blurred and fatigue and frustration sets in. It was during those times that Chuck was at his best. He would know the precise time to rise to his feet, ask the President for permission to address the Senate off the record, and, in his warm and sincere way, he would recite poetry that he had just written. It would always lighten up the moment and every once in a while it was actually pretty good.

Perhaps more than anything, I'll remember the day that Chuck told me that he wasn't going to run for re-election. He said the job that he had come here to do had been done and that it was time to go home and spend more time with his wife, Helen. And without a moments hesitation, he transferred that enthusiasm of his about Maine's future to building a high performance airplane, traveling with Helen and enjoying his children and grandchildren even more. My last memory of Chuck in this chamber was sitting at his desk, cleaning it out, with the help of his daughter Andrea's children. It was really something special watching him laugh as his grandchildren were leaving here with more stationery, pins, buttons and maps than they could possibly carry.

The Joint Resolution before us is a fitting celebration to a man who had greatness within him and bestowed upon him. He carried them with grace and dignity. It's truly remarkable that this Joint Resolution is about just one man. A man who was motivated not by wealth, rank or honor, simply because he cared enough about his family, his community and his State to want to make a difference. And at the end of the day, there is a big difference between well said and well done. Chuck Cianchette accomplished both. I'm honored to call Chuck Cianchette my friend, honored that I had the opportunity to serve with him, and so thankful to his wife Helen, his children and grandchildren for sharing him with us. Thank you Mr. President.

THE PRESIDENT: The Chair recognizes the Senator from Arostook, Senator Paradis.

Senator **PARADIS:** Thank you Mr. President. Men and women of the Senate and dear family members of my seatmate Chuck Cianchette, he was a man of incredible reasoning ability. He must have been absolutely frustrated many many times that, even when the best solution was being put forth, he was not able to bring all the parties together. That is the frustration of our public service. As you know, there's very little fanfare. We're public servants. We come. We go. The last day, as we left here at dawn, I caught up with him on I-95 and I thought how, after all these years of service to our State of Maine, to just leave alone. So we traveled together for a while until he turned off I-95. But he taught us about civility. No matter how frustrated he got, you never knew it. He was a trouble-shooter par excellent in his personal life, in his business life and I think he tried to do it in his public life. He will always be remembered and always loved and treasured for the wonderful service he gave to the people of Maine.

The President requested the Sergeant-At-Arms escort the Senator from Knox, Senator **PINGREE** to the rostrum where she assumed the duties as President Pro Tem.

The President took a seat on the floor.

The Senate called to order by the President Pro Tem **CHELLIE PINGREE** of Knox County.

THE PRESIDENT PRO TEM: The Chair recognizes the Senator from York, Senator Lawrence.

Senator **LAWRENCE:** Thank you Madam President. Men and women of the Senate, it's very hard to say good-bye to Chuck Cianchette. He's someone you almost turn around and expect him to come bounding into the chamber. He was someone who we all knew and loved very much and had a lot of dealings with and had a lot of respect for. And he served a special role in this chamber during a very special time in our State history. Each of us have a very individual relationship with him. So today is a very emotional day for all of us to say good-bye to Chuck. I just wanted to share with you one of my last memories of Chuck. In fact, in December, I had a chance to call him and I talked to him. It was about a month and a half after my daughter Katie died. We had a chance, he and I, to talk about that and to talk about his grand-kids and his sense of life and what truly gave it meaning in life. That's what I remember most about Chuck, his philosophy of life, his kindness, his gentleness, his compassion, and his wisdom. It was very comforting for me to talk to him and it was very easy for me to talk to him then in December as it always was here in the chamber. I think that was one of Chuck's greatest gifts in life, his ability to talk to people, his ability to relate to all people, his ability to make a connection with so many people. So as we leave here today, I know his spirit will live on in each and every one of us. He touched us and made us realize that the job we do is not just simply voting, it's how we perform our jobs and how we treat each other and how we treat people with respect, with kindness, with dignity, and with a civility that makes our society. Thank you very much.

The President Pro Tem requested the Sergeant-At-Arms escort the Senator from York, Senator **LAWRENCE** to the rostrum where he resumed his duties as President.

The Sergeant-At-Arms escorted the Senator from Knox, Senator **PINGREE** to her seat on the floor.

Senate called to order by the President.

THE PRESIDENT: The Chair recognizes the Senator from Waldo, Senator Longley.

Senator **LONGLEY:** Thank you Mr. President. Colleagues in the Senate, at Chuck's funeral his daughter Andrea said what she would like to hear is more stories, and as a daughter who's lost a father I'm not capable of telling stories today about fathers. But I would like to talk about Chuck as a friend. My story is this. In high school, my best friend was DeeDee. Everyone in her family loved to Skidoo and I liked to just cross-country ski. I liked the quiet. I had a quiet family, she had a really noisy family.

Anyway, whenever I was with DeeDee I had to lighten up and go with all the noise. The day after Chuck's funeral I decided to take a walk up to the top of a blueberry hill that overlooks my district. At the top it was perfectly quiet, just beautiful. A beautiful winter day. Then along in the distance I hear this buzz of a single engine airplane coming and getting closer and closer. I must say that just as DeeDee has taught me to enjoy snowmobiling, Chuck will always put a smile on my face now whenever I'm out for quiet and I hear a single engine floating by. Lastly, I'd like to say that as a grandfather, it was obvious how thrilled he was his last day in the Senate when three Cianchette grandchildren came stumbling in and falling all over him. It was complete joy and it was very obvious how much he loved his family. Thank you.

On motion by Senator **MITCHELL** of Penobscot, **ADOPTED.**

JOINT RESOLUTION EXPRESSING SUPPORT FOR A NEW ENGLAND COALITION ON PRESCRIPTION DRUG PRICES

WHEREAS, prescription drugs provide essential treatment to all our citizens and are the most rapidly growing component of health care in the New England region and in the country; and

WHEREAS, retail expenditures on prescription drugs in most New England states have approximately doubled over the past 6 years, and national pharmaceutical expenditures during that time have grown at a rate approaching 15% each year, while inflation has ranged below 3% a year; and

WHEREAS, the pricing of most prescription drugs marketed and developed in the United States is clearly excessive, especially for those drugs still under patent protection and therefore not subject to government regulation as a monopoly or to price competition in an open market, allowing the pharmaceutical manufacturers to be among the most profitable industries in the world; and

WHEREAS, the response of the Federal Government has been to enact legislation only to ensure that federal programs, such as the Veterans Administration and Medicaid, enjoy lower prices for prescription drugs while continuing constitutional barriers to states that may similarly wish to protect their citizens and upholding federal policies that have exacerbated the excessive prescription drug prices imposed on most citizens of the states; and

WHEREAS, in the United States, in the absence of any form of national regulation of prices of patented drugs, pharmaceutical manufacturers can and do charge ordinary Americans monopoly-like prices that exceed those charged in any other country in the world; and

WHEREAS, on average, in the United States prescription drugs are priced 34% higher than the same products sold in Canada, and a congressional study of the 10 prescription drugs most purchased by senior citizens in the United States found that such drugs cost on average 80% more than the same drugs in Canada; and

WHEREAS, United States citizens pay the highest prices in the world for prescription drugs, and such excessive prescription drug prices are particularly harmful to the people of this State who can least afford them, the uninsured and senior citizens, working families and families confronting serious illnesses like cancer and AIDS and chronic health problems; and

WHEREAS, lowering the prices of prescription drugs and providing more affordable access to needed prescriptions will lower overall health care costs by helping to avoid the necessity of hospital and emergency care, surgery and other expensive medical treatments; and

WHEREAS, the Commission to Study Bulk Purchasing of Prescription Drugs and Medical Supplies, an interim study commission of the 119th Legislature, recommended that the State investigate the possibility of joining with other states in the region to lower prescription drug costs to consumers; now, therefore, be it

RESOLVED: That, We, the Members of the One Hundred and Nineteenth Legislature, now assembled in the Second Regular Session, in order to address this problem of excessive drug prices, seek and demand fair prescription drug prices for all our citizens; and be it further

RESOLVED: That, although the most effective solutions are national and the responsibility of Congress, we recognize we must seek to build a multi-state or regional coalition of New England states and beyond, perhaps including the neighboring Canadian province of Quebec and the Maritimes; and be it further

RESOLVED: That, as a coalition, we must explore strategies to lower prescription drug costs in the near term and target the excessive pricing by manufacturers of prescription drugs, which is the underlying cause of high prescription drug costs. These strategies include:

1. Coordinating the passage and adoption of model state legislation to reduce prescription drug prices and guarantee to our citizens access to prescription drugs at lower prices;
2. Working with other states in the New England region and elsewhere to establish joint prescription drug pricing and purchasing agreements;
3. Developing multi-state proposals, agreements or compacts for price regulation of prescription drugs for all citizens;
4. Coordinating with other states to exercise the states' economic power in a way that causes drug companies to set lower prices; and
5. Working with other states to coordinate education of health professionals on the subject of cost-effective prescribing of drugs; and be it further

Education, felt compelled, and I quote, to address a problem that
came to her attention after a badly organized fingerprinting
session up in Houlton. She said, again I quote, State Police
complained about the behavior towards them by the school
people. State Police Lt. Jackie Therrault down-played the State
Police objections. Ms. Lucarelli has released a memo
threatening to report teachers and school workers by asking
State Police, quote, to inform her of names of individuals who are
particularly rude so that I can pass this information along to the
Superintendents. Lucarelli said she didn't mean this as a threat.
I really don't know what a threat is if this isn't a threat. I don't
know how well educated the Deputy Commissioner is but I must
say that from her handling of this matter she is more suited to be
Deputy Commissioner of Corrections than of Education. Thank
you Mr. President.
