Dear Speaker Saxl:

In accordance with Title 9-B MRSA §217, as amended, I am submitting the "Annual Report from the Superintendent of the Bureau of Banking to the Legislature."

Over the past year, Maine's banks and credit unions continued to enjoy solid performance, with good earnings and capital growth spurred on by a steadfastly robust Maine and U.S. economy. However, there are clear signs of a slowdown in the economy at both the national and local levels which indicate the need for renewed regulatory caution for the future.

With the passage of federal financial modernization, or the Gramm-Leach-Bliley Act of 1999, long-standing barriers to affiliation between banks, securities firms, and insurance companies were dismantled. During this time, burgeoning growth in the establishment of Internet web sites has also become prevalent as financial institutions seek ways to deliver increasingly diverse products and services in a fast and convenient manner. These phenomena have heightened the focus on the right to privacy of consumers' nonpublic personal information. Over the past year, federal functional regulators have finalized extensive rules setting national standards to protect an individual's right to privacy of nonpublic personal information. Those rules create additional operational and disclosure requirements that must be implemented by the financial services community within the next six months.

Maine's Universal Bank Charter continues to spark considerable interest, particularly with respect to Maine's specialty bank charter opportunities. Significant interest has also been

expressed by a variety of groups considering the formation of "virtual" institutions, or banks that operate exclusively over the World Wide Web. Over the past year, the Bureau has approved several applications for charter conversions, bank mergers or acquisitions, and formation of limited purpose banks, contributing to the growth in state supervised bank or credit union assets.

The SPEAKER: The Chair recognizes the Representative from Raymond, Representative Bruno.

Representative BRUNO: Mr. Speaker, Men and Women of the House. I rise again today and present the same argument that I presented the other day as to why this rule should not pass. The esteemed Rules Committee did not have a chance to review this new rule. Most rule changes are a major proportion, major rule changes go to the committee for approval and deliberation. We have not seen that. Things have not changed in the past five days, since the last time we voted on this. I ask that when you vote on this, you vote the same way you did last time. This rules change should go to the Rules Committee. There was time for the Rules Committee to meet and to debate this and deliberate it and come out with a unanimous or divided report. We have not seen that. Mr. Speaker, I ask for a roll call.

Representative BRUNO of Raymond REQUESTED a roll call on PASSAGE.

More than one-fifth of the members present expressed a desire for a roll call which was ordered.

The SPEAKER: The Chair recognizes the Representative from the Penobscot Nation, Representative Loring.

Representative LORING: Mr. Speaker, Men and Women of the House. In response to Representative Bruno's concern about the rule not going to the Joint Rules Committee, I do want to say that it was not a conscience effort that we ignore the Rules Committee. It is just that the idea of the amendment to tribal representation came after the Rules Committee hearings. There was never another meeting so we never got the chance to bring it before the Rules Committee. I do want to also say that there are some concerns about the one person, one vote part of this rule. At the federal level, the territorial delegates are allowed to vote in committee. For several years they were also granted the right to vote in the committee as a whole. The latter situation was challenged and upheld by both DC District Court and DC Circuit Court of Appeals. As indicated in the Michael case, which is Michael V. Andrews, when the legislative body is taking nonfinal action through its committees, including a committee of the whole, it is not legislating and therefore the one person one vote principle is not applicable. Rather, the relevant constitutional provision is the one giving the separate houses of the Legislature the authority to adopt their own procedures for considering legislation. Actions by committees are advisory rather than final and legislative rules could allow voting participation by Tribal Representatives. Thank you.

The SPEAKER: The Chair recognizes the Representative from Winterport, Representative Brooks.

Representative BROOKS: Mr. Speaker, Ladies and Gentlemen of the House. As the previous speaker stated a few minutes ago, I rise today to give you some of the same arguments that were given to you the other day. The only thing that may have changed is that those of us who served on a committee last year to look at Native American rights in this body have had an opportunity to talk to people to enlighten them about what truly did go on. As Representative Loring said, there is some misconception about whether or not there was any attempt or any effort to circumvent or not go before the Rules Committee. That is absolutely untrue. I sponsored the legislation last year to

look at a number of issues involving the Native American rights within this body and within the other body. We came back with some recommendations in a report. One of those recommendations we did take up the other day. It wasn't until after the Rules Committee had started to do its work and to conduct its meeting that we realized that this particular proposal of allowing the Native American Representatives to vote in committee hadn't been brought before the Rules Committee. For that, I apologize. It was an oversight. That was the process and that process, yes, I will admit, should have been followed. Being unable to do that at that point in history, then the process that we thought was appropriate to follow was to bring the order directly to the floor and let us decide that.

To repeat, for a long time this body has looked at, investigated, studied and discussed the participation of the Native Americans on the floor. We have made some changes in the orders. We just made recently another change allowing amendments to be offered. I ask you the same question that I asked the other day, think about it, being able to propose a piece of legislation, having it referred to committee and then when you get to committee, you may not be able to vote on that issue. This order would allow simply that. If and when a bill is proposed by a Native American Representative it is regulated under the current rules that that be something that is specifically related to the Indians or the Indian Land Claims or the Native American issues. When that bill comes to committee there is a public hearing just like all other bills and they have an opportunity to discuss that in that hearing forum. However, they are not allowed to vote on it. I think that is the extension that we can grant to them this year. It is an allowance to vote on their own bills.

We have also talked a lot about the constitutionality of allowing voting privileges on this floor. I am not going to stand here and disagree that there are some issues that I, too, haven't been able to resolve with regard to voting on the floor. I do believe that voting in committee on their specific pieces of legislation does not violate that constitution, neither ours or the US Constitution. I ask you to please follow my light on this and to allow us to move forward with participation by the Representatives that come from the Native Americans.

Yesterday at my home I received in the mail and for whatever reason, probably because I am nervous, I can't remember the legislative group of councils. There is a lead article on there, again, I apologize, I didn't get a chance to read, but across the nation bodies of governments are looking at participation by Native Americans. I see a few heads shaking so perhaps some of the rest of you have seen that argument. Again, I am not going to quote it or go into it in any detail because I haven't read it. I think that Maine leads the nation in many, many areas. There is legislation before this body that will be coming before us in a public hearing in a short time where we will be able to do something that is unique again to this country. Let us continue to lead the nation with the participation of a sovereign nation as declared under the Maine Indian Land Claims Act and some limited participation in this body of government. Again, I repeat, please follow my light and pass this order. Thank you Mr. Speaker.

The SPEAKER: The Chair recognizes the Representative from Auburn, Representative Shields.

Representative SHIELDS: Mr. Speaker, Ladies and Gentlemen of the House. The Constitution very clearly delineates who can vote in this body. If our friends from the

Native American groups want to vote in this body, they can be elected as a Representative of their particular district. I maintain and ask you to consider that each committee is an extension of this body. Who votes in committees other than duly elected members? I do not believe that exceptions should be made until the Constitution is amended. I submit that for your consideration to keep it as pure as it is. Thank you.

The SPEAKER: The Chair recognizes the Representative from Winslow, Representative Matthews.

Representative MATTHEWS: Mr. Speaker, Men and Women of the House. First of all, I just want to quickly comment on the good gentleman from Auburn. I believe the last time in this body he referred this to a politically correct kind of vote. Ladies and gentlemen of the House, it seems to me that if one group of citizens, and there are just more than just Native Americans, have been denied the opportunity to participate fully in this country and with the kinds of historic violations of their rights, it is Native Americans. As Representative Brooks mentioned, it is nice to be a member of this Legislature because we have a history in this body of involving the Native American Representatives. I believe we are probably one of the first Legislatures to have their representation here. Now we are simply asking them to be able to participate in intra-committee and to be able to vote on their own issues, intra-committee. It seems like a modest change to me. My questions the other day, and they are the same today, is what is the federal government or the Congress doing? We have heard this morning that they allow intra-committee votes by the Tribal Representatives in Congress. I would like to know what other Legislatures do. This is a modest change, ladies and gentlemen, in the committee on a specific narrow piece of legislation affecting Indian Tribes in Maine. I see it as modest and I offer those questions if anyone has any further elaboration on them. I am prepared to vote as I did the other day and it is not politically correct, it is the correct thing to do. I will vote accordingly.

The SPEAKER: The Chair recognizes the Representative from Wayne. Representative McKee.

Representative MCKEE: Mr. Speaker. Men and Women of the House. The Rules Committee has been very sympathetic to Maine Native peoples. I am greatly in their debt. I do think we have moved ahead in Congress and that represents a positive step too. When the good Representative Loring stood up last week to say that we feel invisible. That word was palatable to me. In my work in Native studies in Washington at the archives, museums here in the State of Maine and at my attendance at meeting across the state, that word resonates, invisibility. In letters to Indian Agents and letters to Washington and to leaders over the past 300 years, we feel invisible. Invisibility still exists. Maine schools are not required, at this point, to teach Wabanaki education. I can remember as an educator when in the '60s and '70s it was very important to teach African American studies. Folks were saying, why can't we just incorporate it into US History? Today we have and we no longer have those courses in our high school because we are better educated about that Unfortunately, Wabanaki education is still largely untaught in our schools unless someone is "into" Indians or likes to teach that and further adding to the invisibility of the Wabanaki peoples of the State of Maine.

We have had excellent support in the past from the Representatives of Native peoples and they have stood on the floor of this House in support of the tribes and their districts. Unfortunately, sometimes these Representatives are not on the

committee that is hearing a particular bill. I think particularly of last year in Judiciary when it was fortunate that the good Representative Loring was actually sitting on Judiciary when she is able to be there and to help educate us about the s word. I remember how poignant it was when a good Representative stood up and talked about the fact that on that day and on his return to the county, suddenly when he saw the s word mountain, it suddenly meant something to him and he had never known that before. When I think about the rudimentary education that we have regarding the Native peoples, I think that we need to do everything we possibly can to erase that invisibility and to increase education. This is a small step. I appreciate process. Principle will go over process for me today. We are moving in the right direction. I feel that this is a strong message to the people of the State of Maine. We do care about Native peoples. We have not always shown that. We can do this in a small way today. I do not believe that it represents anything serious as far as one person, one vote here. I hope you will follow my light and those of others sitting here today in support of Maine Native peoples on this issue.

The SPEAKER: The Chair recognizes the Representative from Durham, Representative Schneider.

Representative SCHNEIDER: Mr. Speaker, Men and Women of the House. I served on the committee last year to study tribal representation in the Legislature. I would like to offer a couple of factual answers to the questions posed by the Representative from Winslow, Representative Matthews. He had two questions, the first was, what other states do as far as representation of tribal members? Maine, I am proud to say, is the only state that has official representation by members of its Indian Tribes in the Legislature. That is a tremendous thing. The second question was, how Congress handles the votes of Representatives from the territories? Congress has a body called the Committee of the Whole, which includes all of the members of Congress so that they can debate and talk about issues without submitting themselves to the formal rules of the floor of Congress. Territorial Representatives have a vote in the Committee of the Whole, but not on the floor of Congress. That vote counts in the Committee of the Whole as long as it does not make a difference to the outcome of the question. If the vote of the Territorial Representatives makes a difference in the outcome of the question, it does not count. Thank you Mr. Speaker.

The SPEAKER: The Chair recognizes the Representative from Hartland, Representative Stedman.

Representative **STEDMAN**: Mr. Speaker, Ladies and Gentlemen of the House. I would again ask the question, or have you consider the question, of whether a person who represents the tribes as an elected Representative from a district should sit on the same committee as a tribal member and that issue would be having two votes from the same area. I think you should consider that as a constitutional question as to whether that is proper or not.

The SPEAKER: The Chair recognizes the Representative from the Passamaquoddy Tribe, Representative Soctomah.

Representative **SOCTOMAH**: Mr. Speaker, Men and Women of the House. We have entered a new area. A era where the Native people of this great State of Maine want to be heard. The people of this great state want to hear from Native people. Now other states are looking at this relationship and trying to duplicate it. Something must be going right if they want to duplicate this. Maine has a unique relationship with the Passamaquoddys and the Penobscots. We are not just a small group of people. We

have a legal and a historic relationship with Maine and the United States. Why are we here? My forefathers and your forefathers. The formation of this state thought it was a good idea for us to be represented here. We are the tribes that were written in the first Constitution of Maine. The tribes were written in the first Constitution of the United States. In 1980, the first modern day treaty was signed between the Passamaquoddys, the Penobscots and the State of Maine. The tribes of Maine are now asking for a voice in the laws, which are being made here, which exclusively and directly affect Indian communities. Last year about 10 Native bills were introduced that would exclusively impact our communities from a total of over 2,500 that were looked at over last year. That amounts to one-half of 1 percent. The tribes want to be part of this process, especially when it affects our communities. Thank you.

The SPEAKER: The Chair recognizes the Representative from Biddeford, Representative Twomey.

Representative **TWOMEY**: Mr. Speaker, Men and Women of the House. Mine is just a short dissertation. I think something did change from last time. I was saddened when I left this room. I was saddened. Representative Schneider, I have such great respect for him and his knowledge and so many of you are so full of good will and you come here to do the people's work. We have two Representatives that I respect also who want to be heard. I can't help but reflect in last session when the Speaker of the House, Speaker Rowe, would have to remind us how many of us were absent at committees. How many of us couldn't operate because there wasn't a quorum. Do we take that to our advantage? We are on a committee and sometimes we don't show up and sometimes there isn't a quorum and here are two people who are struggling to be heard. Thank you.

The SPEAKER: The Chair recognizes the Representative from Raymond, Representative Bruno.

Representative BRUNO: Mr. Speaker, Men and Women of the House. I have heard a lot of arguments today as to why we should pass this rule. The one thing I haven't heard is the true reason why it did not get to the Rules Committee, other than an excuse that it wasn't done on time. We have heard all kinds of reasons here, mostly emotional reasons, why we should allow the Native Americans to vote in committee. As I said last week, you know it may be a good idea, but I won't know until the Rules Committee has a chance to hear it. I want someone to look at this in detail, not just bring it to the floor of the House and ask for a roll call vote and hope it passes. We have gotten so far up field on the arguments of what this is about that we can't get back to the real issue, which is why didn't it get to the rules committee in this process. Good principle always wins in process. If this is a good idea, then let's go to the Rules Committee. That is all we are asking. That is our argument. Let's not let emotion play into this vote. I ask you to vote against this again until it goes to the Rules Committee. Thank you Mr. Speaker.

The SPEAKER: The Chair recognizes the Representative from Old Town, Representative Dunlap.

Representative **DUNLAP**: Mr. Speaker, Men and Women of the House. I will be succinct about this because I could go on about all kinds of different topics related to this, but it is not relevant. I do think it is very curious, given my particular heritage, my family came to the United States from Scotland, and thinking of that and how the Scotlish Tartans were banned in Scotland after the British took over up there a couple hundred years ago, that now we have a bill before this Legislature

pending to designate an official Maine Tartan, which I find curious given this talking about representation on committees. A thought comes to my mind that we have a number of study committees, which vote to report out legislation to the Legislature. Many of the members of those committees are common citizens. They are not elected members of this body as is with the concerns. I would counter with that. Also, a point was made earlier that we should be proud of this state, that we do so much more than any other state in the union. My reply to that is, should we really stop there? Thank you.

The SPEAKER: The Chair recognizes the Representative from Brooklin, Representative Volenik.

Representative **VOLENIK**: Mr. Speaker, Men and Women of the House. A vote in committee is not a vote on the floor of this body or the other body. There are two reasons why any of us may vote for a bill in committee. One, to show support for a bill. Two, to bring an issue to the attention of the Legislature as a whole. When I vote for a bill in committee, it does not add a vote to the tally on the floor of this body or the other body. If a Tribal member of this body votes for a bill in committee, it may result in influencing your vote or my vote, but it will not result in 152 votes in the House or 36 votes in the other body. The vote tallies will remain absolutely the same. Thank you.

The SPEAKER: The Chair recognizes the Representative from Augusta, Representative Madore.

Representative **MADORE**: Mr. Speaker, May I pose a question through the Chair?

The SPEAKER: The Representative may pose his question. Representative MADORE: Mr. Speaker, Men and Women of the House. To anyone who may care to answer it, currently the Tribal Representatives sit on a Joint Standing Committee making it 14 members. If we were to give them the power, that means that the 14th member voting on the committee, who and how would it be determined which member would be removed in order to bring it back to 13?

The SPEAKER: The Chair recognizes the Representative from Newport, Representative Kasprzak.

Representative KASPRZAK: Mr. Speaker, May I pose a question through the Chair?

The SPEAKER: The Representative may pose her question. Representative KASPRZAK: Mr. Speaker, Men and Women of the House. I don't have the answer to that question, but I do have a question of my own. Is there anything presently in Maine State Law that prevents a member of any nation, Indian or otherwise, to run as a candidate for the House or the Senate gaining them the same exact rights and privileges of each and every other member of the House or the Senate?

The SPEAKER: The Representative from Newport, Representative Kasprzak has posed a question through the Chair to anyone who may care to respond. The Chair recognizes the Representative from Augusta, Representative Madore.

Representative MADORE: Mr. Speaker, Ladies and Gentlemen of the House. As a member of the Rules Committee, that question was asked to the Attorney General's Office and the answer was there was nothing that prevents a Tribal Representative from running for a natural seat here in this body.

The SPEAKER: A roll call has been ordered. The pending question before the House is Passage. All those in favor will vote yes, those opposed will vote no.
