In committee hearings and work sessions, the committee may not give executive or judicial branch employees any preference over members of the public in presenting oral testimony either in the order of speaking or the amount of time allowed.

READ.

The SPEAKER: The Chair recognizes the Representative from Penobscot, Representative Perkins.

Representative **PERKINS**: Mr. Speaker, Colleagues of the House. In your printed calendar you will see this order. It is precisely the wording that I wished. I don't know if this pertains to your committee or committees, but it certainly does to some of the ones I have been a member of and some that I have spoke in front of. This is basically about the separation of powers. I am a strong believer in the separation of powers. Our federal constitution and all the state's constitutions are pretty similar saying there are three branches of government, three separate and distinct branches of government. I think that distinction has actually become muddied a bit here in Augusta. I think we need to be very careful that we don't lose that separation and that distinction.

This didn't go in front of the Rules Committee. I apologize. I cannot control when thoughts and ideas come into my head. I apologize for that. If there is any discussion on this today, to be honest, both sides have used this so far in these first three weeks or so saying that shouldn't pass because it didn't go in front of the Rules Committee. Both sides have used that. I would appreciate it if we didn't use that. The other one is, just remember back home, it is not a partisan issue. I presented an order here a couple weeks ago and it had to do with committees and that type of thing. It was a similar thing, but not the same. Afterwards people said to me from both sides, that was a darn good idea. I don't know why it became partisan? Some people voted along partisan lines. I am not immune from that myself.

Let's look at it on its merits and think in terms of your constituents and think in terms of your constituents in committee hearings and especially in the work sessions. How many times have you seen it where a constituent might put up a hand in the work session and they might get recognized if there is time? Usually they are given one shot at it. Have you ever heard a state department person be told that you can give one shot at it and that is it? I never have. Usually, the department people move right with the chair in some committees and almost take over. Sure, we need their information. We need their expertise. That is not the question. I just don't want any preferential treatment. I have had citizens say that they hardly got a chance to say anything whereas the commission and deputy commissioner got unlimited time. That is not fair.

Just in the remote chance that this does not pass today, I would hope that at least people will take cognizance of what goes on in your committee and make sure that this does not happen. Mr. Speaker, I request a roll call, please.

The same Representative **REQUESTED** a roll call on **PASSAGE**.

More than one-fifth of the members present expressed a desire for a roll call which was ordered.

Representative ETNIER of Harpswell moved that the Joint Order and all accompanying papers be INDEFINITELY POSTPONED.

More than one-fifth of the members present expressed a desire for a roll call which was ordered.

The SPEAKER: The Chair recognizes the Representative from Harpswell, Representative Etnier.

Representative ETNIER: Mr. Speaker, Men and Women of the House. It is with true sadness that I move to Indefinitely Postpone anything that comes from my good friend from Penobscot, Representative Perkins. Of all the people I have served with, there are none that I have enjoyed serving with more than the good Representative from Penobscot. Even though we disagree on a fair percentage of the items that roll through these halls, he is a man of great gentlemanly character and honor. I want to say that on the record because I do find it difficult to Indefinitely Postpone anything he brings forward. However, that is what I am doing. It is for what I feel to be a good reason and it has nothing to do with partisan politics as did my vote the other day on an order of Representative Perkins, which I felt was bad policy. This too, I feel, is bad policy and it has nothing to do with whatever party I come from. I urge you to vote based on what you feel is good or bad for policy, not on your party affiliation. I think that this is actually a helpful order in a way because I do think it would be an attempt to mitigate some of the damage that is done to the Legislature by the advent of term limits, which has shifted a lot of the power to the Executive Branch. Despite that, I feel it is an attempt to micro-manage the committee process and committee procedures. I don't think that is necessary. If you look at Rule 304 in the Joint Rules, procedures for public hearing and work sessions, it is fairly broad. It doesn't get into a great deal of specifics. You in your individual committees have adopted your committee rules. You have discussed. I hope, your committee rules and committee methods of procedure as is appropriate. Along those lines, if your individual committee wanted to amend your committee rules in the fashion that Representative Perkins has brought forward,

more power to you. There is nothing prohibiting you from doing so within your individual committee.

Having served as a chair for a couple terms and on six other committees in my time here. I have often found it helpful, frankly, especially in the public hearing process, to allow the department of jurisdiction, in my case it was always the Marine Resources Committee, to allow them to go at the head of the proponent section, if it was a bill they were supporting. Often times the reason for that is because it may be a department bill and it might actually be a bill of theirs that they are bringing to the committee for its consideration, as is fair. I think our committee has always felt that it was reasonable for them to go first to present their reasons why they thought it was a good idea. Frankly, I think that the public is appreciative to the fact that the department has gone at the lead because the public when they arrived there, I think they like to know why the department feels the way it feels and why the department is in favor or against something. Frankly, I think it helps the public when they stand up to speak to frame their response, be it for or against. I think having heard what the department has to say, sometimes helps them frame their arguments either in support or opposed.

I think that was really all I was planning to say on this. Again, I appreciate the Representative bringing this forward. I think it is appropriate if he wants to do it in his individual committee. I, however, would not want to be taken away in my committee that I happen to be on, this blanket ban on allowing either the Executive or the Judicial Branch to state their case at the onset. Thank you very much.

Representative MENDROS of Lewiston moved that the Joint Order be **REFERRED** to the Joint Select Committee on Joint Rules.

The SPEAKER: The Chair recognizes the Representative from Bridgton, Representative Waterhouse.

Representative WATERHOUSE: Mr. Speaker, Ladies and Gentlemen of the House. I told the good Representative from Penobscot that I would get up and support his move to do this today. Not only do I think it is a very good idea, but it has been pet peeve of mine for many years. In fact, most times when I have a speech to give before a club, I do mention the committee process. One of the things that is very disturbing to me is the process of having legislators go first. Of course the sponsor of the bill has to introduce the bill, but then having cosponsors get up and then the different departments and so forth and so on and then recognizing the general public. The vast majority of these people that show up take a day out of work. Some of them travel great distances to come up here and to testify on these bills. I have had some citizens from my towns come up and testify on bills that I put in for them. Some of them have had to sit around for most of the day to get up and testify. I see no reason, we do come up with reasons why legislators or the departments should have a first shot at this. Some of the comments that were made were that cosponsors should be able to get up and be able to testify in support of the bill because they cosponsored the bill. However, I think we all know it has been around here a while that most people that cosponsor bills, would not testify for those bills. I would be greatly surprised if the people who cosponsored all their bills went in and testified in support of those bills. The other big thing is I always said that the departments, the legislators and the lobbyists have many bites of the apple and it is very rare and the new people serving their first term will find this to be true, very rare for citizens to be able to come up for a second bite of the apple. Never mind the third, fourth or fifth or whatever, because they have to work. They come up here. They have their say. They leave and then the work sessions take place at the departments. The lobbyists come in and give information to the committees and everything that citizen might have said has been turned around by the new information and the system never gets a chance to have their second day in court. I think this is a small measure. I think it is good. I think it is a populous measure. It is good for the citizens of this state. I hope you will vote to refer this to the Rules Committee so that they can take a serious look at it. Barring that, I hope we do pass the rule here today.

During his 10 terms in office, Representative Dexter served as the House Chair of the Natural Resources Committee and was a respected member of the Agriculture, Conservation and Forestry Committee. He also served as the chairman of the Board of Selectmen in his hometown of Kingfield. He brought much to this chamber, but I think Eddie will be remembered most for his quick smile and, of course, great analogies, for they revealed the true flavor of rural Maine, which was so much a part of him. I ask, Mr. Speaker, that when the House adjourns today, it do so in honor and lasting memory of Edward L. Dexter of Kingfield. Thank you. The SPEAKER: The Chair recognizes the Representative from Raymond, Representative Bruno.

Representative **BRUNO**: Mr. Speaker, Men and Women of the House. It is awfully sad to do this kind of eulogy type thing. Eddie Dexter was a great guy. For those of us who served with him and knew him, he had a quick whit and he was a man of honor and integrity. He didn't say much, for those of you who knew him, but he would only rise on occasions when he really knew something about the subject. When you talk about the woods and the forests and the trees, there wasn't anyone in this chamber who knew any more. Eddie lived in the woods practically 65 years. He could describe a tree like no other person. He always had great stories to tell. The thing he always had was common sense. When he spoke, he spoke with common sense and that is why people listened to him. I can tell you he was a friend of mine and I am going to miss him dearly.

The SPEAKER: The Chair recognizes the Representative from Bridgton, Representative Waterhouse.

Representative WATERHOUSE: Mr. Speaker, Ladies and Gentlemen of the House. I served with Eddie Dexter in the 117th and the 118th. Eddie Dexter was not only a gentleman, but a gentle man. You might notice on your desk, it was put here earlier, three stories in memory of Eddie Dexter. One of them refers to the famous kitten story. That brings to mind a bill that came out of committee unanimous. It had to do with logging. Eddie had flagged it and I walked up to Eddie and asked him what do you want to do about it and he said, "Why don't we debate it." I knew with Eddie debating it, it stood a good chance of being defeated. Eddie and I got up. I think we were the only two that debated the unanimous committee report. I said my peace and Eddie got up and gave his famous kitten story, about his grandchildren picking up this kitten and squeezing it so hard that its eyes were bugging out. Eddie asked, "What are you doing with that kitten?" The kid said, "I am loving it." Eddie said that is exactly what we are doing up here in the Legislature with all these regulations that we think are helping these people. We are loving them to death. Please save that kitten. He turned around a unanimous committee report and defeated that bill. I would like to think at that time that it was of my doing, but I think it was all Eddie. Thank you.

The SPEAKER: The Chair recognizes the Representative from Gardiner, Representative Colwell.

Representative **COLWELL**: Mr. Speaker, Men and Women of the House. I knew Ed Dexter. I knew him as a great father, as a great public servant and as a great Mainer. Eddie and I didn't see eye to eye on a lot of issues, but we certainly saw eye to eye on what a great state this is that we live in and what great traditions that we have. I just wanted to lend my words to pay tribute to this great man. He did a heck of a job as a legislator and just as a real Maine person. Thank you Mr. Speaker.

The SPEAKER: The Chair recognizes the Representative from Poland, Representative Snowe-Mello.

Representative **SNOWE-MELLO**: Mr. Speaker, Ladies and Gentlemen of the House. I also stand here today in remembrance of Eddie. Eddie and I were very close friends. I remember serving with him in the 118th. I was just a naïve freshman who had a lot to learn. In his area of expertise, I knew I could always rely on Eddie to give me a straight fact on any issue. He was a kind and gentle man. He would always listen and always be there for me. I am sorely going to miss Eddie. Thank you.

The SPEAKER: The Chair recognizes the Representative from Farmington, Representative Gooley.

Representative GOOLEY: Mr. Speaker, Men and Women of the House. I rise today to give tribute to Eddie Dexter. Many times he would say, "I started in the woods when I was 12 years old." That is the truth. He did. He was from a different generation. I am a forester and he was a logger and he used to do some cutting on some of the lots that I used to have. He and I used to have some real interesting discussions about forestry and what is right and what is wrong. I can tell you one thing. When he was in his terms in the Legislature, he stood up for landowner rights. If anybody stood up for landowner rights, it was Eddie Dexter. He was not an average person. He was a lumberman. I can tell you that he was sick a few years ago and he and I would ride down here together and I would look at him and say, "Eddie | have to take you home. You really aren't well enough to come down here today." He said that he was going down. That is where my job is and I want to do it. He came down and he was not well. He was one of those people that get up at 4 a.m. in the morning. He certainly spoke his mind. Probably those of you know that you can't smoke in restaurants now, but Eddie started that several years ago and it was his idea to start that. All I can say is that we will certainly miss Eddie. We respect him. We respect what he did and it was a job well done.

The SPEAKER: The Chair recognizes the Representative from Westbrook, Representative Usher.

Representative **USHER**: Mr. Speaker, Men and Women of the House. Eddie and I started out in the Legislature together. He served on the Natural Resources Committee when I was chair. He was very helpful in the forestry issues. One of the bills that I can remember that Eddie put in had nothing to do with forestry issues. When he had the traveling barbershop, he got national recognition for that. The barber would be able to go from towns in his districts and he was very concerned about what went on in Kingfield. He knew every building. He knew everything that went on in the Kingfield area. His brother happens to reside in my community in Westbrook. I see his brother all the time. I always ask what Eddie's health status was. I was in contact that way. Eddie was a good legislator. He worried about his district all the time and always helped out a lot of people in his district.

The SPEAKER: The Chair recognizes the Representative from Hallowell, Representative Cowger.

Representative **COWGER**: Mr. Speaker, Colleagues of the House. I just need to take a quick moment to remember my libertarian friend, Eddie Dexter. That is what he called me or that is what we called each other. As a freshman in this body in the 118th, Eddie and I were seatmates on the Natural Resources Committee. I was a greenhorn freshman sitting next to probably the most experienced legislator in this body. Eddie and I got to become quite good friends. We disagreed frequently on the issues as well, but occasionally we would agree and it really turned all the heads on the committee. They would look towards us and wonder why we actually agreed on issues. We became good buddies and we did refer to each other as our libertarian friend. I will indeed miss Eddie. He was a gentleman in this chamber. He has taught us all lessons very well and we will miss him.

The SPEAKER: The Chair recognizes the Representative from Auburn, Representative Michael.

Representative **MICHAEL**: Mr. Speaker, Ladies and Gentlemen of the House. I also served with Eddie Dexter way back in the old days and served several years with him on the Natural Resources Committee. I was much more liberal than he was. My extent of the woods was getting out on the weekends and jogging in back of my house. Eddie had a way of taking a young fellow like me and letting me know I didn't know anything, without making me feel insulted. He always had a way of empowering the younger kids on the committee. He was very generous in that sense. He was a lanky gentleman, but sturdily built. He had a kind of an Abe Lincoln look to him. He was perhaps among all of the people I ever met up here, particularly and fundamentally honest. He was a good gentleman and I will miss him.

The SPEAKER: The Chair recognizes the Representative from Kennebunk, Representative Murphy.

Representative MURPHY: Mr. Speaker, Men and Women of the House. I had the good fortune to serve 10 years with Ed Dexter. As Representative Bruno indicated earlier, one of his excellent traits was commonsense. If you could pull up on the computer and look at his legislative packages over the last 20 years, you would see that theme running through. I think the Executive Branch knew that as well. I am looking at Representative Perkins's resolution today in terms of the rules. I think when Ed Dexter served on a committee, the Executive Branch would have gladly waited to be the last to testify because of his probing questions. He was always famous for his frugality, which used to be a Maine characteristic. He would always talk about this poor woodchopper and he would open up his coat so you could see the label. He was always proud that it was a 20 or 30-year-old coat. When I came back to the Legislature, he had a brand new coat on. I had asked him what was happening. He said that it had been 20 years wearing that last on. "Cord wood prices are up and I want you to know that I went to a thrift shop to get this coat."

He was a man of color. Too sadly, much of that color has disappeared from the Maine Legislature. He was a storyteller that the story he told you in the hall could be repeated in this chamber. There weren't two different levels of humor connected with Ed Dexter. He strongly believed in Maine individualism. Those characteristics included family, personal responsibility. He believed that government should be the last resort rather than the first remedy. It is appropriate in the State of the State that the Chief Executive echoed those same themes. He was also a person with an eye for the future because he was very concerned about whether new generations would ever know the joy or the thrill of working in the Maine woods. I think most of all, he loved this institution, this House of Representatives. He always talked about how humbling it was to serve in the people's body. Ed Dexter will be missed.

The SPEAKER: The Chair recognizes the Representative from Sanford, Representative Tuttle.

Representative **TUTTLE**: Mr. Speaker, Men and Women of the House. As I have said, these are always the toughest times for a lot of us in the Legislature recalling friends that we had served with. I always repeat that even though their lives may be gone, I assure you that their spirits will maintain in this institution to help us during the hard times for many years to come. As Representative Usher told you, I also served my first term with Ed Dexter back in the 109th Legislature, which was nearly 20 years ago. We served on the Labor Committee together. Back then, the Labor Committee was affectionately known in the press as the "wild bunch." I guess things really haven't changed all that much over the years for the committee. It was an interesting experience that Ed and I, even though we came from different sides of the issue, we always tried to get together and form some compromise. I think we did in many situations on that committee.

Ed also sat in Seat 33, which back then was the monitor's seat. These were the seats where Representative Perkins and I sit now. Before the voting machines were here, we were responsible for recording the vote. I know Ed always took that quite serious.

I remember a particular story back three years ago when I was in the hospital when I came back to the Legislature and I read something that Peter Mills put on our desks the other day and I would like to share it with you because he had given it me. Eddie told me about a legislator who had returned from being ill in the hospital and he asked a fellow legislator, a known tightwad, why he hadn't sent any flowers? The tightwad replied, "I heard you might not make it and I didn't want to send you flowers twice." For many of you who knew Ed, that was his sense of humor. Ed, rest in peace, my friend. God bless you.

The SPEAKER: The Chair recognizes the Representative from Gray, Representative Foster.

Representative **FOSTER**: Mr. Speaker, Ladies and Gentlemen of the House. Eddie Dexter was probably one of the best reasons that we could call the Maine Legislature a Citizen's Legislature. He was a person with his feet on the ground. He knew the woods. He knew the land. He represented the people who owned that land very well. Thank you very much.

The SPEAKER: The Chair recognizes the Representative from Hartland, Representative Stedman.

Representative **STEDMAN**: Mr. Speaker, Ladies and Gentlemen of the House. On behalf of the Somerset County Republican Caucus, I want to acknowledge Ed Dexter's passing and the contributions he made to our organization. He was an ever present member even though he only represented a very small portion of Somerset County. He never missed the meetings. He always had issues to discuss and he always used his wit and wisdom to enlighten us on the things we should be concerned about. On behalf of that organization, I do pass along our condolences to the family. Thank you.

Representative KASPRZAK: Mr. Speaker, Men and Women of the House. I would ask you to Recede and Concur with the Senate. It has been said that that traditionally and historically these things have gone to Legal and Veterans Affairs. That is the sudden shift. That is last session that things have started to Historically these issues on constitutional amendments shift have been referred to the State and Local Government Committee. I will just read briefly some things from committee subject areas. There is a little booklet in the Information Office. The SPEAKER: The Chair recognizes the Representative from Bath, Representative Mayo.

Representative MAYO: Mr. Speaker, Ladies and Gentlemen of the House. This issue has been on the calendar and kicking around for a number of days or weeks. It happens to be a bill that I am the sponsor of. There is a companion piece that has also been discussed and debated. I would support and urge you to support the chair of the Legal and Veteran's Committee. It is my understanding. I know that in the 119th Legislature, that committee dealt with similar issues and it is my understanding that looking back in the record that also this took place in the 118th Legislature. The previous speaker, the good Representative from Newport, made mention of the various duties of the two committees involved. In listing the duties of the Legal and Veterans Committee, was the word, election. I believe that what we are currently discussing does, in fact, pertain to elections. I would urge you to follow the chair's light on this particular issue and my light and vote against Recede and Concur. Thank you.

Earlier in the session there was a bill sponsored by the good Representative from Penobscot, Representative Perkins, to have a direct election for the position of Attorney General. Could someone tell me what committee that was referred to?

The SPEAKER: The Representative from Lewiston, Representative Mendros has posed a question through the Chair to anyone who may care to respond. The Chair recognizes the Representative from Sanford, Representative Tuttle.

Representative **TUTTLE**: Mr. Speaker, Men and Women of the House. That went to the State and Local Government Committee. I do want to remind you that historically those issues have gone to State and Local Government because of the initiative nature, the election law nature, of this bill that goes to Legal and Veterans Affairs and that is the distinction.

The SPEAKER: The Chair recognizes the Representative from Lewiston, Representative Mendros.

Representative **MENDROS**: Mr. Speaker, May I pose a question through the Chair?

The SPEAKER: The Representative may pose his question.

Representative MENDROS: Mr. Speaker, Ladies and Gentlemen of the House. According to the little booklet that the Representative from Newport, Representative Kasprzak, pointed out, constitutional amendments go to State and Local Elections go to Legal and Veterans Affairs, Government. however, the Attorney General's Office is under the jurisdiction of the Judiciary Committee. That constitutional Amendment didn't come to our committee. It went to the committee that deals with constitutional amendments. Every one of these constitutional amendments has some other area in effect. We can water down that committee and send bills to other committees and have some overlapping areas, but it seems to me that committees either have jurisdiction over an area or they don't. I see no reason why that particular bill that I mentioned couldn't come to the Judiciary Committee. I see no difference in these two pieces of legislation.

The SPEAKER: The Chair recognizes the Representative from Sanford, Representative Tuttle.

Representative **TUTTLE**: Mr. Speaker, Men and Women of the House. If the gentleman would wished that to occur, he would have the right to do that. Based upon, as I said before, the tradition because of the election law nature, I had been a former chair of the State and Local Government Committee 15 years ago. That was a precedent back then. I would hope that we would continue that precedent Mr. Speaker.

The SPEAKER: The Chair recognizes the Representative from Lewiston, Representative Mendros.

Representative **MENDROS**: Mr. Speaker, Ladies and Gentlemen of the House. One other point about the Constitution. The US Supreme Court in Meyer vs. Grant ruled that petitioning is protected by the First Amendment Rights. It is a core political speech at its zenith. This is more constitutional issues that this particular bill will be dealing with and the State and Local Government Committee is the most capable committee that deals with constitutional issues, how things relate to constitutional issues and other constitutional amendments. I urge you to follow the light of the good Representative from Newport, Representative Kasprzak.
