# JOINT RESOLUTION RECOGNIZING WORKERS MEMORIAL DAY ON APRIL 28, 2001

WHEREAS, more than 6,200 American workers are killed annually by workplace hazards and more than 1,500,000 are injured on the job; and

WHEREAS, in this State, there were 26 fatalities in 2000; and WHEREAS, the federal Occupational Safety and Health Act of 1970 guarantees every American worker the right to a safe and healthy workplace; and

WHEREAS, the citizens of Maine want to encourage and support improved safety in the workplace and recognize the adverse impact of workplace deaths and accidents on the State's economy and the tragedy they cause in families and the community; and

WHEREAS, the citizens of this State wish to remember Maine workers killed or injured on the job; now, therefore, be it

RESOLVED: That We, the members of the One Hundred and Twentieth Legislature now assembled in the First Regular Session, on behalf of the people we represent, proclaim April 28, 2001 as Workers Memorial Day in the State of Maine and encourage all residents to remember injured and killed workers and observe the day in an appropriate manner.

This is a ceremony to honor the 26 workers that suffered the unfortunate sudden loss of their lives last year in this state. It is way too high of a record for deaths in this state, besides the thousands of employees that were permanently disabled from occupational disease and injuries on the job. This ceremony will have some of the family members of some of these employees that lost their lives last They will be here to speak. The ceremony will by approximately 45 minutes. I would like to, again, encourage you all to attend if you are here tomorrow. If not, there will be ceremonies in Westbrook and in Millinocket. Thank you.

Dana's great love, in addition to skiing, is caring for horses, including his own, Miss Dana, a Belgian workhorse. Dana currently takes horseback riding lessons twice a week at Healing Horses in Harpswell and volunteers at another horse farm at least once a week. His dream is to someday live in a setting where he can have his horse with him.

Dana volunteers each year at the Common Ground Fair, helping to tend the animals. He has had jobs on a horse farm, bottle redemption center and with a moving company. When not involved with skiing or horses, he enjoys basketball, swimming, bowling and participating in self-advocacy groups and Literacy Volunteers. In September, Dana moved from the group home to a smaller Elmhurst home in Bath. He frequently visits weekends with his family in Edgecomb who are very supportive of his endeavors. This morning it gives me pleasure to offer congratulations to a job well done to Dana Albright.

The SPEAKER PRO TEM: The Chair recognizes the Representative from Sanford, Representative Tuttle.

Representative TUTTLE: Mr. Speaker, Men and Women of the House. It is with sadness and fond memories of years past that I speak to you today of the life of Joseph Ricci. Known by some as the maverick millionaire who owns Scarborough Downs and the businessman with a sharp tongue and provocative political style and two-time gubernatorial candidate. Joe Ricci died in January as many of us know at the young age of 54. Joe will always be remembered by me as a person who was bigger than life and who always spoke the truth as he saw it. Being the Chair of the Committee on Legal and Veterans Affairs, it is my opinion that Maine Harness Racing owns its continued existence to Mr. Ricci and his family. Mr. Ricci who lived in Falmouth is survived by his wife, Sharon; two sons, Jason and Noah; his mother, Anna, from Port Chester, New York; and three sisters, June, Michelle and Lynn. Mr. Speaker, it is my understanding that the family is here today with friends in the gallery. If we could recognize them, Mr. Speaker, thank you very much.

The SPEAKER PRO TEM: The Chair recognizes the Representative from Poland, Representative Snowe-Mello.

Representative **SNOWE-MELLO**: Mr. Speaker, Ladies and Gentlemen of the House. Joe Ricci left a great legacy for us in Poland. His Elan Center was a unique approach to a serious problem and many young people left there the better for it. I worked once at Elan. Joe Ricci was my boss. Frankly, I was scared to death of him, but that was also part of his charm. He was a perfectionist and he expected everybody else to see his vision and make it as perfect as possible.

Years later, I entered politics and was elected to the House. Joe would do a weekly radio program as part of his campaigns

for governor. Oh, I have such fond memories of being in that studio across the microphone from him and having him tell listeners, "Here's one of my favorite Republicans, Lois Snowe-Mello."

Joe was a constituent of mine because he kept a summer place in Poland. Was he cantankerous? Oh yea. But did he care about people? He sure did and that is why it is hard to stand up here today and speak about him because I sure miss Joe a lot.

The SPEAKER PRO TEM: The Chair recognizes the Representative from Scarborough, Representative Clough.

Representative **CLOUGH**: Mr. Speaker, Ladies and Gentlemen of the House. Joe Ricci was known as many things, depending on who did the talking. He was indeed outspoken. That was because when he believed in something, he was passionate about it. Frankly, more of us should emulate that trait. Too often we miss opportunities simply because we did not speak up. Those who knew Joe Ricci know that he was never shy about speaking up. At a time when substance abuse crept up from the tough streets and into the normal middle class family life, Joe had the foresight to found Elan. A special adolescent treatment center designed not only to get young people off drugs and alcohol and other substances, but also to prepare them for a productive adult life. At a time when the harness racing industry in Maine faced near extinction, he kept Scarborough Downs open as an opportunity for horse owners to highlight Maine's standard breeds to locals and tourists. The peripheral benefits from having this facility in Scarborough are immeasurable. Joe was also interested in public service. He thrust himself before the public as a candidate for Governor, not once, but twice. As a Republican, I have to admit that I enjoyed watching Joe put his fellow Democrats to the test. Joe Ricci was a man of tireless energy who enlivened our lives and left Maine just a little bit better for it. We will all miss him.

The SPEAKER PRO TEM: The Chair recognizes the Representative from Winslow, Representative Matthews who wishes to address the House on the record.

Representative MATTHEWS: Mr. Speaker, Men and Women of the House. I won't take but a minute of your time. I did want to speak a little bit earlier about the kids and the coaches that are behind me from Winslow High School because I am extremely proud of their effort. After listening today to the many citizens and students and others that we recognize here in this chamber, I think it is appropriate to say a couple of words. The kids that are behind me today were recognized by this House early in this session. We were not able to have them down here at that time. I think it is important to note that after given the tremendous achievements on the athletic field by Winslow High School, that the kids that are behind you here, 84 percent of these students are academic LTC Conference standout students. That is 84 percent of these students. I know a lot of it is due to their coach and I know how good of a teacher he is because I hear from my son every other day about that. That is important to Winslow High School and the principal and the teachers there that the kids get the kind of education and go on to college and post-secondary school. I wanted to take a moment to remind my colleagues and I am sure that this can also be done around the State of Maine and other schools, but I am very, very proud as one citizen who happens to be a state legislator of the students who are here and their academic achievements as well as their athletic achievements. I know it may be highly unusual, but I would ask all of you to extend

congratulations to not only their athletic prowess, but their academic prowess as well. Thank you Mr. Speaker.

The SPEAKER PRO TEM: The Chair recognizes the Representative from Winterport, Representative Brooks.

Representative BROOKS: Mr. Speaker, Ladies and Gentlemen of the House. I will only take a couple of minutes of your time this morning to talk a little bit about this bill. I wanted to have this opportunity earlier on, because there are two young men here who are paging with us this morning that are the ones who contributed greatly to a civics lesson at their school at Morse Memorial School in the Town of Brooks. I would ask them, they are down front right now, Jonathan King and Philip Hopkins. If they could just stand to see which one of the pages that they are.

When Ashley Seekins, a young classmate of theirs died in September of 2000 as a result of an automobile accident, these two men were the monitors at school for the US Flag. They wanted to fly the flag at half staff and they did all the things that they were told to do by their teachers and by their school. They called the Governor's Office. Actually what they did is they emailed the Governor. The Governor then turned over to the Adjutant General, Joe Tinkham, the request. through the procedure and wrote them back a letter, which they sent by e-mail. That they were sorry, but you can't do that. I don't need to, I am sure, for any of you to repeat the regulations and the law currently that exists that says that only the Governor can do this in the states and only can it be done if it is a statewide dignitary. This didn't satisfy Jonathan and Philip and they continued to pursue this working with me. The result was the legislation that you see before us here today, which has the support of the Chief Executive. It has the support of the Adjutant General. It has the support of a number of veteran's agencies. It has also the support of a number of fire departments, police departments and towns that have written me letters talking about

What it will do is it will allow us to lower the flag to half staff for honoring dignitaries in local communities who want to be cited. For example, if you have a fire chief as we did in Winterport, who had served as fire chief for almost 50 years, he was there as an assistant. He was there as the chief and he died of cancer about three years ago. We were not able to lower the flag over the fire station simply because he was not a statewide dignitary. This will allow this to happen in communities. The process will not change. We will still have to notify the Governor's Office. It will still have to be dealt with by the Adjutant General. The Adjutant General will then determine through proclamation, signed by the Governor that this can

happen. We have checked this out, with the federal law, to determine that there is no conflict. What the federal law says is that the President is the only one can lower the flag to half staff. However, he can designate those who can and he has passed that authority on to all the Governors as we know. In doing so, he gives them the discretion of determining who in the state can be cited by lowering this flag to half staff. This is a, I would say, somewhat landmark pieced of legislation. I don't know of other states who have done this. I do know that it is very consistent with federal law and has the support of the Chief Executive. Thank you Mr. Speaker.

Subsequently, the Majority Ought to Pass as Amended Report was ACCEPTED.
