Senate called to order by President Michael H. Michaud of Penobscot County.

Prayer by Pastor Richard A. Mowery of the Bethel Alliance Church in Bethel.

**PASTOR MOWERY:** Thank you, Mr. President and Senator Ferguson. William Beebe, the naturalist, used to tell this story about President Teddy Roosevelt. At Sagamore Hill, after an evening of talk, the two would go out on the lawn and search the skies for a certain spot of star-like light near the lower left hand corner of the Great Square of Pegasus. Then Roosevelt would recite "this is the Spiral Galaxy in Andromeda. It is as large as our Milky Way. It has one hundred million galaxies. It consists of one hundred billion suns, each larger than our sun." Then Roosevelt would grin and say "now I think we're small enough, let's go to bed."

There is a popular country song out today, I believe the title is "Dance". In that song there is a phrase that goes something like this "I hope that you still feel small beside the ocean." I hold each of you men and women in high esteem. You're continually confronted with large and important issues. Major decisions that effect the whole of our state on a social, economic, material, relational and even spiritual level come from this room. It would be easy for anyone to be tempted to think of themselves as bigger than what they really are or maybe more important than they are. So understanding the largeness of your work here today, may I encourage you to be reminded, as I am often reminded when I stand on the rocks along Pemaquid, just how small I am and how large and awesome God is and realize that there is wisdom and direction available to each of us far beyond ourselves.

As Roosevelt might have said, after seeing the vastness of God's heavenly creation, "now I think we're small enough, let's get to business."

Let's pray together. Heavenly Father, I thank You, that You are who You are and what You are. That You are supreme and awesome and yet available. I praise You that You have told us to ask for wisdom and not to do it half-heartedly and You will give it. So this morning as these men and women begin their awesome task of evaluating and planning and making decisions, I pray that they will look to You first for that wisdom that sees beyond the immediate and the pressing and is able to see the bigger picture, even from a Divine perspective. As they work, help them to work together, maybe not in unanimity but in unity, with one mind and one purpose, to serve You ultimately as well as their constituents to the best of their ability. Help them, Lord, to consider Your ways first as they seek to find their way through the maze of information and decisions that lie before them. Father, I ask for Your enabling and Your blessing upon this Senate for this day. I ask You to bless the Representatives meeting in the other chamber. I ask You to bless our Governor and his staff today.

As You do, may You receive the glory and the honor for You are truly worthy of it all. I ask these things on behalf of these, my leaders, in the name of my Lord Jesus. Amen.

WHEREAS, the citizens of Maine want to encourage and support improved safety in the workplace and recognize the adverse impact of workplace deaths and accidents on the State's economy and the tragedy they cause in families and the community; and

WHEREAS, the citizens of this State wish to remember Maine workers killed or injured on the job; now, therefore, be it

**RESOLVED:** That We, the members of the One Hundred and Twentieth Legislature now assembled in the First Regular Session, on behalf of the people we represent, proclaim April 28, 2001 as Workers Memorial Day in the State of Maine and encourage all residents to remember injured and killed workers and observe the day in an appropriate manner.
