In accordance with 5 MRSA § 13070-J, we are pleased to submit the "agency report" for the Governor's Training Initiative, which has been an instrumental tool in the creation and retention of high skill, quality employment in Maine since its inception in 1996. In calendar year 2000 more than 105 companies participated in training. Fifty-four of fifty-six firms (96.42%) having received \$10,000 or more in reimbursements submitted in accordance with EDIR law. Training projects provided by these firms have impacted the skill development of 2,453 new hires and 4,387 incumbent workers. The attached report lists the amounts paid and the anticipated job growth and retention associated with those funds. Because the funding cycle is spread over a two-year period, funds related to EDIR reporting requirements of this calendar year may be associated with contract allocations spanning three funding cycles (PY98, PY99, PY00).

Statistics included in this report indicate the public benefit derived from the Governor's Training Initiative; these include private dollars leveraged via company match for direct training related activity and an estimated tax base increase associated with new job creation and a potential ensuing job multiplier. In addition, comments have been included from reports that represent overall responses regarding both company and public benefit.

Given our goal of encouraging employers to invest in workers and promote training for workers in all sizes and types of firms, the Governor's Training Initiative has ensured that the needs of small firms are included. In particular, the Governor's Training Initiative is one of the few public vehicles available to reach workers on the job. It acts as an incentive for companies of all sizes to invest in their employees. Importantly, the training plans approved for this program are geared to provide transferable skills to workers. This assists workers who are laid off by equipping them with current skills and is especially important during periods of recession or transition in the workplace.
