Hear this, our prayer, oh God, and use us in the answering of it. Amen.

Senator **BROMLEY:** I just wanted to let my colleagues in the Senate know that the committee's concerns were primarily about having unlicensed people installing oil tanks. Though mechanics are currently licensed, they are not licensed in plumbing, wiring, piping, and the things that are important to hooking up an oil tank appropriately. Also, we currently have people licensed to do this and there are particular and specific types of education that they have to have. This bill does not address that. Many who came before us were quite concerned about the potential of liability if this bill were to go forward. So I urge you to join with me in accepting the Majority Ought Not to Pass. Thank you very much.

**THE PRESIDENT:** The Chair recognizes the Senator from Penobscot, Senator Youngblood.

Senator **YOUNGBLOOD:** Thank you, Mr. President, ladies and gentlemen of the Senate. I would urge you to vote against this motion and ultimately pass this piece of legislation. This was lobbied very heavily by the oil dealers of my area and in many of the other areas of the various representatives of this committee. The manufactured housing group of people in this state has been installing oil tanks for 20 years. There were no reported disasters as a result of doing that. This resulted in a fight between the boards of the manufactured housing group and the oil burner group. It's obvious that the oil burner group had a little bit more moxie. It's not rocket science. The people who testified in favor of this not passing made it sound very difficult, made it sound as though you had to be a little bit of a plumber, a little bit of an electrician, a little bit of a brain scientist in order to install an oil tank. Manufactured homes, mobile homes primarily, come with a furnace all in them. It's only a matter of hooking an oil tank to an existing furnace. If, in fact, the ability of the people who are doing this is not properly regulated, than we ought to be saying to them you need to get a license. You need to take this course. You need to get this certification, whatever that certification might be. We ought not to be telling an industry that has been doing this for 20 years - you've got eyes, you people who run these businesses, no longer know how to do this. This was taking a very hard-handed approach, from my prospective and also from the prospective of the House Chair of this committee, that after 20 years this has not been a disaster. Have their been spills from oil tanks? You bet your life. But I believe that if you were to go back and check those out, they were undoubtedly not caused as a result of somebody who was in the manufactured home installing one of these, it was a result of some Ed Youngblood thinking he could hook his own up, knowing nothing about this, and created a spill. There must be a much better way to approach this than saying just because you've been doing it all these years doesn't mean you ought to be able to continue. I urge you to vote against this motion and turn this around and do

for Maine businesses what we're sent here to do. Thank you very much.

**THE PRESIDENT:** The Chair recognizes the Senator from Aroostook, Senator Martin.

Senator **MARTIN:** Thank you, Mr. President, members of the Senate. Let me first indicate to you that I'm surprised that this bill went to the committee that it did. It really belonged in the Natural Resources Committee because that is the committee that deals with the issue we have before us. The oil burner group may or may not have more power, I'm not sure, but I do want to emphasize a couple of things. First of all, there have been a number of leaks, a number of breaks. Secondly, you need to know that this is now the number one problem in this state. This is the number one problem in homes. We are presently having leaks caused by improper installation. Whether it be done by an individual or be done by a manufactured housing group, I have no clue. The statistics have not been kept along those lines and I can't verify or deny the information provided to us by the Senator from Penobscot. But I do know this, it is a very serious issue. It is one that should be dealt with by the people who deal with it and not by giving it to another group. I really maintain, in the long run, that if we don't deal with the issue of these tanks, located in your basement and mine for example, we'll have a long-term problem with water, especially those who have their own wells. So I encourage you to accept the majority 11-2 committee report because I think they were moving in the right direction. I just wish it had been unanimous Ought Not to Pass.

We have passed a number of mandates onto the local level already this year and have defended those as things we just need to do. Now that the shoe is on the other foot, it becomes obvious that, although the cost of this is something that the state may not have asked for it is going to be using up several hundred thousand dollars worth of our precious revenue in order to cover this exemption. It also adds to the rather piece-meal approach that we have taken to tax exemptions and to taxation policy in general. So I would urge your support for the Minority Ought Not to Pass report.
