The SPEAKER: The Chair recognizes the Representative from Saco, Representative Kane,

Representative KANE: Mr. Speaker, Men and Women of the House. This is a bill that would provide an across the board 20 percent increase in provider reimbursement rates for Maine Care. While there is a great deal of sympathy and support in principle for the increase of the reimbursement rates for providers under Maine Care, the fiscal note on this bill would be nearly \$55 million to the general fund, something that we obviously cannot afford right now or in the foreseeable future. Thank you Mr. Speaker.

The SPEAKER: The Chair recognizes the Representative from Auburn, Representative Shields.

Representative SHIELDS: Mr. Speaker, Ladies and Gentlemen of the House. I am the only one opposing the current motion. I do it because I want to bring you a message. I realize that in these current days of fiscal problems that there is no chance that this bill is going to be funded or passed. However, this is an opportunity to tell you about the support given by the medical care providers and their acceptance of low fees, which has allowed Maine to go ahead with programs. In other words. the Maine providers have subsidized the health care programs for many years by accepting low reimbursements when their overhead costs were much higher. For instance, a brief office visit currently under Medicaid or Maine Care pays the doctor \$13.17. This bill raises that up to \$15.81. That is a 20 percent increase. Your overhead costs in seeing a patient is probably somewhere between \$20 and \$30 per patient. You can see why a number of people have to limit the number of Maine Care people they can see. The provider's patience is running short, particularly this year because you have cut them again. Some day those who want the taxpayers of Maine to provide health care for everyone will need to realize what the true cost of that is and realize what a level of reasonable reimbursements to providers really is. Thank you.

The Chair ordered a division on the motion to ACCEPT the Majority Ought Not to Pass Report.

A vote of the House was taken. 64 voted in favor of the same and 55 against, and accordingly the Majority Ought Not to Pass Report was ACCEPTED and sent for concurrence. ORDERED SENT FORTHWITH.
