Representative **CROSTHWAITE**: Thank you Mr. Speaker. Mr. Speaker, Ladies and Gentlemen of the House. Morris Yachts has been in operation for over three decades. The product line includes sail and power yachts, with a fine reputation for luxury, performance and great value. It has truly set the standard for yachtsmen around the world.

Tom Morris began this endeavor in 1972, and son Cuyler, who is now the President of the company, joined him in 1995. Tom's family had been vacationing in Maine during the summers since 1886, so his love for sailing and the sea were with him since birth. The family "A Class" boat, Manchester 17, was bought by Tom's grandfather in 1911, and served five generations until 1975 when Tom and his brother Bill donated her to the Mystic Seaport. She was sailed from Maine to Mystic as

One last note is that we have as an original Mainer, Elijah Parish Lovejoy, who was an abolitionist publisher, whose words were quoted by Martin Luther King. Mr. Lovejoy was from Albion, Maine and he graduated from Colby College. And it was he who first said, "As long as one man is not free, I am not free. As long as one man lacks justice, I suffer injustice". It is with these words that I am pleased that Roger Richmond is here today, will be available to all of us to speak and learn more about this piece. And hopefully the future of the model, and perhaps some further legacy from Maine. Thank you Mr. Speaker.

JOINT RESOLUTION EXPRESSING THE INTENT OF THE LEGISLATURE TO ENSURE RESPONSIBLE GOVERNMENTAL EXPENDITURES

WHEREAS, the Members of the One Hundred and Twentysecond Maine Legislature enacted limitations to ensure responsible and sensible governmental expenditures; and

WHEREAS, the people of the State of Maine have placed their trust in elected officials; and

WHEREAS, we, the Members of the One Hundred and Twenty-third Maine Legislature, honor the solemn trust the people of the State of Maine have bestowed upon us; and

WHEREAS, the Attorney General of Maine has opined that a joint rules change requiring a 2/3 majority to override the spending limitations would likely be found unconstitutional, if reviewed by the Maine Supreme Judicial Court; now, therefore, be it

RESOLVED: That We, the Members of the One Hundred and Twenty-third Legislature of the State of Maine now assembled in the First Regular Session, reaffirm our commitment to remain under the spending cap on governmental expenditures as enacted by the One Hundred and Twenty-second Maine Legislature; and be it further

RESOLVED: That suitable copies of this resolution, duly authenticated by the Secretary of State, be transmitted to the Honorable John Elias Baldacci, Governor of the State of Maine. **READ**.

The SPEAKER: The Chair recognizes the Representative from Presque Isle, Representative Fischer.

Representative **FISCHER**: Thank you Mr. Speaker. Mr. Speaker, Men and Women of the House. The purpose of this Joint Resolution is to clearly state the intent of this Legislature not to exceed LD 1's caps, not about a majority vote, not about a two-thirds vote, just not to exceed the caps period. And that's what we are committed to. We should not allow this aisle to divide us. We should not allow our disagreement on issues such as these to divide us. But instead, we should today, stand together and say quite clearly to the people of the State of Maine, that we are committed to work in a bipartisan way. And to pass a bipartisan budget together. That will be what is best for the people of the State of Maine.

There are many big commitments contained both in the supplement budget the Chief Executive has presented to us, and in the biennial budget that he has presented to us. It has large investments in K-12 education, in higher education, in fulfilling our responsibilities to Maine's hospitals, to making sure there is an adequate safety net for all Mainers. All of those things, all of

them, live within the caps that the last Legislature passed. And we reaffirm our commitment to those caps here today.

The biennial budget that the Chief Executive has presented, as it stands now with revenue increases, contained therein, is still \$70 million below the spending caps in each year of the biennial, \$140 million below the spending caps. Our committee, the Appropriations Committee, is committed not to send a budget to the floor of this House that exceeds those caps. That is the pledge that I make. That is the pledge that our Caucus makes. And I ask all of you to join in that pledge. Thank you Mr. Speaker.

The SPEAKER: The Chair recognizes the Representative from Winthrop, Representative Flood.

Representative **FLOOD**: Thank you Mr. Speaker. Mr. Speaker, Ladies and Gentlemen of the House. While I am very disappointed that we are not able to find a way to approve a two-thirds majority vote on the excess above and beyond LD 1's spending caps, I do want to say that I respect the effort and the review that this proposal has caused. When I drafted the proposed rule, I knew that it would result in significant discussion at the liberation, regarding spending and the various philosophies about majority voting and supermajority voting.

Spending reform is a key necessity for our state. And the proposed rule would have formalized important discipline and scrutiny regarding state spending during the 123rd Legislature. I am pleased, however, that the Resolution that we have before us, was proposed by our Chair of the Appropriations Committee. I think that is most relevant. I am disappointed that the proposed rule will not become a reality, but I am proud however, of the important discussion that this has precipitated. And I am pleased that as a secondary solution, we may be able to pass a good Joint Resolution that pledges our constraint regarding state spending, during this Legislature.

Let's make this a meaningful pledge and work our hardest to honor it. I want to personally thank the leaders of both caucuses for listening to this proposal and giving it consideration. I appreciate the meetings with members of both parties. Particularly the Representative from Newport, Representative Tardy, the Representative from Brunswick, Representative Crosthwaite, the Representative from Brunswick, Representative Gerzofsky, and House Democrat Leader, Representative Pingree, and you Mr. Speaker. I also appreciate the deliberations before the Joint Rules Committee and its members from both bodies. I do want to say that I will continue my pursuit to encourage greater and greater levels of discipline regarding state spending. The people of Maine deserve that and nothing less. It is critically important.

In the interim however, I graciously respect the fact that we have gone as far as we can with this today. And I thank this body for its patience. And I hope when this matter comes to a vote, we will demonstrate to the state our full commitment to control spending with 151 green lights. Again, I want to thank you all for your patience. I think we can do better and I will continue to pursue additional, reasonable spending controls. Thank you very much Mr. Speaker.

The SPEAKER: The Chair recognizes the Representative from North Haven, Representative Pingree.

Representative **PINGREE**: Thank you Mr. Speaker. Mr. Speaker, Men and Women of the House. I certainly don't want to stand any longer between this Chamber and lunch. But I just very briefly wanted to echo the comments of the good Chair of Appropriations. I actually wanted to thank Representative Flood for handling this matter with real respect, with real interest in pursuing a good process for this legislative body, and a real commitment to fairness. I think he has handled himself in a very

respectful way and I've enjoyed working with him. And I certainly appreciate the body's willingness to consider this Joint Resolution. Thank you Mr. Speaker.
