I am very proud to stand up today and honor Burt Edwards for doing probably one of the most difficult jobs in a community, the task for running for and serving on a local School Board. As you can imagine the issues that come before the members of the Board of Education, are very intense issues and involve families and their children and their education. And Mr. Edwards has faced all of these challenges with grace and a plum over the 18 years he has served.

As you heard, he also has been very involved in the community in athletics, High School Booster Clubs. His children that you heard mentioned, all graduated from South Portland High School. And Mr. Edwards was able to hand all of them except one their diploma, he happened not to be the Chair that year. And then those wonderful, young citizens all went on to graduate from colleges in Maine.

We have a couple of comments today from Burt's family. His daughter remembers when he was running for the School Board, and she says that as children, ranging in ages from 3 to 15 years old, we were all thrilled that he was running. But in the dark ages, she says, before color copiers, Internet, and email, fancy signs and community papers, the glamour quickly faded. We spent countless hours spray-painting signs and folding photo copied black and white flyers, which then needed to be hand delivered. She says, "I remember trudging around covering just about all the South Portland community on weekends with flyers. It was a pretty cool way for someone in high school to spend their weekends. I always prayed that I would not see anyone I knew. Having our dad on the School Board had both advantages and disadvantages."

And the ultimate message when we decided that we would like to get Burt here today to honor him with this Sentiment, his family tried to keep it a secret from him, but as you can imagine, that task is a little daunting. So last night they finally had to break the news to him that he wasn't coming today to help his son-in-law. He was coming to receive a sentiment. And his daughter read him a poem that begins, "Hope you're ready busta, cause you're going to Augusta." And the poem ends with, "Your accomplishment in the last 18 years will be shared. It will show your hard work, dedication, and how much you cared. I hope you know how very proud we are of you, not only to your dedication to the schools, but us too." So I thank you all very much and welcome Burt and his family here and honor his accomplishments over the 18 years for South Portland children. Thank you Mr. Speaker.

The SPEAKER: The Chair recognizes the Representative from South Portland. Representative Bliss.

Representative **BLISS**: Thank you Mr. Speaker. Mr. Speaker, Men and Women of the House. I cannot imagine being on a school board. I have no idea why anyone would want to be on a school board. Many of you have been on, and many of you are still on your own local school boards. And the job is so intense, and so difficult, partly because you're dealing with limited dollars, and partly because you're dealing with your friends and neighbors and your children. It is the supreme thankless, public service job.

Burt didn't do it once, and he didn't do it twice, and he didn't even do it three times. Think about 18 years. When I was running for this seat for the first time, seven years ago, the big issue in South Portland was neighborhood elementary schools. Do we regionalize? Do we make one big elementary school? It was a very hot topic. Frankly, I wasn't very well versed on that issue, and people said to me over and over again, "Talk to Burt. Talk to Burt."

I have since learned in the last seven years in being in the Legislature, that anything that deals with the schools in South Portland, or that deals with young people in the community in South Portland, the answer is, talk to Burt. So I'm delighted to stand up here and commend Burt on what he thinks is his retirement. But I want to promise in front of all of you, that when the next issue comes along, the answer in South Portland is going be talk to Burt. Thank you Mr. Speaker.

WE, your Memorialists, the Members of the One Hundred and Twenty-Third Legislature of the State of Maine now assembled in the First Regular Session, most respectfully present and petition the President of the United States, the Secretary of Homeland Security and the Congress of the United States, as follows:

WHEREAS, the federal REAL ID Act of 2005 mandates an unfunded national driver's license on the people of Maine and was passed as a rider on a military spending bill; and

WHEREAS, implementation of the REAL ID Act of 2005 will cost Maine taxpayers approximately \$185 million; and

WHEREAS, the REAL ID Act of 2005 national database will invite theft of identity and invasion of privacy; and

WHEREAS, the REAL ID Act of 2005 will impose inconveniences and higher taxes on Mainers with no attendant benefit such as protections from terrorism; now, therefore, be it

RESOLVED: That the Maine State Legislature refuses to implement the REAL ID Act of 2005, and we thereby protest the treatment by Congress and the President as agents of the Federal Government; and be it further

RESOLVED: That We, your Memorialists, respectfully urge and request that the Congress of the United States repeal the REAL ID Act of 2005; and be it further

RESOLVED: That official copies of this resolution, duly authenticated by the Secretary of State, be transmitted to the Honorable George W. Bush, President of the United States; the Honorable Michael Chertoff, Secretary of Homeland Security; the Honorable John E. Baldacci, Governor of the State of Maine; the Honorable Richard Cheney, President of the United States Senate; the Honorable Nancy Pelosi, Speaker of the United States House of Representatives; and each member of the Maine Congressional Delegation.
