The committee shall develop recommendations for changes to the tax code that will strengthen research and development and Maine's innovation economy and enhance the State's advancement in this area: and

Today the second-oldest continuously operating elementary school in Portland, Clifford Elementary serves students of dozens of diverse nationalities and of various incomes, blending the best of old traditions and society's newest challenges in a growing and changing city. We salute the Clifford Elementary community upon its first century of accomplishments and extend our best wishes for its next century of success in Portland, Longfellow's beloved city "that is seated by the sea";

Nathan Clifford is a beacon of education. It is an anchor, a fulcrum of a vibrant neighborhood in the center of Portland. Let me sum up this Sentiment. Nathan Clifford is an awesome school. Thank you.
