WHEREAS, the State of Maine possesses unique opportunities for innovative growth; and

WHEREAS, those opportunities raise issues that are normally placed before several different joint standing committees of the Legislature; and

WHEREAS, to capitalize on those opportunities, a focused, integrated and long-term approach is necessary to build sustainable prosperity for our State; now, therefore, be it

ORDERED, the Senate concurring, that the Joint Select Committee on Prosperity is established as follows:

**1. Establishment.** The Joint Select Committee on Prosperity, referred to in this order as "the committee," is established.

**2. Membership.** The committee consists of 15 members of the Legislature: 4 Senators appointed by the President of the Senate and 11 members of the House of Representatives appointed by the Speaker of the House. The President shall appoint 2 members from the party holding the largest number of seats and 2 from the party holding the second-largest number of seats. The Speaker shall appoint 5 members from the party

holding the largest number of seats, 5 from the party holding the second-largest number of seats and 1 who is unenrolled in any party. The first-named Senate and House members serve as co-chairs.

**3. Duties.** The committee shall develop a comprehensive plan to achieve sustainable prosperity in the State. In order to reach that goal, the committee shall:

A. Review recent reports aimed at addressing the long-term growth of the State's economy and the preservation of our quality of life, including, but not limited to:

(1) "Charting Maine's Future: An Action Plan for Promoting Sustainable Prosperity and Quality Places," by the Brookings Institution;

(2) The final report of the Joint Select Committee on Research, Economic Development and the Innovation Economy; and

(3) The report of the Governor's Council on Jobs, Innovation and the Economy;

(4) "Economic Development Programs in Maine - EDPs Still Lack Elements Critical for Performance Evaluation and Public Accountability," from the Office of Program Evaluation and Government Accountability; and

(5) "Maine Comprehensive Research and Development Evaluation 2006," February 6, 2007, prepared pursuant to the Maine Revised Statutes, Title 5, section 13108;

B. Seek comments and recommendations from selected joint standing committees on elements of the plan that fall within their jurisdictions, including, but not limited to:

(1) From the Joint Standing Committee on Agriculture, Conservation and Forestry on investments in public lands necessary to preserve the State's quality of place;

(2) From the Joint Standing Committee on Appropriations and Financial Affairs on cuts to State Government enacted since the recession of 2001, potential future cuts and spending limitations at various levels of government;

(3) From the Joint Standing Committee on Business, Research and Economic Development on the proper level of investment in the innovation economy and the format and amount of that investment;

(4) From the Joint Standing Committee on State and Local Government on investments in municipal infrastructure necessary to preserve the State's quality of place;

(5) From the Joint Standing Committee on Taxation on the tax structure necessary to support sustainable growth in the State's economy;

(6) From the Joint Standing Committee on Transportation on the transportation infrastructure necessary to support sustainable growth in the State's economy, including highways, railroads and port facilities;

(7) From the Joint Standing Committee on Education and Cultural Affairs Committee on investments in higher education; and

(8) From the Joint Standing Committee on Government Oversight Committee on locating efficiencies and savings in State Government; and

C. Develop recommendations for future legislative action to expand the State's economy over the long term and to identify and address threats to the State's guality of life.

**4. Meetings.** In conducting its duties, the committee may meet with any individuals, departments, organizations or institutions it considers appropriate.

**5. Appointments.** All appointments must be made no later than 7 days following the effective date of this order.

6. Staff assistance. The Office of Policy and Legal Analysis and the Office of Fiscal and Program Review shall provide

staffing and clerical assistance to the committee and may, within existing resources, obtain technical assistance from appropriate sources.

**7. Compensation.** Members of the committee are entitled to receive the legislative per diem as defined in the Maine Revised Statutes, Title 3, section 2 and reimbursement for travel for attendance at meetings of the committee held during the legislative interim.

**8. Report.** The committee shall submit its initial findings and recommendations, along with any necessary implementing legislation, to the First Regular Session of the 123rd Legislature by May 14, 2007 and shall submit its final findings and recommendations, along with any necessary implementing legislation, to the Second Regular Session of the 123rd Legislature by January 2, 2008.

Representative **AUSTIN**: Thank you Mr. Speaker. Mr. Speaker, Ladies and Gentlemen of the House. I apologize over my eagerness. Today I want to share my support of LD 112, a bill that will create a one-time fee for Veterans Vanity Registration Plates. Currently under State law, veterans with vanity plates are

required to pay a \$15 annual fee, as does anyone else that chooses to have a vanity plate when they register their vehicle.

This bill took life after I was contacted by a veteran from my hometown of Gray, who wanted to have the years he served in Vietnam on his Veterans license plate. His desire wasn't a surprise to me because, as many of you know, after talking with veterans, they are very proud of where they served, when they served, and what particular unit that they served with, as they were protecting our great land. So it should follow that they might want specific information displayed and visible on their Veterans license plate. Herein, lays our challenge, and why he came to us for help.

Having this information on the Veterans plate constitutes a vanity plate, and requires an additional \$15 fee, along with the registration, every single year. It seems appropriate that they pay the \$15 initially, to make up their special plate. However, once the initial fee is paid, this bill asked for a waiver for the fee from thereon, a small price for the State to invest in recognizing the service of these individuals who have given so much, to not only our country, but our great State.

Please do not confuse this request. This is not a new specialty plate. This is a Veterans plate with information especially significant to the individual veteran, if they so chose that option. We all know there is never a good time to disregard a revenue source. This bill has a projected fiscal source of up to \$28,000. Many of you who have served with me realize how I count and appreciate every hard-earned tax dollar and fee that is paid to this State. And I certainly respect the posture of the Transportation Committee, considering this bill.

Having worked with this veteran through our Legislative process, I feel the timing is extremely positive and good to recognize veterans by making these plates available—particularly the Vietnam Veteran, who is seeing such disparity in the welcoming home of our veterans and soldiers, versus their welcome home 40 years ago.

This bill is something that we can invest in with great emotional gain as a State. The veteran, who initiated this bill, has been so pleased with his legislative experience. He has felt empowered to speak out in a positive way, through his testimony in Committee, for all veterans. Especially, for those who have carried that negative weight, of their own homecoming for such a long time.

Now, regardless of your age, I know you have heard the stories about the Vietnam War, and the reception that many of our soldiers received when coming home. You may have had family, friends, or even a beau, as someone in this Chamber had, who served during that campaign. Those were difficult and emotional times, both for this country, and for our veterans to reconcile.

I speak today, not to pass on any guilt to you. You are not responsible for the prevailing attitudes of that era. I only ask, that as one of this leadership sitting in this Chamber today, that you consider the value of extending this grateful gesture of thanks to the veterans. It will send a message of healing for which many, many, feel that it is never ever too late to receive. I thank you for your thoughtful consideration.

The SPEAKER: The Chair recognizes the Representative from Fayette, Representative Holman.

Representative **HOLMAN**: Thank you Mr. Speaker. Mr. Speaker, Ladies and Gentlemen of the House. I rise today, to speak in opposition to this bill as amended. First and foremost, I want to say it is my first time doing this, so give me a little slack. But second, I fundamentally believe that the State has an obligation to work at making energy more affordable and more sustainable. So I hope that you will remember that as I make my comments on this bill before us.

However, with all due respect to the Committee and their hard work, and I know that this is a Unanimous Report. I am opposed to this bill as amended. Because of the fundamental facts of what we are as a body. What we are, is a part-time Legislature, where citizens who serve, who do not necessarily have the expertise that we might have, as we are placed on those Committees of jurisdiction.

Most importantly, we are a term-limited Legislature. I have been up working here in Augusta for many years, and when we passed the law that term-limited the Legislature, there was a major shift in power, in my mind. That shift was away from the Legislative Branch.

What this bill does, in part, and what my objection to this bill is, is that it removed from the Public Utilities Commission, a cap on revenues. What that means, is it allows the PUC to raise electricity rates, or rates on consumers. Right now, there is a cap in place. I have a fundamental objection with removing that cap, because it shifts power away from the Legislative Branch, which places a check on their ability to raise rates.

So, I am speaking today, on behalf of my constituents, who are ratepayers. I'm not an expert on utility matters, but I do have a lot of experience in dealing with the three branches of governments. Caps and statutes, caps on spending, caps on revenues and statutes, provide an important incentive to agencies to meet those expectations, and to prioritize what they do. It safeguards our powers and authorities. And also protects, a safeguard in place, for our citizens. In this case, it is the ratepayers.

Arguments for this bill, this is an academic issue. Well if it is so academic, why do we need this? Why do we need to remove that cap? I have also been told that the legislators who serve on this Committee are very qualified. They are good people. They mean to do well. I believe that. But we do not pass laws based on personalities. We pass laws so we have systems in place to protect our citizens. I have been told that this is the "better of two evils". Well when that "evil" is on our ratepayers, I'm not going to vote for either evil. I hope that you will agree with me.

I have been told that we've been asked by the PUC, we've asked the PUC to do more, and more things. That is why they need more money. But I also ask you to think about all of the things this Legislature has done in the last few years, to increase spending on utility matters. We have created more. We have created offices and new positions over at the State Planning Office, in order to study this. So why are we adding those responsibilities on to the PUC? Or maybe we should be looking at this more thoroughly.

My point is, as a part-time citizen, term-limited legislator, will the members of the Utilities Commission from this point forward have that expertise to thoroughly review, which is a very complicated area of knowledge? I think that we would all agree with that. Are we certain that they are going to have that expertise to provide that very, thorough analysis needed, in order to make sure ratepayers are not being taken advantage of?

I think that one of the most important questions to ask yourself, is if we pass this law, are our rates going down tomorrow? Or are rates going up? I have been told our rates will go up. Will they go up in the future? You bet. I think caps work. This exact same issue was presented to the Workers' Compensation Board, and the Legislative Committee of jurisdiction, declined to remove their cap. I believe it was because of the safeguards the caps provide, an important power of the Legislative Branch.

With that, I'd ask you to please consider my arguments. Please consider your ratepayers. Please consider the importance of the Legislative Branch's authority, and to keep that cap in place. Mr. Speaker, I'd ask for a roll call in this matter. Thank you very much, for indulging me.

Representative HOLMAN of Fayette **REQUESTED** a roll call on **PASSAGE TO BE ENACTED**.

More than one-fifth of the members present expressed a desire for a roll call which was ordered.

The SPEAKER: The Chair recognizes the Representative from Winslow, Representative Fletcher.

Representative **FLETCHER**: Thank you Mr. Speaker. Mr. Speaker, Ladies and Gentlemen of the House. I share many of the same values, principles, as the good Representative from Fayette. For those who know me, they talk about, "squeaking the dime into about 11 cents." I understand her points. They are valid. But let me tell you how I view it, and I hope that we can look at it from an objective point of view.

The current system says that, "you will collect no more than". It is a revenue cap. The way the system has worked, is that automatically, when we raise that cap, the ratepayers end up paying that. Even though, the revenue isn't needed for this period of time. So in a way, we are charging them more than what the actual expenses of the PUC would be because we are building a reserve that will be utilized over time, to fund the PUC as changes grow.

I also want to stress the fact that I have a great deal of respect for my members of the Utilities and Energy Committee. We guard with our life, those ratepayer fees, because we know it is a hidden tax. People do not see them. We can do it without a vote of this body. So we are very, very conscious to make sure everything that is spent, which comes out of ratepayers' pockets, has a value. That actually, this process that we are going to, will require that the Committee of jurisdiction scrutinize and recommend the budget, which is the spending.

I am not a believer in tax caps, or revenue caps. We have to deal with the issue, which is the spending side of the equation. Because the revenue, or tax cap, is a result of the taxes. So, I believe that we will have a much better control over the spending, by dealing with the spending, and not be dealing with the revenue side of the equation. Let us spend our time and energy doing the checking of the numbers, to make sure that value is created.

Point number three, the PUC is spending more money than what they have in the past. Absolutely. But that is because the Committee of jurisdiction have said, "We want you to do this piece of work for the ratepayers, and the consumers of the State of Maine." We aren't asking them to go out and do frivolous stuff. We want to see the cost and benefit analysis. I didn't bring the numbers with me, but if you look at what the PUC and what the public advocate, which by the way is funded the same way.

We approve the budget every year. We expect them to save money to avoid costs for ratepayers in the State of Maine. We measure their performance, on what they save potential ratepayers from rate increases. So I just want people to understand that. This is not about trying to control their spending. This is putting an artificial cap, which will then become another issue, which we'll then raise and we'll collect extra money for a while. I wholeheartedly agree with the principles. That we have to make sure that everything we spend creates value for the ratepayer or the taxpayer.

We will probably have a lot of debates this session, on those principles and values. But I would suggest that in this case, this is the best option. It is a more frugal option and it gets to the heart of the issue, which is where are we spending the money, and what are we doing for the work. If you want to hold someone accountable, hold the thirteen members of the Utilities and Energy Committee. I would welcome you to come every time, any time, and watch us turn ten cents into eleven. Thank you, very much, Ladies and Gentlemen.

The SPEAKER: The Chair recognizes the Representative from South Portland, Representative Bliss.

Representative **BLISS**: Thank you Mr. Speaker. Mr. Speaker, Men and Women of the House. I could not agree more with my colleague, the good Representative from Winslow. He has served admirably, as the lead from the other party on this Committee for several years, and is constantly reminding the Chair that we have to scrutinize every nickel. He does an amazing job of that. This bill also, does that.

It is kind of a peculiar thing that there is in statute, a maximum amount that the Public Utilities Commission can assess utilities every year, to provide operating funds. They are not funded by the General Fund. They are funded by this Assessment on Utilities. It is a peculiar thing that the maximum that they can possibly assess, is written into statute.

My colleague is right. What this means, is they'll assess that maximum. Every few years, we have to change the statute to raise the maximum so that they can, guess what? Assess the maximum. They build up a reserve and it leads to—who knows what it leads to.

We didn't think that made sense anymore. We thought it made more sense to rely on the Committee to scrutinize their budget. So we have taken that cap out of statute, and instead written in, and this was a bill that was unanimously approved as amended, by the Utilities and Energy Committee. The amendment that we inserted into the bill, was to specifically require that the Public Utilities Commission come to the Committee of jurisdiction and walk through their budget, and allow us to recommend to the Legislature approval, or not, of the budget that they think that they want to have any given year.

My good friend, from Winslow, is exactly right. That this will make them operate more carefully. It will save more money. It will allow them to do their job better. For a lot of years, the Public Utilities Commission was basically an adjudicatory body. In the last six or seven years, the Utilities and Energy Committee has given more and more authority and responsibility, to that Commission. We have given them the responsibility that used to be held by the Utilities for efficiency programs.

Now, we have Efficiency Maine, operated by the Public Utilities Commission. We have given them responsibility to implement and operate both the E-911 telephone emergency response system, but also the consolidation of that system—from 49 ESOPs scattered around the state, to a smaller number, somewhere between 16 and 24 for efficiency purposes. The Public Utilities Commission is doing a lot of things they didn't use to do. They have already bumped against that statutory cap. We do not want them to "bump" against another statutory cap that we artificially create.

This bill makes sense. It streamlines the process. It still requires them to come back to us, both the Utilities and Energy Committee and the Legislature as a whole, and get approval before they can move forward with the budget, any given year. I would urge you to vote in favor of LD 267. Thank you, Mr. Speaker.

The SPEAKER: A roll call has been ordered. The pending question before the House is Enactment. All those in favor will vote yes, those opposed will vote no.

This being an emergency measure, a two-thirds vote of all the members elected to the House being necessary, a total was taken.
