#### JOINT RESOLUTION MEMORIALIZING THE UNITED STATES CONGRESS AND THE FEDERAL COMMUNICATIONS COMMISSION TO FOREGO IMPOSING A CAP ON FEDERAL UNIVERSAL SERVICE FUND SUPPORT FOR MAINE'S RURAL WIRELESS CARRIERS

WE, your Memorialists, the Members of the One Hundred and Twenty-Third Legislature of the State of Maine now assembled in the First Regular Session, most respectfully present and petition the United States Congress and the Federal Communications Commission as follows:

WHEREAS, the federal Telecommunications Act of 1996 through the establishment of the Federal Universal Service Fund was intended to promote the availability of quality services at just, reasonable and affordable prices, increased access to advanced telecommunications services throughout the Nation and the availability of quality services to all consumers, including those in low-income, rural, insular and high-cost areas, at rates that are reasonably comparable to those charged in urban areas; and

WHEREAS, the intended goals of that legislation have not been met in the State of Maine, and many of Maine's communities have no wireless services or inadequate wireless service; and

WHEREAS, the failure to achieve the goals of improved and high-quality services has, and will continue to have, a direct and substantial negative impact on the health and safety of the people living and working in Maine's rural areas; and

WHEREAS, the failure to achieve this goal of high-quality wireless services at just, reasonable and affordable rates to everyone is a very significant barrier to the economic development of much of rural Maine; and

WHEREAS, there are 2 rural wireless carriers in Maine that have successfully sought certification as eligible telecommunications carriers and have used the federal universal service funding they have received to construct significant additional wireless infrastructure in rural Maine; and

WHEREAS, the Maine Public Utilities Commission has certified that these Maine rural wireless carriers have used the funds received from the federal universal service fund in a manner consistent with all laws and regulations governing the funds; and

WHEREAS, the Federal-State Joint Board on Universal Service has recommended that the Federal Communications Commission impose a cap on funding for competitive eligible telecommunications carriers; and

WHEREAS, this recommended cap would limit Federal Universal Service Fund support for Maine's rural wireless carriers currently receiving these funds; and

WHEREAS, the proposed cap on funding would serve to undercut the purpose and objective of the federal Telecommunications Act of 1996 by impairing the ability of Maine's wireless eligible telecommunications carriers to expand infrastructure into rural Maine so that rural and urban wireless service is equal, as promised by that act; now, therefore, be it

RESOLVED: That We, your Memorialists, on behalf of the people we represent, take this opportunity to request that the Federal Communications Commission reject the cap proposed by the Federal-State Joint Board on Universal Service; and be it further

RESOLVED: That We, your Memorialists, respectfully urge and request that the United States Congress take action to repeal the cap if it is adopted by the Federal Communications Commission; and be it further

RESOLVED: That suitable copies of this resolution, duly authenticated by the Secretary of State, be transmitted to the Honorable Kevin J. Martin, Chairman of the Federal Communications Commission, to the President of the United States Senate, to the Speaker of the United States House of Representatives and to each Member of the Maine Congressional Delegation.

The SPEAKER PRO TEM: The Chair recognizes the Representative from North Haven, Representative Pingree.

Representative **PINGREE**: Thank you Mr. Speaker. Mr. Speaker, Men and Women of the House. I just want to briefly call your attention to the Joint Resolution that I am presenting today. For any of you who live in rural areas, I think that most of you probably understand that our high-quality, rural cell phone access, is still not what it should be. Almost anywhere in my district, whether I am driving here to Augusta, or if I am driving to Blue Hill, or Mount Desert Island, I think that my cell phone works about one-fifth of the time. I know that some of you in this hall can sympathize with me.

The Federal Government, through the FCC, is considering capping the Federal Universal Service Fund, which provided federal funds to Unicel and U.S. Cellular, who are the two carriers that provide service in rural areas. This Resolution is meant to send a message to our Federal Delegation and the FCC, who we hope will be working on our behalf, to oppose this effort to cap the Universal Service Fund. There is a feeling down in Washington that the country already has rural cell phone access. I know that most of us understand that that is not yet a reality in Maine, and this cap cannot go into place until a state like Maine, a highly rural state, is covered.

So, I know that many of us have heard about the Chief Executive's effort, Can You Hear Me Now, that he spoke about in his state address a couple of years ago. I think that this Resolution is an important message we send down to Washington, to say that we still cannot hear each other in many parts of our state, and for our economy and for our emergency capacity, it is important that this cap not go into place. Thank you, Mr. Speaker.

Subsequently, the Joint Resolution was **ADOPTED**. Sent for concurrence.

Representative **HINCK**: Thank you Mr. Speaker. Mr. Speaker, Ladies and Gentlemen of the House. It is my honor to recognize, here today, Dr. William McFarlane. Dr. McFarlane heads the Portland Identification and Early Intervention Program, also known at PIER.

This groundbreaking program, which began December 1, 2000, conducts early intervention to identify and treat childhood mental illnesses such as schizophrenia and bipolar disorder. As much as 3 percent of the population is at risk for psychosis. This is more common than early onset of diabetes. PIER identifies these individuals. It educates the provider, community, and school professionals to help in this program. Early intervention, just like with diabetes, can work to help avoid the problems that we would eventually see with these kinds of mental illnesses.

It has been successful, remarkably so, recently recognized by the Robert Wood Johnson Foundation and provided with additional funding. We are very thankful for everything that is done in this program, to help the Portland area and Maine in general. We are very pleased and honored to have this kind of program conducted, and thank Dr. McFarlane and his associates for all the good that the do for the State of Maine. Thank you very much.

The SPEAKER PRO TEM: The Chair recognizes the Representative from South Portland, Representative Eberle.

Representative **EBERLE**: Thank you Mr. Speaker. Mr. Speaker, Men and Women of the House. I would also like to offer my congratulations and my thanks to Dr. McFarlane and the PIER program. The work that they do with our young people in helping identify and treat early onset of mental illness has been a gift to the children, to the youth that have been in the program, the adolescents, to their families, and to society in general. They have established a program that prevents schizophrenia in children and they are taking it national, we are putting Maine on the map, the biggest health philanthropy in the country is funding this. It is very exciting, and it has captured the interest of the Health and Human Services Committee, we hope to see more replication in Maine, and are looking for ways to do that with out state funds. Thank you, Dr. McFarlane—many more years of work for us, please. Thank you.

Representative **BARSTOW**: Thank you Mr. Speaker. Mr. Speaker, Ladies and Gentlemen of the House. I am pleased today, to give recognition on the House floor to who I consider to be the unofficial Mayor of Gorham. Angelo Sotiropoulos has been an institution in our community with his restaurant, Gorham House of Pizza, not only because of the good product, the good food, and the atmosphere that he has in the restaurant, but also because of the good work he does in the community for many different organizations. The same way that you have a restaurant, like a Moody's in Waldoboro, or Pizza by Alex in

Biddeford, Gorham House of Pizza is that type of institution to us in Gorham.

As was said in the sentiment, he helped out with projects such as the DARE program, and he also helped out with Project Graduation. One person, I know for myself and my colleague, Representative Farrington, who is not here right now that I can speak of, is the fact that we had, two winters ago, a fundraising dinner for heating oil assistance, Keep Maine Warm. The SPEAKER PRO TEM: The Chair recognizes the Representative from Wilton, Representative Saviello.

Representative **SAVIELLO**: Thank you Mr. Speaker. Mr. Speaker, Ladies and Gentlemen of the House. Today we have with us a real hero: Major Kenneth Bryant of Phillips. He was deployed in Operation Enduring Freedom in Afghanistan and was awarded the Bronze Star. Let me tell you a little bit about a Bronze Star. The Bronze Star Medal is the United States Armed Forces Honorary Military Honor for heroic and meritorious

achievement of service, in connection with operations against opposing Armed Forces.

Major Bryant served for more than 25 missions in Afghanistan. The Bronze Star narrative, read by General Libby, cited Bryant for several acts of bravery under fire: On April 27, 2006, according to the narrative, Bryant provided suppressive fire from his vehicle machine gun, covering a squad under attack from enemy small-armed fire. On May 4, 2006, Bryant's fourvehicle convoy was ambushed. Under his leadership, the attack was repelled and the convoy completed its mission.

While serving in Afghanistan, Bryant was also present for eight rocket attacks against his base. The Bronze Star cited Major Bryant for consistently working with leadership to develop, sustain, and proof company training in the combat region. The narrative concluded that Major Bryant's overall performance has extremely positive impact to the role of the United States Army in Afghanistan. When asked himself, Major Bryant gave this quote, he "has always taken to heart John Kennedy's message: Ask not what your country can do for you, but what you can do for your country." Major Bryant has served his country, his state, and his town well. Thank you, Mr. Speaker.

#### READ.

Representative MAZUREK of Rockland moved that the House **ACCEPT** the Majority **Ought Not to Pass** Report.

The SPEAKER PRO TEM: The Chair recognizes the Representative from Scarborough, Representative McDonough.

Representative **McDONOUGH**: Thank you Mr. Speaker. Mr. Speaker, Men and Women of the House. Representative Mazurek did get it right the first time. Anyway, I rise this morning to ask the House members to support this bill. There has been an awful lot of discussion about it. It is a people's bill; it is a bill that protects people's homes. There has been some discussion about this should be before the Insurance Committee, but what happens is when these huge pieces of equipment are being used in residential neighborhoods, they damage our properties. This has occurred in Scarborough. It has occurred in Kennebunk, where foundations have been cracked, in the ground pools that the walls have cracked.

People have spent thousands and thousands of dollars trying to prosecute these cases, to go after the contractors that are responsible. What happens is that you have a number of contractors dealing with a street or a road project, and your property is damaged. All of the sudden, they are saying and they are pointing their fingers this way and that way, saying "Prove it is us, prove that it is my company," and it is very difficult to do.

Recently, down on Route 1, I believe it is Waldoboro, there was a church that has the colored windows, and they were damaged with a road construction job. These reclaimers are the ones that you see out on the Maine Turnpike, which is an appropriate place for them. They are digging up the roads; they are vibrating the devil out of the landscape, and as I said, that is an appropriate place to do it. The MDOT hydrologist was before the Natural Resources Committee last week, and I asked him a question about what happens with wells that our farm friends have, or if you are in a rural area, what happens there? They go out; they test the wells before they start the job to find out what the water flow is. After the work is done, they go back and see if there has been any change in the water flow, a very important issue.

Again, this is a situation that perhaps the time has not come, but it will come because as we use more and more of these pieces of equipment, more and more homes are going to be damaged by them. Sewer pipes are broken, foundations are cracked as I mentioned before. This is a bill that I hope will get a majority here in the House, in the peoples' House. We are elected to protect our people in our communities, and I think that we have demonstrated that time after time.

Men and Women of the House, I have every confidence that we are here to do the peoples' business and protect our friends neighbor. I would ask you to vote for this bill and defeat the Majority Ought Not to Pass, and go with your friends and neighbors. Thank you, Mr. Speaker, and I want to thank the good Representative from Portland, Representative Marley, for allowing me to bring this here to the floor of the peoples' House. Thank you very much, Representative.

The SPEAKER PRO TEM: The Chair recognizes the Representative from Rockland, Representative Mazurek.

Representative **MAZUREK**: Thank you Mr. Speaker. Mr. Speaker, Ladies and Gentlemen of the House. I am going to ask you to support the Majority Ought Not to Pass Report. True, it does deal with reclaimers. If you have been following along the last six months or so, you will know that the cost of road construction has actually skyrocketed, it has gone up 35 percent in the last six months. This bill, if it should pass, would just simply add on more expense to the cities and towns to reclaim and rebuild their roads. It means that these materials would have to be dug up; they would have to be transported to a place out of town, ground up, transported back, and laid down. With these reclaimers that job is done in one motion. It is time effective and it is cost effective.

I realize that Representative McDonough has mentioned a couple of problems, there are problems in any construction, but the cost certainly would double, if not even triple for many communities. So, please support the Majority Ought Not to Pass Report. Thank you.

The SPEAKER PRO TEM: The Chair recognizes the Representative from Vassalboro, Representative Browne.

Representative **BROWNE**: Thank you Mr. Speaker. Mr. Speaker, Ladies and Gentlemen of the House. I urge that you support the Majority, it is a 12-1 Committee Report, Ought Not to Pass, granted there is a lot of finger pointing going on here. If there are damages occurring, the insurance companies say it is up to the town, the town says it is up to the paving contractors, and so forth. As the Representative from Rockland pointed out, it does increase the cost considerably. What this does is it is like a giant rototiller: It grinds the pavement all up, and they have different sizes depending on the thickness of the road. Then they have the vibrating rollers, and again, these are a much more efficient way.

Again, something may have to be done, but it is something down the line. We need to establish the cause and not only the cause, but who is responsible for any damages incurred. Again, I urge you to support the Ought Not to Pass. Thank you.

The SPEAKER PRO TEM: The Chair recognizes the Representative from Old Orchard Beach, Representative Hogan.

Representative **HOGAN**: Thank you Mr. Speaker. Mr. Speaker, Ladies and Gentlemen of the House. I, too, would ask you that you support the Ought Not to Pass motion. I just cannot believe that we are debating this. This was understood by the Committee, 12-1 Ought Not to Pass.

This is basically what everybody has been saying: It saves on the community and their expenses, and it is understood by the majority of the Committee as well that there was just one on the minority side, and the road-reclaiming machine does make a lot of noise, but that is it. It does shake the ground, but it does not do anything to save communities money. I would ask you strongly to support the Ought Not to Pass. Thank you.

The SPEAKER PRO TEM: The Chair recognizes the Representative from Portland, Representative Marley.

Representative **MARLEY**: Thank you Mr. Speaker. Mr. Speaker, Ladies and Gentlemen of the House. Since I am the one, I felt that I needed to get up. Just to give you an idea of why I voted for this, because I think we all see these 12-1 Reports and think, what is that person doing?

The good Representative from Scarborough, Representative

McDonough, brought the bill forward, and if you look at the bill title in the Minority Amendment, it is an "Act to Prohibit Construction Companies from Using Certain Heavy Equipment in Residential Areas". The bill in fact, had two components, however. That was part of it, as far as limiting the type of

equipment they could use. The second half was presumed liability piece. The Committee really was focused on the type of equipment that could be used in the neighborhoods, and in my amendment I actually took that out. I do not think it is our place to be telling businesses how to do their jobs.

However, just like most people, I think my home is probably my largest investment, it is my nest egg. When we are hearing stories about peoples' homes, you know, I am sitting at home and they are reclaiming the street in front of me and it is damaged, I had a concern about the homeowner and that investment. I will be honest, I do not know if this bill is the way to do it, but I did not feel it was appropriate to let this go under the hammers and Ought Not to Pass. Well, recognizing that this is a concern, when I did the Minority Report, I actually sent letters to the Chairs of Judiciary, and hearing from them and hearing from lawyers in the House, they said it really would get into the Maine Tort Act, Maine Tort Reform Act, I believe, is what it is called.

To be honest, if it was early in the session, I would have asked that this bill be re-referred to the Committee on Judiciary to address that—I assume it would be Judiciary, the good Representative mentioned Insurance, but I think it would be Judiciary—but that is really the point, that it is very important that we make sure that we protect the homeowner. Those that are supporting the Ought Not to Pass are absolutely right: This would be very cost prohibitive for communities if they did not use this equipment. However, how do we protect that homeowner, that investment when they have done nothing wrong, is the goal that I was looking at.

As I said, this may not be the way of doing it. I hope that if this is not the way of doing it, someone else will submit a bill that goes to the Judiciary and looks at this very issue, and make sure that we have the protection for the homeowners. Thank you very much.

Representative McDONOUGH of Scarborough **REQUESTED** a roll call on the motion to **ACCEPT** the Majority **Ought Not to Pass** Report.

More than one-fifth of the members present expressed a desire for a roll call which was ordered.

The SPEAKER PRO TEM: The Chair recognizes the Representative from Ripley, Representative Thomas.

Representative **THOMAS**: Thank you Mr. Speaker. Mr. Speaker, Ladies and Gentlemen of the House. What this bill will do if we were to pass it, is it shifts the presumption of damage to the contractor. There are legal remedies already in place, so if a contractor damages a person's home, their foundation, their well, they are liable and they have to pay it, and they pay everyday, and most contractors have insurance. But if we shift the presumption to the contractor with no distance involved, everyone who has a crack in their foundation, if there is somehow that they can blame it on the road construction job, they are going to. So, we are going to have contractor after contractor going to court, presumed that they did the damage, and all of those costs are going to be added to the road projects.

Whether we use the heavy equipment, or whether we do not, you have to use some form of heavy equipment to rebuild a road. Do we want to stop rebuilding roads in some of these residential areas? Do we want to put this presumption of damage on every contractor, on every job? I think that we have plenty of legal safeguards now, and we do not need this bill. I would urge you to vote for the motion. Thank you. The SPEAKER PRO TEM: The Chair recognizes the Representative from Scarborough, Representative McDonough.

Representative **McDONOUGH**: Thank you Mr. Speaker. Mr. Speaker, Ladies and Gentlemen of the House. I promise to be very brief. I do not disagree with some of the things that the good Representative from Ripley has just talked about, but what I am saying is, and I say this to you, my friends, that this is no presumption on the contractor. We can handle it exactly the same way that we do with blasting now. If they are going to be dealing and tearing up the roads, and pounding the heck out of peoples' property, they can at least go in and video the foundations. That eliminates this business of saying every contractor is going to be taken into court.

Another issue is the contractors have deep pockets, and the poor homeowner is the one that has to go out and take the contractor to court when they cannot afford it, so nothing happens other than the fact that you have a damaged piece of property that is your main place that you live. I would just say once again that this is a peoples' bill. If we want to protect the people, we will vote for the bill, and I would ask you to follow my light. Thank you very much.

The SPEAKER PRO TEM: The Chair recognizes the Representative from Rockland, Representative Mazurek.

Representative **MAZUREK**: Thank you Mr. Speaker. Mr. Speaker, Ladies and Gentlemen of the House. Just one last comment: This bill will send the message to private contractors of how difficult it is to do business here in Maine, by adding this unnecessary cost. I think that we are talking about an industry that hires thousands of people in the summer. What this bill will do is simply make it that much more difficult for these people to hire these people at work in our state, and get our roads in good shape. So, please, let's take a look at it from that angle as well. Thank you very much.

The SPEAKER PRO TEM: The Chair recognizes the Representative from Berwick, Representative Burns.

Representative **BURNS**: Mr. Speaker, may I pose a question through the Chair?

The SPEAKER PRO TEM: The Representative may pose his question.

Representative **BURNS**: Mr. Speaker, the question is does homeowners liability insurance cover such damage on a no-fault basis, to anybody who can answer that. Thank you.

The SPEAKER PRO TEM: The Representative from Berwick, Representative Burns has posed a question through the Chair to anyone who may care to respond. The Chair recognizes the Representative from Scarborough, Representative McDonough.

Representative **McDONOUGH**: Thank you, Mr. Speaker. In response to the question, I believe they do not.

The SPEAKER PRO TEM: The Chair recognizes the Representative from Ripley, Representative Thomas.

Representative **THOMAS**: Thank you Mr. Speaker. Mr. Speaker, Ladies and Gentlemen of the House. The deep pockets the good Representative from Scarborough talks about are in fact not the contractors, but yours and mine; we are going to be the ones that pay the extra bill.
