### READ.

Representative PERRY of Calais moved that the House ACCEPT the Majority Ought Not to Pass Report.

The SPEAKER: The Chair recognizes the Representative from Newfield, Representative Campbell.

Representative **CAMPBELL**: Thank you Mr. Speaker. Mr. Speaker, Ladies and Gentlemen of the House. This bill, here, what it does is give the people in long-term care another \$5 or \$10 spending money for toothpaste, candy bars, or whatever. Once you leave the long-term care facility, you know where you are going, don't you? You are not going home. So it is really a bill to help these people get a little goodies or a few things they

need, a little more money, before they leave the nursing home. I would like a roll call vote. Thank you.

Representative CAMPBELL of Newfield REQUESTED a roll call on the motion to ACCEPT the Majority Ought Not to Pass Report.

More than one-fifth of the members present expressed a desire for a roll call which was ordered.

The SPEAKER: The Chair recognizes the Representative from Calais, Representative Perry.

Representative **PERRY**: Thank you Mr. Speaker. Mr. Speaker, Ladies and Gentlemen of the House. This was a difficult bill to work with. We had passed a bill earlier that did allow for some increase in allowance; this one asks for more and for an extension of it going on.

As Health and Human Services looked at the priorities and the needs that we would be bringing forth to Appropriations, we had decided that we had to really make some priorities so that Appropriations knew what we considered to be priority. The decision was, not that we did not want to see it, but that the money we were asking for, we would liked to have seen, or those who voted in the majority would liked to have seen in other needed places that were already brought forth. The bill for this was \$1.1 million, so we, as a result, voted against it.

The SPEAKER: The Chair recognizes the Representative from Skowhegan, Representative Finley.

Representative **FINLEY**: Thank you Mr. Speaker. Mr. Speaker, Ladies and Gentlemen of the House. Representative Perry, it was not an easy vote. I have been a social worker in nursing homes for the past ten years and with all due respect to Representative Campbell, it does not pay for toothpaste; it does not pay for shampoo. What it does is it increases the personal allowance for \$10 a month; however, most everyone in the nursing home has very few needs and because we as taxpayers are paying for probably 85 to 95 percent of the people already in the nursing homes, families, in my experience, are more than willing to supplement. Usually the only need that they would have in the nursing home would be if they wanted to have their hair done, and in many cases if the person does not have the funds, the beauticians will do it free of charge.

I do not find that the people in the nursing homes are suffering a hardship with their \$40 a month. I did not vote no for this easily; I gave it a lot of thought. But looking at all of the major cuts and the major needs that we have in this state, I felt this was one that we could vote Ought Not to Pass on. Thank you.

The SPEAKER: The Chair recognizes the Representative from Newfield, Representative Campbell.

Representative **CAMPBELL**: Thank you Mr. Speaker. Mr. Speaker, Ladies and Gentlemen of the House. Thank you Mr. Speaker. Mr. Speaker, Ladies and Gentlemen of the House. I supported this bill because the people it is going to help the most cannot speak for themselves in this chamber. We have plenty of money for a lot of other things, but when these people that are in a nursing home, they cannot come here and ask for help. I have a feeling that we should not start nickel and diming the people that need it the most. We listen to the lobbyists in the hallways and we listen to the different agencies that need this or that; these people cannot speak in this chamber and that is why I support this bill.

The SPEAKER: The Chair recognizes the Representative from Saco, Representative Valentino.

Representative **VALENTINO**: Thank you Mr. Speaker. Mr. Speaker, Ladies and Gentlemen of the House. I would like to say, also, I feel that this is a wonderful bill and I understand the

situation for the people, but I also have to applaud the Health and Human Services Committee, and the Chair, for taking a difficult position. This obviously is a very good bill, but they have recognized that we are under certain financial constraints this year. There are going to be many, many good bills that we are going to want to vote for this year, but because of the financial situation, we will not have the money for it and I applaud the Committee by having the courage not to just send this to the Appropriations Committee.

I think the fiscal responsibility has to start right here with all of our votes, with every member in this chamber realizing we have to at least keep what we have going now to sustain it without making additional cuts, and although there will be many, many good bills and good ideas to help people, I appreciate not sending it all down to the Appropriations Committee; therefore, I will be voting against it even though it is a good bill. Thank you.

The SPEAKER: The Chair recognizes the Representative from Eliot, Representative Lewin.

Representative **LEWIN**: Thank you Mr. Speaker. Speaker, Ladies and Gentlemen of the House. I voted against passage of this bill because I knew we were going to have a supplemental budget coming, and I knew we were going to see a whole lot of other cuts, and in the supplemental budget we are going to be taking cuts that curtail us and that are going to carry right on into 2009. We have had curtailments that are taking money from home healthcare; home healthcare is when you keep people in their own home at infinitely less cost than the state can afford to pay to take care of them. While we are making cuts like that, I cannot, in conscience, vote for this kind of a bill; it just is not sensible and in my view it is time that common sense prevailed in all these terrible choices we have to make. They are awful, no one likes them, there is no one in this room or any others in this building that likes to do these things, but they are the tough choices we were elected to make and it is an appropriate thing not to pass this bill. Thank you.

The SPEAKER: The Chair recognizes the Representative from Newfield, Representative Campbell. Having spoken twice now requests unanimous consent to address the House a third time. Is there objection? Chair hears no objection, the Representative may proceed.

Representative **CAMPBELL**: Thank you Mr. Speaker. Mr. Speaker, Ladies and Gentlemen of the House. Being my sixth year in the Health and Human Services, and hopefully get elected again and spend two more years, I hear from a lot of my colleagues on both sides of the aisle about what we can afford and not afford; so my advice to them is to get off of Health and Human Services and get on Appropriations. When we send these bills to Appropriations and they cancel them out for lack of funds, I can accept that, but I am not in Health and Human Services to nickel and dime things, whether we can afford it or we cannot afford it. Thank you.

The SPEAKER: A roll call has been ordered. The pending question before the House is Acceptance of the Majority Ought Not to Pass Report. All those in favor will vote yes, those opposed will vote no.
