The SPEAKER: The Chair recognizes the Representative from Portland, Representative Marley.

Representative **MARLEY**: Thank you Mr. Speaker. Mr. Speaker, Ladies and Gentlemen of the House. This is a bill which first of all I would say in all honesty is very complicated and probably may have needed to go the Committee on State and Local Government, because it gets a lot of governance issues.

This Legislature dealt with a similar bill in the 122nd Legislature, I believe, or the beginning of the 123rd and it gets into road associations and you would be amazed at how contentious that would be. This bill made me be thankful that I live in the City of Portland, I must tell you. This amendment is very similar to the bill, but it gets back to allowing roads associations to use any method that they choose, endorsed by a majority vote at a hearing on how to do assessment. The issue that brought this bill forward was really that that previous Legislature that I mentioned made the road association, tied their hands and made them look at it through evaluation purposes only, and associations had done it simply on the number of lots you have, or came together as a community and made a determination. In some cases, it was wonderful to hear, some of these road associations said, "Hey, Bob down the street is on disability, he is ill. We are going to absorb his or hers costs this year and spread it among everybody," and they decided that unanimously and did that. The Legislature tied their hands by making it mandatory that they do it by evaluation, so they have come back, they are trying to address the issue.

As you can see, we have a three-way report here: One of the reports wants to go back and just strip out the language we did two years ago; one wants to do nothing. I will be honest: It is an imperfect bill; there are concerns about the unorganized territories; concern about the written notice piece there, we believe that is addressed but it is not clear in the language. I am moving this Majority Report, but there are still issues and I will guarantee you this is going to be a bill you can see again in the next Legislature. Thank you, Mr. Speaker.
