More than one-fifth of the members present expressed a desire for a roll call which was ordered.

The SPEAKER: The Chair recognizes the Representative from Bath. Representative Watson.

Representative WATSON: Thank you Mr. Speaker. Mr. Speaker, Ladies and Gentlemen of the House. Looking at this bill, the title, "An Act to Change the Formula for Calculation of the Motor Vehicle Excise Tax", it sounds like a bill you can take home and be proud of. You know your constituents have always complained about the automobile excise tax, it is one of the most consistent complaints we get. They buy a new car, a \$35,000 sticker price, they get it for \$20,000, go to a town office to register, and they find they are paying an excise tax based on the sticker price. They complain, they show a bill of sale and say I didn't buy this for \$30,000, I bought it for \$20,000 and I got a good deal, that is what I should pay a tax on. That is not the way the law works, and that is biggest complaint with automobile excise tax. It is not a sales tax; it is the tax you pay for the privilege of operating a motor vehicle in your municipality; it is collected by your municipality and goes to that coffer, the state is not involved with the exception of setting the rates. But the biggest complaint we have about automobile excise taxes is the fact they are based on the sticker price. If you go back and tell your constituents we fixed the excise tax, they will expect you to say that you fixed that part of it. That doesn't happen in this bill; the excise tax is still based on the manufacturer's suggest retail

price and not on what you actually paid.

What this bill does is it reduces, by 3 mills, the excise tax that is paid in that first year. Then the mill rate paid in succeeding years is bumped up slightly, and then drops again in the seventh or eight year, so all this does is ease the pain of that first year on a brand new car. If you are like most Mainers, we don't buy brand new cars; we buy three or four or five or six or seven year old cars, and we drive them until they are that age. This will not help the constituents in that situation.

I was in the minority on this bill, argued against in committee once I saw what the working group, which had done a great job and worked very hard, had come up with. The only reason I am opposed to it is because it does not hold out the promise of fixing the automobile excise tax, and if I try to explain this to a constituent, what we did here, all I can say is we saved you 3 mills on the excise tax the first year you register your brand new car, and I guarantee you the response will be a cross-eyed look saying what have you done for me lately. I encourage you to support the Minority Ought Not to Pass on this bill, I don't think it is a good law, I don't think it is going to help us back home, and it certainly doesn't answer the question or the complaints you get from your constituents about the automobile excise tax. Thank you, Mr. Speaker.

The SPEAKER: The Chair recognizes the Representative from Saco, Representative Pilon.

Representative **PILON**: Thank you Mr. Speaker. Mr. Speaker, Ladies and Gentlemen of the House. This bill, LD 2270, as my good friend from Bath has suggested, does not address the MSRP issue. However, the working group that was established—the members of the working group was the Maine Revenue Services, Maine Auto Dealers Association, the Bureau of Motor Vehicles, and Maine Municipal Association—and this working group went off last year, came back and reported this report, and this was a good first step in addressing the dreaded excise tax.

How many of us here love paying the annual excise taxes on our cars? Anyone want to raise their hand? A brand new car, 24 mills, Maine is one of the highest excise tax states; Arizona is the other highest excise tax state. What we are trying to do is relieve the pain when you go buy that new car at the town halls. So the group came back and said, yes, how can we ease the pain, and they came back and they said let's stretch out the years. Right now, it is a six-year buy down, so we stretched it out to eight years; the first year is 21 and the last year under this new bill is 3.5. Right now, you bought them out at 4, so you now bought them out at 3.5, not a bad deal.

The other thing was that we were able to negotiate, based on a consumer's credit history, is if you are credit worthy, you can now roll your taxes, your sales tax, and your excise tax in the first year of purchasing that new vehicle. What the dealer will do it cut back a check to you for the first year's excise tax, and you just take it to the town hall and pay your excise tax. I believe this is a good first step. I think that what it will do in the first year, if the Maine auto dealers start to publicize this, it will stimulate auto sales. A lot of people don't think that this is a good idea, that the municipalities will be losing revenues, but on the flip of that is, the first year, 21 mills from 24 mills, I believe that it will stimulate and the car auto dealers will see an increase in sales. So I would hope that you would follow my light and support LD 2270. Thank you, Mr. Speaker.

The SPEAKER: The Chair recognizes the Representative from Bangor, Representative Blanchette.

Representative **BLANCHETTE**: Thank you Mr. Speaker. Mr. Speaker, Ladies and Gentlemen of the House. In my other life, the other hat that I wear, I do represent Bangor on the Bangor

City Council, and we have discussed this excise tax reduction and there is nobody here that would like any more than to take home this, what everyone perceives to be tax relief for our constituents. But I have to remind you that the excise tax stays exclusively in your home, or the majority of it does, and that is what fixes your roads. Now there are not too many of you here who can tell me that the roads in your municipality, whether you live up in Greenbush, or you live in Bath, or you live in Bangor, or maybe you are down in Portland where they are looking at huge layoffs due to the lack of revenue of some public safety employees. This is a 1.6 percent reduction in revenue to your cities on the year that that new vehicle has the most value, so this is a big hit to your municipal budgets.

Before you cast a final vote on this, I urge you to go out into the hall and use your little cell phone. You need to call your city manager or your lead assessor and say what is going to be the impact on my community if this bill passes. Short-term tax relief has a way of coming back and biting us with a larger ticket at a later date, and we all know the potholes that we have fallen in to and are out there waiting for us. They are like the little green monster on Pac Man: they are just clamping their jaws and going for our tires. So I urge you to defeat this Ought to Pass motion, although well intentioned and really trying to think about your constituents back home, you may end up, if you pass this in fact, costing them not only more money in car repairs but less money in roads repairs. Thank you, Mr. Speaker.

The SPEAKER: The Chair recognizes the Representative from Allagash, Representative Jackson.

Representative JACKSON: Thank you Mr. Speaker. Mr. Speaker, Ladies and Gentlemen of the House. Forgive me if I say anything that has already been said here today, I just came in, but this bill is like one of the things that made me want to come to Augusta. I remember in the 122nd, I think there were eight of us who put the same bill in to go back to the way it used to be. Does anyone remember that, whenever you went and registered your car and you actually paid the tax on what you paid for your car? That was a long time ago, but I remember that. I paid \$12,000 for my pickup, that is what I paid in excise tax. Now they got the MSRP and it is normally \$4,000 or \$5,000 more than what I actually paid. So if there is any tax here in Maine that people should have a problem with, and I know probably for town officials, they don't like this bill, but I know that every one of my constituents that isn't a town official, they love it. I think this is probably the most unfair tax that we have in the state, because it is the only one I know of that you are paying on an amount that you never even paid for, it is totally outrageous, so I would hope that you would support this.

The SPEAKER: The Chair recognizes the Representative from Chapman, Representative Sutherland.

Representative SUTHERLAND: Thank you Mr. Speaker. Mr. Speaker, Ladies and Gentlemen of the House. The number of small towns I represent really look to the excise tax revenue annually, it is part of how they address the budget. There aren't a whole lot of people who buy a brand new car. Cars that are three, four, two years old, five or six years old, and you know what, I will have to look at those people and say we raise your tax because the excise tax for those years goes up. So I am not so concerned about the people who can afford to buy a brand new car, I guess it goes along with saying, if you can do that, hopefully you can pay the excise tax. Correcting what the good Representative from Allagash referred to in terms of what you paid on, I would be 100 percent behind it, but at the end of the day, the small town I live in and those other small towns are going to have less revenue because that is how this is structured, so I cannot vote to support this bill.

The SPEAKER: The Chair recognizes the Representative from Millinocket, Representative Clark.

Representative **CLARK**: Thank you Mr. Speaker. Mr. Speaker, Men and Women of the House. I hope you take really a close look at this bill. Yes, I was one of those back in 2003 to smother the bill and, what it was, it was on the sticker price. I just bought myself a car and saved \$5,000 or \$6,000 or \$7,000 on it. I went down to register for it and come to find out I didn't pay on the \$15.5; I paid on the \$23.5. That really set me back a little bit and I should have probably known better, but this bill does not cure all.

This bill, as far as I am concerned, only takes care of the person who buys a new car. It has been stated earlier: Why should we need to subsidize somebody who is buying a new car? The person buying a new car, for the next couple of years, is even going to be paying more. You take a person who has a two-year old car; it goes from 7.5 to 18. That is an increase. The third year that person owns a car, 13.5 to 15, that is another increase. The fourth year, it goes from 10 to 11. That is an increase. If you are going to do something with this, take a look at the sticker price. Yes, I applaud the working group, they did some good work, but they didn't really get on ship and try to resolve the problem. The problem had to do with the sticker price. We all know what we paid for; we ought to be paying for what we paid for the tax, not the book value. So I hope when you vote, you don't vote for this and vote for the Majority Ought Not to Pass. Thank you, Mr. Speaker.

The SPEAKER: The Chair recognizes the Representative from Mexico, Representative Briggs.

Representative BRIGGS: Thank you Mr. Speaker. Speaker, Ladies and Gentlemen of the House. As many of you know, I do work at the town office and I do deal with this everyday. I wait on customers, every day, with these excise rates of what they have to pay. According to this chart here, for me. I see that a balance is out, when it is all said and done, for all the years if you have owned your vehicle, for all of these years, you are paying 0.5 mill extra throughout all the years. To me, it looks like, at the beginning when you buy your vehicle brand new, you are going to be charged the 21 percent instead of the 24. You are not going to paying as much for a brand new vehicle. Throughout the rest of them, they are increased a little bit, but it was taken away when you buy the vehicle. For me, the person who is going to benefit the most from this, is the person who goes out and buys a brand new vehicle, as opposed to the people who have older vehicles and, for me, in my community, I have a lot of people who buy the older vehicles because we not a very rich community. So I feel that if people can go out and buy a new vehicle, they pay the 24 percent mill rate. To me, they are going to pay that, then it will be a done deal for all of the rest of the other years, it won't be so bad if we paid the current rate right now, because the mill rates are less.

I think, in the long run, it would be better to help the communities overall as opposed to helping somebody who has gone out and purchased a brand new car. To me, I think the cost for them; I mean, if I could go out and afford to buy a brand new car, I guess I would say I would have the money to pay for the excise tax. So I think we really need to look at this picture overall together and try to balance it out and, to me, the current rate is the way that I would like to see everybody go. Thank you, Mr. Speaker.

The SPEAKER: The Chair recognizes the Representative from Blue Hill, Representative Schatz.

Representative **SCHATZ**: Thank you Mr. Speaker. Mr. Speaker, Men and Women of the House. I was one of the Representatives in the 122nd that put in a bill to make the excise

tax constituents pay, not the sticker price but the actual pay price, and I was informed the excise tax is not a sales tax, it is really a property tax and that is why it is assessed on the sticker price. I still don't think that is fair, but that, I think, gives logic to the fact that the first year is reduced as much as it is in this bill, so I think that makes up for some of the unfairness that we all spoke of. And yes, it does allow some additions to creep in as you go down the list of aging cars, but that should compensate somewhat for our municipalities losing up front on the new cars. It is not a prefect bill, but I say it is a step in the right place, but hopefully the next Legislature will get to that issue of what the real price should be established at. Thank you, Mr. Speaker.
