Each Senator has on his or her desk today a basket or a key chain handcrafted by Passamaquoddy elders. I think that we can all agree that they are a beautiful product. The Passamaquoddy people are known worldwide for the extraordinary baskets that they make. I well remember when I was Chief of Staff to Senator Snowe what a proud moment it was for me when the Senator was visited by the actress Jane Alexander, who was chairing the National Endowment for the Arts at that point. When she came to meet with Senator Snowe the Senator was on the floor, so I escorted her into the office to let her be comfortable until the Senator came back. As we walked into the office Jane Alexander looked at a basket Senator Snowe had on top of the credenza behind her desk. She said, 'Oh my goodness, a Passamaquoddy basket.' I can tell you, as a little boy from Perry, Maine, home to the Passamaquoddy tribes, I was thrilled that the Passamaquoddy culture was so recognized at the highest levels of arts and culture in this country. It is with extraordinary pleasure for me to welcome here to the Senate Chamber today my friends, partners for all of us in Washington County and in the State of Maine, and real drivers of economic development in a part of the state that so desperately needs it, the Passamaquoddy represented here today by their excellent and talented Governors, Governor Rick Doyle and Governor Bill Nicholas. I remember visiting Uncle Fred and Aunt Katherine either at their summer ocean home or at his house in Gardiner. He loved to talk politics and, with a twinkle in his eye and his pipe, he wanted to talk politics with his niece who shared the same political views as he did. Also what was unique about my uncle, and he had a really great sense of humor, was that he always had Labs. They were usually Black Labs, except for when he passed away he had finally had his first Yellow Lab. He called every single one of these Labs 'Governor'. Thank you.
