Prayer by Reverend Kate Braestrup, Chaplain of the Maine  
Warden Service.

**REVEREND BRAESTRUP:** I did want to give a small, very brief, explanation for the inspiration for this prayer. I've learned that everywhere I go I take myself with me. Recently I went to Khabarovsk, Russia to meet my daughter, who is a 16-year-old exchange student. If you haven't heard of Khabarovsk, it's all right. I hadn't either. It's all the way on the other side of Russia, almost to the Pacific Ocean, close to China. I went as a Mom, I went as a law enforcement person, and I brought along my Fish and Wildlife self as well. The first thing I learned was that a police officer in Maine may be universally presumed to be a source of help and protection, the uniform is a sign of trustworthiness and basic decency. This is not true in Khabarovsk. You do not talk to cops in Khabarovsk. I was told that many times. More painfully, if I told the Russians that I work in law enforcement, I could actually see the fear and mistrust in their faces. I also learned what an environment that was actually quite like Maine's looks like when it's not protected. The whole time I was there and looking, because I work with Game Wardens, I saw five kinds of animals; sparrows, pigeons, magpies which are like crows, stray cats, and pack of feral dogs. That was it. On a day long excursion into the countryside through fields and woods, on the banks of the Amur River, we saw no ducks, no frog spawn, no fish, no squirrels, we heard no birdsong, and we drove 100 miles through the countryside and saw no road kill. None. When you are driving home tonight or when you are going back to school, I invite you to count how many species you see or hear or smell from your moving car. You'll get a sense of how eerily empty that Russian landscape seemed and what a thankful thing it was to come home to Maine. If you will join me for a moment in the spirit of prayer.

Dear and generous God, we would begin this day in gratitude, for we have inherited treasures. Ours is a natural environment of richness and beauty and wonder. It is a treasure to behold, to partake of, and to defend. Ours is a society blessed in the rule of law, a culture marked by accountability and trust. Here, too, is a treasure to behold, to partake of, and to defend. Built up over generations, paid for too often in blood, these treasures of trust and natural richness are ours unearned and too often unnamed. Our inheritance is perhaps more precious, rare, and fragile than we are inclined to remember. Help us to remember now. In this radiant and fertile season on this day after Memorial Day incline our hearts to thankfulness, that we may know and love and earnestly defend these gifts. We are American and we live in Maine. Amen.

Senator **ROTUNDO**: Thank you, Madame President, men and women of the Senate. I rise to ask you to reject the motion that is currently before you. At this point in time the Maine University System does not have the authority from the State to regulate firearms on their campuses. They have policies in place, but they don't have the authority to have those policies. We have not given them that authority. This bill does not say they have to regulate firearms. It does not say they have to keep them off campus or they have to keep them on campus. It simply gives them the authority to make those policies that they feel will best serve their campuses. There are policies now in place on the different campuses, but they are not worth the paper they are written on because, again, the State has not given these campuses in the University System the authority to make these decisions and if these policies were ever challenged in a court of law they would most likely not hold up. This leaves us with great liability issue, if you think about some of the things that could perhaps happen. Again, this bill does not say that they need to regulate firearms. It simply gives them the permission from the State to make those decisions on their own campuses if they chose to. It gives them the authority to do what they've already done, in terms of establishing policies on their campuses. Thank you.

Senator **ROTUNDO** of Androscoggin requested a Division.

**THE PRESIDENT:** The Chair recognizes the Senator from Cumberland, Senator Diamond.

Senator **DIAMOND**: Thank you, Madame President, men and women of the Senate. I appreciate the comments of the good Senator from Androscoggin, Senator Rotundo. I'm compelled to share a little more information with you. The committee on Criminal Justice and Public Safety spent a long time on this bill. We treated it very seriously because of obvious reasons. It came down to this, spending a considerable amount of time with the General Council for the University of Maine System. We asked the General Council three questions on this bill. Remember, this is the person who is going to be representing the University if there are any court cases. We asked the General Council three

questions. Are you anticipating any challenges to your ability to write your campus policies? Answer, no. If you are challenged, if you were challenged in court, do you think you would win? The answer was yes. If felt at all threatened with the policies would you be willing, on short notice, to come to the legislature and ask for legislation if you needed it? The answer was yes. That, ladies and gentlemen, was why we had a 12 - 1 report. It really gave us the background we needed and this Senate the background it needs for an Ought Not to Pass.

Senator **ROSEN:** Thank you, Madame President, men and women of the Senate. I hope you are willing today to move past the majority Ought Not to Pass report and accept the minority Ought to Pass report. I'd like to just speak for a couple of minutes here and give you an idea of what this bill is all about. As you remember, in the Spring of 2004, when the citizens of Maine instructed the legislature to fund 100% of special education costs at the local level and 55% of other educational costs and then in the Fall of that same year, in November, we had a citizen initiated property tax containment measure which failed on the ballot. The Chief Executive introduced LD 1 and the Joint Select Committee was formed and spent a month working on LD 1. I was happy to be a member of that committee along with the Senate Chair from Hancock, Senator Damon, the Senator from Penobscot, Senator Perry, the Senator from Kennebec, Senator McCormick, and the Senator from Somerset, Senator Mills. We spent a month locked in a room working on what ultimately became the spending limitation growth limits that are on the books today. The Chief Executive's original proposal called for the establishment of caps, of growth limits, in local county and state spending. Then his proposal called for an override mechanism that would go out to the citizens of the state if the local municipality felt that it needed to spend beyond the growth cap amount. That level would fall on the property taxpayer in its full form and they would have the ability to chose to vote yea or nay, we accept that responsibility. That was in the original proposal. Those of us on the committee decided that we should soften that override mechanism and we did and we put in place a provision that allows, in a municipal form of government that has an elected council, for them to make the choice, that the county commissioners will make the choice, or that the school board will make the choice as to whether that community or that district will override the spending limit.

That had been in place for a couple of years and we come up again with November 2006 with another initiative on the ballot requesting caps and limitations to provide property tax relief for the citizens of Maine. It became clear to me, talking to folks as I campaigned, that they wanted the opportunity to be able to vote to make the decision as to whether or not their local governmental entity will exceed those spending growth limits, and in effect, accept a property tax increase. They wanted to be able to make that decision. If they said yes, then it's their money and they have accepted it. If they say no, then they have had involvement in the process and they have made their opinion known in the privacy of the ballot box.

This proposal that is before you simply extends the override mechanism out into the community as a public referendum. The local governing entity, the town council, the school board, the county commissioners, maintain complete and full authority to design their budgets, to determine how funds are spent, and to exercise that authority that they are entitled to. The only question here is if they chose to pass a budget with a level of spending that exceeds the spending caps which are determined and put into law by the legislature then they must seek voter approval. This bill does not apply to town meetings. That mechanism stays as designed in LD 1. The Chief Executive has been saying for quite some time that he wants to see 90% of the additional funding that is flowing into communities for K-12 spending to be reflected in a beneficial way to the property tax payer. The legislature has struggled, both this session and last session, to figure out a way to accomplish that. This proposal will come closer than anything else to allowing the citizens to have a voice, to make the ultimate

final decision, and to accomplish the goal that the Chief Executive has been working so hard to achieve. I hope that you will reject the majority Ought Not to Pass and move on to accept the Minority Report.

Senator **ROSEN** of Hancock requested a Division.

**THE PRESIDENT:** The Chair recognizes the Senator from Penobscot, Senator Schneider.

Senator **SCHNEIDER:** Thank you, Madame President, men and women of the Senate. I rise in support of the majority Ought Not to Pass report, there are 10 members who are in support of the Ought Not to Pass. I also want to point out that acceptance of the Minority Report is not an acceptance of this piece of legislation at all. In fact, the amendment which the Minority Report brought forward allows counties to exceed the spending caps in Public Law 2005 chapter 2 only if it is approved by referendum and removes all sections of the bill related to the school administrative units and municipalities. They were trying to get at counties because some of the committee members have not had good experience with county government. I want to make that very clear. If you are to accept the Minority Report it is exceptionally different from what the original bill was intended to do. That is one issue. The other issue I want people to know about, and the reason why I was on the majority Ought Not to Pass report with 9 of my colleagues, is that, though I agree with the good Senator from Hancock, Senator Rosen, that more education needs to be done at the local level to ensure that people are aware of why they are exceeding the caps when they do so, this tool will certainly make a larger cost for municipalities or counties when they chose to exceed the caps. Therefore I did not feel that it was an appropriate tool, to send on an additional mandate, or what could be a mandate, if they end up exceeding the caps to go to referendum. It's just another cost that will be borne by the local taxpayers and our committee recognized that. That is why we voted for the majority Ought Not to Pass report. We just didn't want to send more costs onto the local taxpayers. If you want to do that, if you want to be responsible for sending additional costs onto the local taxpayers then go ahead and support the Minority Report. Thank you very much.

**THE PRESIDENT:** The Chair recognizes the Senator from Hancock, Senator Damon.

Senator **DAMON:** Thank you, Madame President. May I pose a question through the Chair?

**THE PRESIDENT:** The Senator may pose his question.

Senator **DAMON:** Thank you, Madame President. With regards to county budgets, if the commissioners vote to exceed the cap can the budget advisory committee override that decision or does it have to go out to the referendum of all the county residents?

**THE PRESIDENT:** The Senator from Hancock, Senator Damon poses a question through the Chair to anyone who may wish to answer. The Chair recognizes the Senator from Penobscot, Senator Schneider.

Senator **SCHNEIDER:** Thank you, Madame President. I am assuming the Senator from Hancock, Senator Damon, is referring to the Minority Report. It will end up going out to referendum.

On motion by Senator **SCHNEIDER** of Penobscot, supported by a Division of one-fifth of the members present and voting, a Roll Call was ordered.

**THE PRESIDENT:** The Chair recognizes the Senator from York, Senator Courtney.

Senator **COURTNEY:** Thank you, Madame President, men and women of the Senate. I'm a little confused. I'm wondering if maybe someone in this Body could help me. The provision that the good Senator from Hancock, Senator Damon, asked about, it would go out to referendum if the budget committee doesn't agree with the county commissioners? It's my understanding that the county commissioners have the final say. I thought I heard that if the county commissioners exceed the cap and the budget committee says not to it would go out to referendum. I'm just wondering if we could get some clarification on that before we vote?

**THE PRESIDENT:** The Senator from York, Senator Courtney poses a question through the Chair to anyone who may wish to answer. The Chair recognizes the Senator from Somerset, Senator Mills.

Senator **MILLS:** Thank you, Madame President. By virtue of my laptop here I have access to the provision. It says that the current law says a county may exceed or increase the county assessment limit only if approved by a vote of a majority of all the members of both the county budget committee or county budget advisory committee and the county commissioners. The bill would go further and say 'and if approved by the voters at a referendum.' It would impose a referendum requirement to exceed the spending limits on top of the customary back and forth between the budget committee and the county commissioners. Thank you.

**THE PRESIDENT:** The pending question before the Senate is the motion by the Senator from Penobscot, Senator Schneider to Accept the Majority Ought Not to Pass Report. A Roll Call has been ordered. Is the Senate ready for the question?

The Doorkeepers secured the Chamber.

The Secretary opened the vote.
