**THE PRESIDENT:** The Chair recognizes the Senator from Somerset, Senator Mills.

Senator **MILLS:** Thank you, Madame President and men and women of the Senate. If I may speak to this nomination and to the ensuing three that are before us this morning, because they all have a common procedural deficiency that it is disturbing to me and if I could just take a brief moment to explain the source of my negative votes on these people. I have to hasten to say that it was not on the basis of their merits but on the basis of the procedure by which the nominations were posted. I have to begin by drawing people's attention to Title 5, Section 3, which says that somebody who is appointed to a civil office, and the Board of Education is one of many civil offices to which the Governor has the power of appointment and we have power, under the Constitution, for approval of the committee's review, and is appointed to a job that has a fixed term, in this case the terms for those positions in the Board of Education is five years, you continue to hold office beyond the end of that term until a successor has been appointed to that office and qualified. This is a curious phenomenon.

I'm informed that judges are not in that same category. They hold over for a maximum of six months beyond the end of the

term and then I think they automatically lose their eligibility. Not so with these other categories.

This is the curious thing, strategically and tactically, I suppose. If the Chief Executive were inclined to keep somebody in an office that they already hold and didn't consider that the prospects of reappointment were likely to be successful, that Chief Executive could simply fail to appoint anybody to replace the incumbent and the incumbent could carry on for at least the term of that Governor, indefinitely, for any number of years as long as the Chief Executive chose not to appoint a replacement. It's very interesting.

On the other side of that coin is this, if we, as a Senate, and if the committee of jurisdiction felt strongly that an incumbent should stay in office, shall we say indefinitely, they could take the position that they are going to reject any replacement nominee and the effect of that rejection is to leave the incumbent in office for as long as the two branches of government remain at loggerheads. I don't know if this ought to be the law, but the Deputy Attorney General, who works on education matters, some others and I spent quite a bit of time last Monday looking into this because it relates to the following issues. When I saw six appointments to a nine member board I thought to myself, 'What is going on? Why all of a sudden do we have this?' These are people who are appointed to five-year terms, so why do we suddenly have, all in one slug, six positions to fill? You would think they'd be coming up in more staggered fashion. Then I got to looking at the notices and I couldn't tell from looking at the notices, any of them, who's term was being filled, for what duration, and who's positions were they taking, who was going off the board and who they were replacing. It mattered to me, quite candidly. I was concerned about some of the incumbent members.

As matters turned out, we're now faced this morning with four nominees, but that aside, we tried to sort this out within the committee. We've asked, informally, the Governor's Office to try to explain to us how many years were left. We found out that there were members on the Board of Education who had been serving for at least two years into a holdover period. There were some people who were coming before us who presumably should be going on for three years more, others maybe four, and others five. That, too, makes a difference to me. I took the position that the nominations were not properly posted, not properly advertised, and not properly before the committee. Maybe it's a bit sticky to do so, but I didn't know how to handle the situation other than by taking that position. I have to say that in many cases it doesn't matter because you have vacancies cropping up singularly, one at a time. Somebody gets nominated and they step in. It's fairly obvious, perhaps, whose job is being filled and for how long. In this case it was patently not obvious. It was very confusing and I had some concerns about the nominees, how long they were going to be on, and whose positions and places they were taking and for how long. I could not resolve any of that by looking at the notices or the formal records that were posted before us.

Then something else occurred to me, it isn't just myself, as a committee member, who should be concerned about this. There is a statute that says that the Governor has to post these nominations publicly. I believe that is pursuant to a Constitutional requirement. It isn't as if we have discretion over this, we really have to do this properly. In the posting, the public has notice of who's being replaced and what is the term of office. More so, the notice actually has to say, has to define, the office to which that

person is nominated. It seems to me it is insufficient, at least in this case where there were all sorts of ambiguity and confusion. It is an incomplete notice, not to specify the term within the notice and the slot that is being replaced. For that reason, I took a position that I would not vote for any of the nominees even though, quite frankly, I respect deeply several of them. It's not personal, it's just business. I needed to explain all of this on the record, if nothing else but to save myself some embarrassment with the nominees. Thank you, Madame President.

I would guess that this will not happen again. If it does I will insist; I will join forces with my colleague. I don't have that information presently, but we can easily get it if that is important.

Senator **MITCHELL:** Thank you, Madame President. I might add that I joined the other members of the committee in trying to answer this question. We were very careful in making our motions that a certain candidate replaced a specific person with a term of years because there had been confusion. I guess our motion is not reflected here, but it did in the committee meeting. I'm sorry it's not on the calendar. Some of them are for three-year terms, some are for five-year terms, and we can probably get that just in a moment. It's very specific. The motion made by the committee was that this person was replacing a specific person. Sometimes it was three years. We ended it at 2012 if you had a full five-year appointment. If the Senate is so inclined I think we could get that within a couple of minutes. They are very specific in the record of our committee.
