I think it probably got a

unanimous report because I was busy during the work session and they didn't have to hear from me. Thank you so much to Commissioner Jordan, if she's listening, and also to the Senate Chair and all of the members of the Criminal Justice Committee.

THE PRESIDENT: The Chair recognizes the Senator from Somerset, Senator Mills.

Senator **MILLS:** Thank you, Madame President and men and women of the Senate. This issue of confidentiality, as it applies to the records and proceedings relating to certification of teachers, has a lengthy history, to those of us who lived through the fingerprinting debates, because one of the issues that kept cropping up in the fingerprinting debates was how many teachers are there who lose certificates from time to time. How many are there that have their certificates turned in or are suspended and so forth? We found, to our great surprise, that state law does not grant public access, even to statistical information, about the removal of teachers' certificates. It goes further. Current law, which is a very old law that we think goes back to the early part of the 20th century, renders completely confidential any information about the status of a teacher's certificate. The Administration presented to the Education Committee the other day a bill that we got very late in the session, but that's all right because we're used to these things. This bill would at least permit, and is what the Majority Report permits, the Department to reveal to another jurisdiction that the certificate has been suspended or revoked. Having heard the presentation from the Department, I thought to myself that it seemed to me that something further ought to be released or revealable and I began to look around at other statutes where these issues are dealt with. We lawyers live under such rules. There are about 4,000 of us in the state. I have had the pleasure of representing some of my fellow professionals in their ethical proceedings and have become intensely aware, through the publicity that is available, of just how much trouble people in my profession can get into from time to time. There being only about 4,000 of us and there are something like 27,000 teachers, I'm extrapolating and thinking that, even as well behaved as we know teachers are in comparison to members of my own profession, surely there is opportunity for mischief there. I won't even go into the various clerical settings and other professions that we've all become aware of through publicity. In any case, there are certain elements to any good professional confidentiality law that are entirely missing from state law in regard to teachers. It is not my goal to try to carry this too far or to shine an adverse light on this profession or any other.

We didn't really have a chance to discuss the Minority Report in committee because it was the end of session and the bill came late. The opportunity to give it any kind of committee time was quite limited. I am offering it to you this afternoon because I think it's important. Let me just touch on why I think it is. Just a couple of points. If there is a complaint made about a teacher stealing money from the French Club, getting involved with a student, or being involved in some other nefarious activity the current law does not even permit the Commissioner of Education to report that to law enforcement or to even cooperate with law enforcement except to receive information from the police. I confirmed this with the Commissioner. It is her practice to simply passively listen to any information that she can glean from a parallel investigation by law enforcement, but she's not at liberty, under current law, to reveal anything that she knows that might be helpful or important to a law enforcement investigation. One of the things that this Minority Report does is it says the

Commissioner has, or would have, the power or latitude to discuss or reveal relevant information only to those law enforcement agencies that need it in aid of their investigation.

There is another issue. What happens if a teacher has a certificate in two or more jurisdictions? Say they are licensed to teach in Massachusetts and also licensed to teach in Maine? They get into trouble here in Maine. This happens to lawyers and accountants as well. The first thing you do if you are advising such a person is tell them to surrender their certificate immediately if the evidence is pretty strong and pray that they don't exercise any right of reciprocity so that they could then move to Massachusetts and continue teaching, practicing law, practicing accountancy, or what have you. We used to have this problem with OUIs 30 years ago. Hunters would come up here. They'd get caught drunk driving. Maine would suspend their right to operate on Maine roads for a year and they would stay in Massachusetts for a year and nothing bad happened. Finally the states got their act together and we now have reciprocity on OUI laws. What about the protection of children? If there is a teacher in Maine that gets into some kind of trouble and the only thing that the Commissioner is authorized to talk about to another jurisdiction is the fact that the license is no longer valid in Maine, beyond that the Commissioner's lips are sealed. That is the Majority Report. The grounds for the termination, the factual underpinnings of the complaint, the opportunity for reciprocity, the public moral duty to see that there is reciprocity, and that this license is pulled in another jurisdiction is completely absent from the Majority Report. It is dealt with very narrowly, and adequately, in the Minority Report.

These are some of my concerns as I saw this happening and the public hearing on this bill was only something like a week ago. I think that if you took the trouble to look at the text of the Minority Report, which is very brief, you will see that it is a significant improvement over the bill that was presented to us by the Administration that did not, in my view, adequately deal with this very sensitive area. The reason I spent all of our time on this, and it's been 10 or 15 minutes, at the end of the session is that I don't think this is something that should wait until next year, to put a bill in next year to discuss and maybe we'll pass something at that time. I think there is an opportunity, in the current law and under the Majority Report, for some bad things to happen that we can prevent. We can prevent it by passing a law that gives the Commissioner a somewhat broader authority to deal with disciplinary issues in those rare occasions when it is required. It's required in all professions, trust me because I've represented accountants, lawyers, and many other professions. I should not forget doctors. I see one or two. It happens in all professions. We have people who get addicted to drugs or alcohol, who have problems that should be reported in some sensitive way and it is just part of the society in which we live in. We need to have a system in place. Our duty as legislators is to have a system in place that allows our public officials to deal with these issues sensitively and appropriately and protect the public as well as the professionals whose reputations and lives are at stake. I am offering up the Minority Report in that vein and urge your affirmative vote on my motion. I want to thank my fellow committee members for allowing me this opportunity. I could have offered it as an amendment but it would have been a needless exercise for the Revisor's Office to prepare it as an amendment. I appreciate the opportunity to offer the minority view. Thank you.

On further motion by same Senator, supported by a Division of one-fifth of the members present and voting, a Roll Call was ordered.

THE PRESIDENT: The Chair recognizes the Senator from Kennebec, Senator Mitchell.

Senator **MITCHELL:** Thank you, Madame President and colleagues in the Senate. I will start by admitting that I was absent from the public hearing and I'm not nearly as knowledgeable as my good colleagues who serve on the committee. I have been spending time reading both the Minority Report and the Majority Report and I'm particularly concerned. I do understand the need. The Governor brought this bill forward. We were the only state in the country that did not share with this national teacher certification organization if a teacher in Maine had been suspended or had their license revoked. The bill that we brought forward, the Majority Report, which I might mention is a 12 -1 report, says that we will participate because we want to be sure that people who are hiring teachers from Maine have knowledge. I think it would be incumbent upon anyone hiring a teacher from Maine, if they show up in this database, who have lost their license, or have not been hired back, to interview them and to find out why. I'm not sure how much further our responsibility goes in revealing confidential information because the level of violation or whatever else could be diminutive to very serious. I think there is some responsibility here. I guess the main thing I'm concerned about, although I have the utmost respect for the judicial skills of the good Senator from Somerset, Senator Mills, is that this is a 12 - 1 report about a very complicated matter which we have not had time to deliberate. I have been chastised many times on the floor of this Chamber for that kind of precipitous action. This is very serious stuff. We're all concerned about confidentiality. I think the committee made a very strong statement in the Majority Report that we did believe that information concerning a teacher's revocation, suspension, or denial of renewal would be in this national database, available for anybody seeking to hire a Maine person. I am comfortable only with going that far and I would urge you to vote against the Minority Report and at least begin with the Majority Report that puts us into the national database of sharing information that is helpful.

THE PRESIDENT: The Chair recognizes the Senator from York, Senator Bowman.

Senator **BOWMAN:** Thank you, Madame President, men and women of the Senate. I think there are several things that have been stated previously but I believe that they need to be stated again. This bill is like several others, maybe many others, that came to us late in the session and that do not get sufficient vetting and involvement by committee members. It's a fact of life, but it doesn't make it right. This really applies to this bill here. Something needs to pass on this subject because Maine is the last of the states to join with the other states in sharing this information. The Majority Report did that but did not disclose beyond a certain point. The thing that appeals to me in the Minority Report is that, and these are my words and I'm not a lawyer, it levels the playing field among professions. That has a certain appeal to me.

Going back to my first point, and the good Senator from Somerset, Senator Mills, could correct me on this, as my

recollection serves me there was not much of an opportunity for him to discuss his position and I think that, in a large part, contributed to the lopsided vote as it was taken.

THE PRESIDENT: The Chair would remind people to speak through the Chair and if they have a direct question they can ask it to anyone.

Senator **BOWMAN:** Thank you, Madame President. I'm just trying to say that this is what I recalled. I don't think it's terribly important but I wanted to put it out on the record. Thank you very much for the opportunity.
